Morgan Stanley B.V. ("MSBV" or the "Issuer") and Morgan Stanley in its capacity as guarantor (the "Guarantor") have prepared this fourth base prospectus supplement (the "Fourth Base Prospectus Supplement") to supplement and be read in conjunction with the base prospectus dated 20 July 2021 (the "Base Prospectus"), as supplemented by the first supplement to the Base Prospectus dated 26 August 2021, the second supplement to the Base Prospectus dated 14 October 2021, and the third supplement to the Base Prospectus dated 29 October 2021 in relation to MSBV's program for the issuance of notes, certificates and warrants.

This Fourth Base Prospectus Supplement has been approved by the Central Bank of Ireland, as competent authority under Regulation (EU) 2017/1129 (the "**Prospectus Regulation**"). The Central Bank only approves this Fourth Base Prospectus Supplement as meeting the standards of completeness, comprehensibility and consistency imposed by the Prospectus Regulation. Such approval should not be considered as an endorsement of the Issuer or the quality of the Securities. This document constitutes a supplement for the purposes of Article 23(1) of the Prospectus Regulation.

In addition, this Fourth Base Prospectus Supplement has been approved by the Irish Stock Exchange plc trading as Euronext Dublin ("Euronext Dublin") as supplementary listing particulars, pursuant to the listing and admission to trading rules of Euronext Dublin, for the purpose of providing information with regard to the Issuer and the Guarantor for the purposes of admitting Securities to the Official List of Euronext Dublin and trading on its Global Exchange Market. The Global Exchange Market is the exchange regulated market of Euronext Dublin and is not a regulated market for the purposes of Directive 2014/65/EU.

Unless otherwise defined in this Fourth Base Prospectus Supplement, terms defined in the Base Prospectus shall have the same meaning when used in this Fourth Base Prospectus Supplement. To the extent that there is any inconsistency between any statement in this Fourth Base Prospectus Supplement and any other statement in, or incorporated by reference in, the Base Prospectus, the statements in this Fourth Base Prospectus Supplement will prevail.

The purpose of this Fourth Base Prospectus Supplement is to:

- (a) disclose the publication by Morgan Stanley of its Quarterly Report on Form 10-Q for the quarterly period ended 30 September 2021 (the "Morgan Stanley September 2021 Form 10-Q") and incorporate the Morgan Stanley September 2021 Form 10-Q by reference into the Base Prospectus, as set out in "Part A" of this Fourth Base Prospectus Supplement;
- (b) make amendments to the "Introductory Pages" section of the Base Prospectus as set out in "Part B" of this Fourth Base Prospectus Supplement;
- (c) make amendments to the "General Information" section of the Base Prospectus as set out in "Part C" of this Fourth Base Prospectus Supplement.

The Issuer accepts responsibility for the information contained in this Fourth Base Prospectus Supplement. To the best of the knowledge of the Issuer, the information contained in this Fourth Base Prospectus Supplement is in accordance with the facts and the Fourth Base Prospectus Supplement makes no omission likely to affect its import. The Guarantor accepts responsibility for the information relating to the Guarantor in this Fourth Base Prospectus Supplement.

Save as disclosed in this Fourth Base Prospectus Supplement, no significant new factor, material mistake or inaccuracy relating to information included in the Base Prospectus has arisen since the publication of the Base Prospectus.
