Morgan Stanley B.V. ("MSBV"), Morgan Stanley & Co. International plc ("MSI plc"), Morgan Stanley Finance LLC ("MSFL") and Morgan Stanley Finance II Ltd ("MSFII" together with MSBV, MSI plc and MSFL, the "Issuers") and Morgan Stanley in its capacity as guarantor (the "Guarantor") have prepared this second base prospectus supplement (the "Second Base Prospectus Supplement") to supplement and be read in conjunction with the base prospectus dated 25 January 2023 (as supplemented by the first supplement to the Base Prospectus dated 16 March 2023, the "Base Prospectus") in relation to MSBV's program for the issuance of notes, certificates and warrants.

This Second Base Prospectus Supplement has been approved by the Central Bank of Ireland, as competent authority under Regulation (EU) 2017/1129 (the "**Prospectus Regulation**"). The Central Bank only approves this Second Base Prospectus Supplement as meeting the standards of completeness, comprehensibility and consistency imposed by the Prospectus Regulation. Such approval should not be considered as an endorsement of the Issuers or the quality of the Securities. Investors should make their own assessment as to the suitability of investing in the Securities. This document constitutes a supplement for the purposes of Article 23(1) of the Prospectus Regulation.

In addition, this Second Base Prospectus Supplement has been approved by the Irish Stock Exchange plc trading as Euronext Dublin ("Euronext Dublin") as supplementary listing particulars, pursuant to the listing and admission to trading rules of Euronext Dublin, for the purpose of providing information with regard to the Issuers and the Guarantor for the purposes of admitting Securities to the Official List of Euronext Dublin and trading on its Global Exchange Market. The Global Exchange Market is the exchange regulated market of Euronext Dublin and is not a regulated market for the purposes of Directive 2014/65/EU.

Unless otherwise defined in this Second Base Prospectus Supplement, terms defined in the Base Prospectus shall have the same meaning when used in this Second Base Prospectus Supplement. To the extent that there is any inconsistency between any statement in this Second Base Prospectus Supplement and any other statement in, or incorporated by reference in, the Base Prospectus, the statements in this Second Base Prospectus Supplement will prevail.

- (d) incorporate the Morgan Stanley Proxy Statement dated 6 April 2023 (the "Morgan Stanley April 2023 Proxy Statement") by reference into the Base Prospectus, as set out in "Part A" of this Second Base Prospectus Supplement; and
- (e) make certain consequential amendments to the "General Information" section of the Base Prospectus as set out in "Part B" of this Second Base Prospectus Supplement.
