Morgan Stanley ("Morgan Stanley"), Morgan Stanley & Co. International plc ("MSI plc"), Morgan Stanley Finance LLC ("MSFL") and Morgan Stanley B.V. ("MSBV", together with Morgan Stanley, MSFL and MSI plc, the "Issuers") and Morgan Stanley, in its capacity as guarantor (in such capacity, the "Guarantor") have prepared this fourth base prospectus supplement (the "Fourth Base Prospectus Supplement") to supplement and be read in conjunction with the base prospectus dated 10 October 2017 (the "Base Prospectus") of Morgan Stanley, MSI plc, MSFL and MSBV (each in its capacity as Issuer) and Morgan Stanley (in its capacity as Guarantor) relating to the Regulation S Program for the Issuance of Notes, Series A and Series B, Warrants and Certificates as supplemented by the first supplement to the Base Prospectus dated 30 November 2017 (the "First Base Prospectus Supplement"), the second supplement to the Base Prospectus dated 29 March 2018 (the "Second Base Prospectus Supplement") and the third supplement to the Base Prospectus dated 16 May 2018 (the "Third Base Prospectus Supplement").

This Fourth Base Prospectus Supplement has been approved by the Luxembourg *Commission de Surveillance du Secteur Financier* (the "CSSF"), which is the Luxembourg competent authority for the purpose of Directive 2003/71/EC, as amended (the "Prospectus Directive") and relevant implementing measures in Luxembourg, as a prospectus supplement issued in compliance with Article 16.1 of the Prospectus Directive and relevant implementing measures in Luxembourg.

The CSSF gives no undertaking as to the economic and financial soundness of any transaction or the quality or solvency of any of the Issuers in line with the provisions of Article 7.7 of the Luxembourg Law on Prospectuses for Securities.

Unless otherwise defined in this Fourth Base Prospectus Supplement, terms defined in the Base Prospectus (as supplemented by the First Base Prospectus Supplement, Second Base Prospectus Supplement and Third Base Prospectus Supplement) shall have the same meaning when used in this Fourth Base Prospectus Supplement. To the extent that there is any inconsistency between any statement in, or incorporated by reference in, this Fourth Base Prospectus Supplement and any other statement in, or incorporated by reference in, the Base Prospectus (as supplemented by the First Base Prospectus Supplement, Second Base Prospectus Supplement and Third Base Prospectus Supplement), the statements in, or incorporated by reference in, this Fourth Base Prospectus Supplement will prevail.

The purpose of this Fourth Base Prospectus Supplement is to:

- disclose the publication of the Registration Document of Morgan Stanley, Morgan Stanley & Co. International plc, Morgan Stanley B.V. and Morgan Stanley Finance LLC dated 8 June 2018 (the "2018 Registration Document") and incorporate by reference certain sections of the 2018 Registration Document as set out in "Part A" of this Fourth Base Prospectus Supplement;
- (b) disclose the publication of the Proxy Statement of Morgan Stanley dated 6 April 2018 (the "2018 Proxy Statement") and incorporate by reference certain sections of the 2018 Proxy Statement as set out in "Part A" of this Fourth Base Prospectus Supplement; and
- make certain consequential amendments to the Base Prospectus (as supplemented by the First Base Prospectus Supplement, Second Base Prospectus Supplement and Third Base Prospectus Supplement) pursuant to the publication of the 2018 Registration Document and the 2018 Proxy Statement as set out in "Part B" of this Fourth Base Prospectus Supplement.

In accordance with Article 13 paragraph 2 of the Luxembourg Law on Prospectuses dated 10 June 2005, investors who have agreed to purchase or subscribe for, or have applied to purchase or subscribe for, any Notes prior to the publication of this Fourth Base Prospectus Supplement shall have the right, exercisable within two Business Days following the date of publication of this Fourth Base Prospectus Supplement, to withdraw their acceptances or applications by notice in writing to the relevant Issuer or Manager, as the case may be. The final date within which such right of withdrawal must be exercised is 13 June 2018.

Each of the Issuers and the Guarantor, as applicable, confirm the following:

Save as disclosed in this Fourth Base Prospectus Supplement, no significant new factor, material mistake or inaccuracy relating to information included in the Base Prospectus (as supplemented by the First Base Prospectus Supplement, Second Base Prospectus Supplement and Third Base Prospectus Supplement) has arisen since the publication of the Third Base Prospectus Supplement.

Each of the Issuers and Guarantor accepts responsibility for the information contained in this Fourth Base Prospectus Supplement. To the best of the knowledge and belief of the Issuers and the Guarantor (who have taken all reasonable care to ensure that such is the case), the information contained in this document is in accordance with the facts and does not omit anything likely to affect the import of such information.

Any information or documents incorporated by reference into the 2018 Registration Document are not incorporated by reference into this Fourth Base Prospectus Supplement as such information or documents are either not relevant for the investor or covered in another part of this Fourth Base Prospectus Supplement.
