Morgan Stanley, Morgan Stanley & Co. International plc ("MSI plc"), Morgan Stanley B.V. ("MSBV") and Morgan Stanley Finance LLC ("MSFL") have prepared this second supplement to the registration document (the "Second Registration Document Supplement") to supplement and be read in conjunction with the registration document dated 11 December 2020 (the "Registration Document"), as supplemented by the first supplement to the Registration Document dated 9 July 2021 (the "First Registration Document Supplement") of Morgan Stanley, MSI plc, MSBV and MSFL.

This Second Registration Document Supplement has been approved by the Luxembourg Commission de Surveillance du Secteur Financier (the "CSSF") as competent authority under Regulation (EU) 2017/1129 (the "Prospectus Regulation"), as a supplement to the Registration Document issued in compliance with Article 10(1) of the Prospectus Regulation for the purposes of providing information during the period twelve months after 11 December 2020 with regard to Morgan Stanley, MSI plc, MSBV and MSFL as issuers or obligors in respect of debt or derivative securities.

The CSSF only approves this Second Registration Document Supplement as meeting the standard of completeness, comprehensibility and consistency imposed by the Prospectus Regulation and the CSSF gives no undertaking as to the economic and financial soundness of any transaction or the quality or solvency of the issuers. Such approval should not be considered as an endorsement of the issuers that are the subject of this Second Registration Document Supplement.

Unless otherwise defined in this Second Registration Document Supplement, terms defined in the Registration Document shall have the same meaning when used in this Second Registration Document Supplement. To the extent that there is any inconsistency between any statement in, or incorporated by reference in, this Second Registration Document Supplement and any other statement in, or incorporated by reference in, the Registration Document, the statements in this Second Registration Document Supplement will prevail.

This Second Registration Document Supplement constitutes a supplement to and should be read in conjunction with, the Registration Document.

The purpose of this Second Registration Document Supplement is to:

- (a) disclose the publication by Morgan Stanley of its Quarterly Report on Form 10-Q for the quarterly period ended 30 June 2021 (the "Morgan Stanley June 2021 Form 10-Q") and incorporate by reference as set out in "Part A" of this Second Registration Document Supplement;
- (b) make certain consequential amendments to the Registration Document pursuant to the publication of the Morgan Stanley June 2021 Form 10-Q as set out in "Part B" of this Second Registration Document Supplement; and
- (c) make certain consequential amendments to the Registration Document pursuant to the publication of the Morgan Stanley June 2021 Form 10-Q as set out in "Part C" of this Second Registration Document Supplement.

Each Responsible Person (as defined below) accepts responsibility for the information contained in the relevant document and confirms that, to the best of its knowledge, having taken all reasonable care to ensure that such is the case, the information contained in the relevant document in accordance with the facts and does not omit anything likely to affect the import of such information.
