Morgan Stanley B.V. ("MSBV" or the "Issuer") and Morgan Stanley in its capacity as guarantor (the "Guarantor") have prepared this sixth base prospectus supplement (the "Sixth Base Prospectus Supplement") to supplement and be read in conjunction with the base prospectus dated 12 December 2016 (the "Base Prospectus"), the first base prospectus supplement dated 22 December 2016 (the "First Base Prospectus Supplement"), the second base prospectus supplement dated 24 March 2017 (the "Second Base Prospectus Supplement"), the third supplement to the Base Prospectus dated 18 May 2017 (the "Third Base Prospectus Supplement") and the fifth supplement to the Base Prospectus dated 13 June 2017 (the "Fourth Base Prospectus Supplement") of MSBV relating to the programme for the issuance of secured notes, warrants and certificates.

This Sixth Base Prospectus Supplement has been approved by the Central Bank of Ireland as competent authority for the purpose of Directive 2003/71/EC, as amended (the "**Prospectus Directive**") and relevant implementing measures in Ireland, as a base prospectus supplement issued in compliance with Article 16.1 of the Prospectus Directive and relevant implementing measures in Ireland. The Central Bank only approves this Sixth Base Prospectus Supplement as meeting the requirements imposed under Irish and EU law pursuant to the Prospectus Directive.

Terms defined in the Base Prospectus (as supplemented by the First Base Prospectus Supplement, the Second Base Prospectus Supplement, the Third Base Prospectus Supplement, the Fourth Base Prospectus Supplement and the Fifth Base Prospectus Supplement) shall have the same meaning when used in this Sixth Base Prospectus Supplement. To the extent that there is any inconsistency between any statement in this Sixth Base Prospectus Supplement and any other statement in the Base Prospectus (as supplemented by the First Base Prospectus Supplement, the Second Base Prospectus Supplement, the Third Base Prospectus Supplement, the Fourth Base Prospectus Supplement and the Fifth Base Prospectus Supplement), the statements in this Sixth Base Prospectus Supplement will prevail.

The purpose of this Sixth Base Prospectus Supplement is to:

- (a) disclose the publication by MSBV of its Interim Financial Report for the six months ended 30 June 2017 (the "MSBV June 2017 Interim Accounts") and incorporate by reference, as set out in "Part A" of this Sixth Base Prospectus Supplement;
- (b) disclose the publication of the second supplement to the Registration Document of Morgan Stanley, Morgan Stanley & Co. International plc, MSBV and Morgan Stanley Finance LLC dated 18 October 2017 (the "Second Registration Document Supplement") and incorporate by reference certain sections of the Second Registration Document Supplement as set out in "Part A" of this Sixth Base Prospectus Supplement; and
- (c) make certain consequential amendments to the Base Prospectus (as supplemented by the First Base Prospectus Supplement, the Second Base Prospectus Supplement, the Third Base Prospectus Supplement, the Fourth Base Prospectus Supplement and the Fifth Base Prospectus Supplement) pursuant to the publication of the MSBV June 2017 Interim Accounts and the Second Registration Document Supplement as set out in "Part B" of this Sixth Base Prospectus Supplement.

Each of the Issuer and the Guarantor accepts responsibility for the information contained in this Sixth Base Prospectus Supplement. To the best of the knowledge and belief of each of the Issuer and the Guarantor (who have taken all reasonable care to ensure that such is the case), the information contained in this Sixth Base Prospectus Supplement is in accordance with the facts and does not omit anything likely to affect the import of such information.

Save as disclosed in this Sixth Base Prospectus Supplement, no significant new factor, material mistake or inaccuracy relating to information included in the Base Prospectus (as supplemented by the First Base Prospectus Supplement, the Second Base Prospectus Supplement, the Third Base Prospectus Supplement, the Fourth Base Prospectus Supplement

and the Fifth Base Prospectus Supplement) has arisen since the publication of the Base Prospectus (as supplemented by the First Base Prospectus Supplement, the Second Base Prospectus Supplement, the Third Base Prospectus Supplement, the Fourth Base Prospectus Supplement and the Fifth Base Prospectus Supplement).
