Morgan Stanley, Morgan Stanley & Co. International plc ("MSI plc"), Morgan Stanley B.V. ("MSBV") and Morgan Stanley Finance LLC ("MSFL") have prepared this third supplement to the registration document (the "Third Registration Document Supplement") to supplement and be read in conjunction with the registration document dated 11 December 2020 (the "Registration Document"), as supplemented by the first supplement to the Registration Document dated 9 July 2021 and the second supplement to the Registration Document dated 17 August 2021 of Morgan Stanley, MSI plc, MSBV and MSFL.

This Third Registration Document Supplement has been approved by the Luxembourg Commission de Surveillance du Secteur Financier (the "CSSF") as competent authority under Regulation (EU) 2017/1129 (the "Prospectus Regulation"), as a supplement to the Registration Document issued in compliance with Article 10(1) of the Prospectus Regulation for the purposes of providing information during the period twelve months after 11 December 2020 with regard to Morgan Stanley, MSI plc, MSBV and MSFL as issuers or obligors in respect of debt or derivative securities.

The CSSF only approves this Third Registration Document Supplement as meeting the standard of completeness, comprehensibility and consistency imposed by the Prospectus Regulation and the CSSF gives no undertaking as to the economic and financial soundness of any transaction or the quality or solvency of the issuers. Such approval should not be considered as an endorsement of the issuers that are the subject of this Third Registration Document Supplement.

Unless otherwise defined in this Third Registration Document Supplement, terms defined in the Registration Document shall have the same meaning when used in this Third Registration Document Supplement. To the extent that there is any inconsistency between any statement in, or incorporated by reference in, this Third Registration Document Supplement and any other statement in, or incorporated by reference in, the Registration Document, the statements in this Third Registration Document Supplement will prevail.

This Third Registration Document Supplement constitutes a supplement to and should be read in conjunction with, the Registration Document.

The purpose of this Third Registration Document Supplement is to:

- (a) disclose the publication by MSI plc of its half-yearly financial report for the six months ended 30 June 2021 (the "MSI plc June 2021 Interim Accounts") and incorporate by reference, as set out in "Part A" of this Third Registration Document Supplement;
- (b) disclose the publication by MSBV of its interim financial report for the six months ended 30 June 2021 (the "MSBV June 2021 Interim Accounts") and incorporate by reference, as set out in "Part A" of this Third Registration Document Supplement;
- (c) disclose the publication by MSFL of its interim financial report for the six months ended 30 June 2021 (the "MSFL June 2021 Interim Accounts") and incorporate by reference, as set out in "Part A" of this Third Registration Document Supplement; and

(d) make certain consequential amendments to the Registration Document pursuant to the publication of the MSI plc June 2021 Interim Accounts, the MSBV June 2021 Interim Accounts and the MSFL June 2021 Interim Accounts, as set out in "Part B" of this Third Registration Document Supplement.

Each Responsible Person (as defined below) accepts responsibility for the information contained in the relevant document and confirms that, to the best of its knowledge, having taken all reasonable care to ensure that such is the case, the information contained in the relevant document in accordance with the facts and does not omit anything likely to affect the import of such information.
