# BASE PROSPECTUS FOR THE ISSUANCE OF NOTES, SERIES A AND SERIES B UNDER THE REGULATION S PROGRAM FOR THE ISSUANCE OF NOTES, SERIES A AND B, WARRANTS AND CERTIFICATES

#### This Base Prospectus

This document is a base prospectus ("Base Prospectus") prepared for the purposes of Article 8 of Regulation (EU) 2017/1129 (the "Prospectus Regulation") for the purpose of the offering of Notes (as described below) other than for Exempt Notes (as described below) from time to time. This Base Prospectus should be read together with (i) any supplements to it from time to time, (ii) the information incorporated by reference into it (see "Incorporation by Reference" below) and (iii) in relation to a Tranche of Notes, the Final Terms or Pricing Supplement (described below) relating to that Tranche of Notes. References in this Base Prospectus or the relevant Pricing Supplement to "Exempt Notes" are to Notes for which no prospectus is required to be published under the Prospectus Regulation.

The information on any websites referred to herein does not form part of this Base Prospectus unless that information is incorporated by reference into this Base Prospectus and has not been scrutinised or approved by the competent authority.

Application has been made to the Commission de Surveillance du Secteur Financier (the "CSSF") in its capacity as competent authority under the Luxembourg law of 16 July 2019 on prospectuses for securities (the "Luxembourg Law on Prospectuses") to approve this document as a base prospectus for the purposes of Article 3 of the Prospectus Regulation. The CSSF only approves this Base Prospectus as meeting the standards of completeness, comprehensibility and consistency imposed by the Prospectus Regulation. Such approval should not be considered an endorsement of the Issuer or the quality of the Notes that are the subject of this Base Prospectus and investors should make their own assessment as to the suitability of investing in the Notes. Pursuant to Article 6(4) of the Luxembourg Law on Prospectuses for securities, by approving this Base Prospectus, the CSSF gives no undertaking as to, and assumes no responsibility for, the economic and financial characteristics of the Notes or the quality and solvency of the Issuer.

Application has also been made to the Luxembourg Stock Exchange for the approval of this Base Prospectus with respect to Exempt Notes as a base prospectus for the purposes of the Luxembourg Law on Prospectuses. The CSSF has neither approved nor reviewed information contained in this Base Prospectus in connection with the issue of any Exempt Notes.

Application has been made to the Luxembourg Stock Exchange for Series A Notes issued under the Program to be admitted to trading on the regulated market (the "Regulated Market") or Euro MTF market (the "Euro MTF Market") of the Luxembourg Stock Exchange and to be listed on the Official List of the Luxembourg Stock Exchange. The Regulated Market is a regulated market for the purposes of Directive 2014/65/EU of the European Parliament and of the Council on markets in financial instruments (as amended, "MiFID II"). The Luxembourg Stock Exchange's Euro MTF market is not a regulated market for the purposes of MiFID II).

References in this Base Prospectus to Series A Notes being listed (and all related references) shall mean that such Notes have been admitted to the Official List of the Luxembourg Stock Exchange and to trading on the Regulated Market or Euro MTF market of the Luxembourg Stock Exchange or, as the case may be, listed and admitted to trading on the SIX Swiss Exchange AG ("SIX Swiss Exchange") or such other or further stock exchange(s) as the Issuer and any Distribution Agent may agree. The Issuer may also issue Series B Notes pursuant to this Base Prospectus which will not be listed or admitted to trading and may be offered to the public in the European Economic Area or the United Kingdom other than in circumstances where an exemption is available under Article 1.4 of the Prospectus Regulation or Article 1.4 of the Prospectus Regulation as it forms part of domestic law by virtue of the European Union (Withdrawal) Act 2018 (the "EUWA") (the "UK Prospectus Regulation").

The CSSF has neither approved nor reviewed information contained in this Base Prospectus in relation to any offer to the public or admission to trading on the SIX Swiss Exchange AG or any trading venue in Switzerland.

The CSSF has been requested in its capacity as competent authority under the Prospectus Regulation and the Luxembourg Law on Prospectuses to notify the competent authority of the Republic of Italy with a certificate of approval attesting that the Base Prospectus has been drawn up in accordance with the Prospectus Regulation.

This Base Prospectus will be valid for offers to the public or admissions to trading on a regulated market by or with the consent of the Issuer for 12 months from its date and will expire on 21 July 2026. The obligation to supplement it in the event of significant new factors, material mistakes or material inaccuracies will not apply after the earlier of the date 12 months from the date of this Base Prospectus and the closing of the offer period for the Notes or the Notes being admitted to trading on a regulated market, whichever occurs later.

This Base Prospectus has been (i) registered in Switzerland with the reviewing body (*Prüfstelle*) SIX Exchange Regulation AG or another reviewing body approved by the Swiss Financial Market Supervisory Authority FINMA as a foreign prospectus that is also deemed to be approved in Switzerland pursuant to Article 54(2) of the Swiss Federal Act on Financial Services ("**FinSA**") for inclusion on the list of approved prospectus pursuant to Article 64(5) FinSA, (ii) deposited with this reviewing body and (iii) published pursuant to Article 64 FinSA.

The information on any websites referred to herein does not form part of this Base Prospectus unless that information is incorporated by reference into the Base Prospectus and has not been scrutinised or approved by the competent authority.

#### The Program

Morgan Stanley ("Morgan Stanley"), Morgan Stanley & Co. International plc ("MSI plc"), Morgan Stanley B.V. ("MSBV"), Morgan Stanley Finance LLC ("MSFL"), Morgan Stanley Finance II Ltd ("MSFII") and Morgan Stanley Europe SE ("MSESE") established, or acceded to, the Regulation S Program for the Issuance of Notes, Series A and B, Warrants and Certificates (the "Program"). Under the Program, Morgan Stanley, MSI plc, MSBV, MSFL, MSFII and MSESE may offer from time to time Series A Notes and Series B Notes (together the "Notes issued under the Program"), Warrants (the "Warrants") and Certificates (the "Certificates", and together with the Notes issued under the Program and the Warrants, the "Program Securities"), to the extent permitted thereunder. Only certain of the Notes issued under the Program are described in this Base Prospectus, being those issued pursuant to the Issue and Paying Agency Agreement (as defined under "General Description of the Notes" below) (hereafter referred to collectively as the "Notes"). For the avoidance of doubt, (i) this Base Prospectus does not relate to or describe any Program Securities other than Series A Notes and Series B Notes that Morgan Stanley may issue pursuant to the Issue and Paying Agency Agreement and (ii) Morgan Stanley may from time to time issue Series A Notes and Series B Notes, pursuant to the Issue and Paying Agency Agreement or otherwise (including under an indenture), through means other than this Base Prospectus.

#### The Notes

Under this Base Prospectus, securities in the form of Notes may be offered.

#### Conditions of the Notes

The terms and conditions applicable to a Tranche of Notes (the "Conditions") are the Terms and Conditions (set out in the section entitled "Terms and Conditions of the Notes" below) as completed by the applicable Final Terms or Pricing Supplement (described below).

#### Final Terms and Pricing Supplement

A "final terms" document (the "**Final Terms**") or pricing supplement (the "**Pricing Supplement**") will be prepared in respect of each Tranche of Notes. The Final Terms or Pricing Supplement will complete the Terms and Conditions in relation to such Notes. Notice of the aggregate nominal amount of Notes, interest (if any) payable in respect of the Notes, the issue price of the Notes and certain other information which is applicable to each Tranche of Notes will be set out in such Final Terms, which will be filed with the CSSF, or such Pricing Supplement. The Final Terms or Pricing Supplement therefore contains vital information in regard to the Notes. Copies of Final Terms or Pricing Supplements in relation to Series A Notes to be listed on the Luxembourg Stock Exchange will also be available on the website of the

Luxembourg Stock Exchange (www.luxse.com). Copies of Final Terms which are required to be made available to the public in relation to Series B Notes will be available at http://sp.morganstanley.com/EU/Documents.

#### The Issuer

The issuer (the "Issuer") of Notes under this Base Prospectus from time to time will be Morgan Stanley. Information on the Issuer is included in this Base Prospectus, including information incorporated by reference.

#### Status of the Notes

The Notes are unsecured and unsubordinated obligations of the Issuer and not of any affiliate of the Issuer. The Notes are not deposits or savings accounts and are not insured by the United States of America ("U.S.") Federal Deposit Insurance Corporation or any other governmental agency or instrumentality or deposit protection scheme anywhere, nor are they obligations of, or guaranteed by, a bank.

#### Return on the Notes

Interest payments on the Notes may depend on the performance of one or more of any of the following types of underlying reference assets: interest rates, swap rates and inflation indices, as may be specified in the applicable Final Terms. In addition, the principal amount repayable or payable upon redemption may be determined by reference to one or more inflation indices as may be specified in the applicable Final Terms. In such instances, where the performance of the relevant inflation index or indices is positive, investors in the Notes will be able to participate in such positive performance. Conversely, if performance is negative, the return on the Notes to the investor is floored at 100 per cent. of the Calculation Amount of each Note. Furthermore, if "Accrued Value" is specified as being applicable in respect of a Note in the applicable Final Terms or Pricing Supplement, the principal amount payable upon redemption will be determined by reference to a formula as further specified in the Conditions and the applicable Final Terms or Pricing Supplement. The sponsor of any inflation index to which the Notes may be linked shall be an entity other than the Issuer or any legal entity belonging to the same group as the Issuer. For the avoidance of doubt, the final redemption amount in respect of such Notes will not be less than 100 per cent.

#### Benchmarks Regulation: Article 29(2) statements on benchmarks

Amounts payable under the Notes may be calculated by reference to (i) the Euro Interbank Offered Rate ("EURIBOR"), (ii) any CMS Reference Rate (as defined in Condition 2, and determined in accordance with Condition 6.7 (CMS Rate Determination), of "Terms and Conditions of the Notes"), (iii) SOFR (as defined in Condition 6.8 (Provisions specific to SOFR as a Reference Rate) of "Terms and Conditions of the Notes"), (iv) SONIA (as defined in Condition 6.9 (Provisions specific to SONIA as a Reference Rate) of "Terms and Conditions of the Notes"), (v) ESTR (as defined in Condition 6.10 (Provisions specific to ESTR as a Reference Rate) of "Terms and Conditions of the Notes"), (vi) SARON (as defined in Condition 6.11 (Provisions specific to SARON as a Reference Rate) of "Terms and Conditions of the Notes"), (vii) TONA (as defined in Condition 6.12 (Provisions specific to TONA as a Reference Rate) of "Terms and Conditions of the Notes") or (viii) one or more other specific indices or price sources or a combination of indices or price sources.

EURIBOR is provided by the European Money Markets Institute ("EMMI"). As at the date of this Base Prospectus, EMMI appears on the register of administrators and benchmarks established and maintained by the European Securities and Markets Authority ("ESMA") pursuant to Article 36 of Regulation (EU) 2016/1011 of the European Parliament and of the Council on indices used as benchmarks in financial instruments and financial contracts or to measure the performance of investment funds (the "Benchmarks Regulation").

A CMS Reference Rate is a constant maturity swap rate, calculated on a fixed-to-floating basis by reference to an underlying floating rate that can in itself constitute a "benchmark" for the purposes of the Benchmarks Regulation.

SOFR and SOFR Index are provided by the Federal Reserve Bank of New York (the "New York Federal Reserve"). As at the date of this Base Prospectus, the New York Federal Reserve does not appear on the register of administrators and benchmarks established and maintained by ESMA pursuant to Article 36 of the Benchmarks Regulation.

SONIA and SONIA Index are provided by the Bank of England. As at the date of this Base Prospectus, the Bank of England does not appear on the register of administrators and benchmarks established and maintained by ESMA pursuant to Article 36 of the Benchmarks Regulation.

€STR and €STR Index are provided by the European Central Bank. As at the date of this Base Prospectus, the European Central Bank does not appear on the register of administrators and benchmarks established and maintained by ESMA pursuant to Article 36 of the Benchmarks Regulation.

TONA is provided by the Bank of Japan. As at the date of this Base Prospectus, the Bank of Japan does not appear on the register of administrators and benchmarks established and maintained by ESMA pursuant to Article 36 of the Benchmarks Regulation.

As far as the Issuer is aware the New York Federal Reserve, as administrator of SOFR and SOFR Index, the Bank of England, as administrator of SONIA and SONIA Index, the European Central Bank, as administrator of  $\varepsilon$ TR and  $\varepsilon$ TR Index, and the Bank of Japan, as administrator of TONA, are not required to be registered by virtue of Article 2 of the Benchmarks Regulation.

SARON and SAION Index are provided by SIX Index AG and are endorsed for use in the European Union by SIX Financial Information Nordic AB. As at the date of this Base Prospectus, SIX Financial Information Nordic AB appears on the register of administrators and benchmarks established and maintained by ESMA pursuant to Article 36 of the Benchmarks Regulation.

TONA Index is provided by QUICK Corp. As at the date of this Base Prospectus, QUICK Corp. does not appear on the register of administrators and benchmarks established and maintained by ESMA pursuant to Article 36 of the Benchmarks Regulation. As far as the Issuer is aware, as at the date of this Base Prospectus, the transitional provisions in Article 51 of the Benchmarks Regulation apply, such that QUICK Corp. is not currently required to obtain authorisation or registration (or, if located outside the European Union, recognition, endorsement or equivalence).

Similarly, any other index or price source by reference to which amounts payable under the Notes are calculated may also constitute a "benchmark" for the purposes of the Benchmarks Regulation.

In cases where amounts payable under the Notes are calculated by reference to a CMS Reference Rate or one or more other indices or price sources that is not one of EURIBOR, SOFR, SOFR Index, SONIA, SONIA Index, €STR, €STR Index, SARON, SAION Index, TONA or TONA Index, the relevant Final Terms or Pricing Supplement will specify:

- the name of each index or price source so referenced;
- the legal name of the administrator of each such index or price source; and
- whether or not the legal name of the administrator of each such index or price source appears on the register of administrators and benchmarks established and maintained by ESMA pursuant to Article 36 of the Benchmarks Regulation.

Not every index or price source will fall within the scope of the Benchmarks Regulation. #### GENERAL DESCRIPTION OF THE NOTES

The following overview describes the key features of the Notes that the Issuer is offering under the Program pursuant to this Base Prospectus in general terms only. Investors should read this general description together with the more detailed information that is contained in this Base Prospectus and in the applicable Final Terms or Pricing Supplement. This section constitutes a General Description of the Program for the purpose of Article 25.1(b) of Commission Delegated Regulation (EU) 2019/980.

**Issuer:** Morgan Stanley.

**Distribution Agent:** Morgan Stanley & Co. International plc.

**Fiscal Agent:** The Bank of New York Mellon, London Branch.

Registrar and Transfer Agent: The Bank of New York Mellon SA/NV, Luxembourg Branch

(together with the Fiscal Agent, the "Agents")

**Notes:** Series A Notes and Series B Notes which are issued by Morgan

Stanley under the Regulation S Program for the Issuance of Notes, Series A and B, Warrants and Certificates (the "**Program**"), and which are issued pursuant to the issue and paying agency agreement dated as of 21 July 2025 between the Issuer and the Agents (the "**Issue and Paying Agency Agreement**"). For the avoidance of doubt, this Base Prospectus does not relate to or

describe any securities other than the Notes.

Authorisation: The issue of, amongst others, the Notes were authorised by

Morgan Stanley pursuant to resolutions (the "Authorising Resolutions") adopted at a meeting of the Board of Directors of Morgan Stanley held on 25 September 1998, 17 June 2003, 14 December 2004, 20 September 2005, 12 December 2006, 19 June

2007, 17 September 2007 and 16 June 2008.

**Issuance in Series:** Notes will be issued in series (each a "Series"). Each Series may

comprise one or more tranches ("Tranches" and each a "Tranche") issued on different issue dates. The Notes of each Series will all be subject to identical terms, except that the issue date and the amount of the first payment of interest may be different in respect of different Tranches and each Series may comprise Notes of different denominations. The Notes of each Tranche will all be subject to identical terms in all respects, save that a Tranche may comprise Notes of different denominations.

Forms of Notes: Notes will be issued in registered form and may be in either

individual certificate form or in global certificate form.

Each global note certificate will either be: (a) in the case of Notes which are not to be held under the New Safekeeping Structure (as defined below), registered in the name of a nominee of a common depositary for the Relevant Clearing System and the relevant global note certificate will be deposited on or about the issue date with the common depositary; or (b) in the case of Notes which are to be held under the new safekeeping structure ("New Safekeeping Structure" or "NSS"), registered in the name of a nominee of a common safekeeper for Euroclear and/or Clearstream, Luxembourg and the relevant global note certificate

will be deposited on or about the issue date with the common safekeeper for Euroclear and/or Clearstream, Luxembourg.

**Terms and Conditions:** 

A set of final terms or pricing supplement will be prepared in respect of each Tranche of Notes (each a "Final Terms" or a "Pricing Supplement", as applicable). The terms and conditions applicable to each Tranche will be those set out herein under the heading "Terms and Conditions of the Notes", as completed by the applicable Final Terms or Pricing Supplement in relation to such Tranche. The applicable Final Terms or Pricing Supplement will also specify which of the provisions set out in the Terms and Conditions are applicable in respect of a particular Series of Notes.

**Specified Currency:** 

Notes may be denominated or payable in any currency as set out in the applicable Final Terms or Pricing Supplement, subject to all applicable consents being obtained and compliance with all applicable legal and regulatory requirements.

Status:

The Notes constitute part of the Issuer's senior debt and will rank pari passu with all of the Issuer's other unsecured and unsubordinated debt.

Morgan Stanley intends that the Notes will, when issued, constitute "loss-absorbing capacity" within the meaning of the final rules issued by the Board of Governors of the Federal Reserve System and, accordingly, will have only those provisions described in this Base Prospectus that will permit compliance thereof at such time of issuance. In this respect, Morgan Stanley is a parent holding company and has no operations and depends on dividends, distributions and other payments from its subsidiaries to fund its debt obligations (including Notes). Under a support agreement that Morgan Stanley has entered with its material subsidiaries, upon the occurrence of a resolution scenario, including a single-point-of-entry resolution strategy as contemplated in its resolution plan, Morgan Stanley would be obligated to contribute or loan on a subordinated basis all of its material assets, other than shares in its subsidiaries and certain intercompany payables, to provide capital and liquidity, as applicable, to its material subsidiaries. That obligation will be secured, in accordance with an amended and restated secured support agreement, on a senior basis by Morgan Stanley's assets (other than shares in its subsidiaries). As a result, claims of Morgan Stanley's material subsidiaries against its assets (other than shares in its subsidiaries) will be effectively senior to its unsecured obligations, including Notes which would be at risk of absorbing Morgan Stanley's and its subsidiaries' losses.

**Issue Price:** 

Notes may be issued at any price, as specified in the applicable Final Terms or Pricing Supplement, subject to compliance with all applicable legal and regulatory requirements.

**Maturities:** 

Notes will have maturities as specified in the applicable Final Terms or Pricing Supplement, subject to compliance with all applicable legal and regulatory requirements.

Notes having a maturity of less than one year will, if the issue proceeds are accepted in the UK, constitute deposits for the purposes of the prohibition on accepting deposits contained in section 19 of the Financial Services and Markets Act 2000 (as

amended) unless they are issued to a limited class of professional investors and have a denomination of at least £100,000 or its equivalent, see "Subscription and Sale".

**Redemption:** 

The applicable Final Terms or Pricing Supplement will indicate either that the relevant Notes cannot be redeemed prior to their stated maturity (other than as provided in "Early Redemption" below) or that such Notes will be redeemable at the option of the Issuer upon giving notice to the Noteholders on a date or dates specified prior to such stated maturity and at a price or prices specified.

The redemption amount payable in respect of the Notes may be linked to the performance of an Inflation Index (see "Inflation-Linked Notes" below).

Unless previously redeemed or purchased and cancelled, each Note will be redeemed by the Issuer at no less than 100 per cent. of its nominal value on its maturity date.

Notes having a maturity of less than one year may be subject to restrictions on their denomination and distribution, see above.

**Early Redemption:** 

Early redemption will be permitted for taxation reasons as mentioned in Condition 10.2 (*Tax Redemption*) of the "*Terms and Conditions of the Notes*" but will otherwise be permitted (including, without limitation, following the occurrence of an Inconvertibility Event) only to the extent specified in the applicable Final Terms or Pricing Supplement.

Interest:

Notes may be interest-bearing or non-interest-bearing. Interest (if any) may accrue at a fixed rate (which may be zero), a floating rate, a rate which varies during the lifetime of the relevant Series or at a rate which is linked to the performance of an Inflation Index (see "Inflation-Linked Notes" below).

**Inflation-Linked Notes:** 

The Issuer may issue Notes that are Inflation-Linked Notes as defined in Condition 8 (*Inflation-Linked Note Provisions*) of the "*Terms and Conditions of the Notes*". The applicable Final Terms or Pricing Supplement in respect of each issue of Inflation-Linked Notes will specify the basis for calculating the amounts of interest payable and/or principal repayable or payable, which will be determined by reference to the performance of the Inflation Index specified in the applicable Final Terms or Pricing Supplement.

**Denominations:** 

Notes will be issued in such denominations as may be specified in the applicable Final Terms or Pricing Supplement, subject to compliance with all applicable legal and regulatory requirements.

**Taxation:** 

Payments made by the Issuer in respect of any Notes will be made without withholding or deduction for, or on account of, any Tax (as defined below) imposed or levied by or on behalf of the U.S. or any representative political subdivision thereof or any authority or agency therein or thereof having power to tax, unless the withholding or deduction of those Taxes is required by law. In order to avoid withholding, the beneficial owner of the Note (or a financial institution holding the Note on behalf of the beneficial owner that is not a United States person) is required under currently applicable law to timely furnish the appropriate IRS Form W-8 on which the beneficial owner certifies under penalties

of perjury that it is not a United States person and meets the criteria for exemption from U.S. withholding tax. No additional amounts will be paid with respect to any taxes, including with respect to taxes imposed due to the failure to timely provide the appropriate IRS Form W-8 or taxes withheld under FATCA. See "Taxation – United States Federal Taxation".

**Benefit Plan Investors:** 

The Notes may not be acquired or held by, or acquired with the assets of, any employee benefit plan subject to Title I of the United States Employee Retirement Income Security Act of 1974, as amended ("ERISA"), any individual retirement account or plan subject to Section 4975 of the United States Internal Revenue Code of 1986, as amended, or any entity whose underlying assets include "plan assets" within the meaning of Section 3(42) of ERISA by reason of any such employee benefit plan, account or plan's investment therein.

**Use of Proceeds:** 

The net proceeds from the sale of Notes will be used by the Issuer for general corporate purposes.

**Listing and Admission to Trading:** 

Applications have been made to admit the Notes which are "Series A" Notes by Morgan Stanley to the Luxembourg Stock Exchange. The applicable Final Terms or Pricing Supplement will specify whether an issue of Notes which are "Series A Notes" will be admitted to the Official List of the Luxembourg Stock Exchange and to trading on the Regulated Market or Euro MTF Market of the Luxembourg Stock Exchange, or admitted to listing and trading on the SIX Swiss Exchange or admitted to listing. trading and/or quotation by any other listing authority, stock exchange and/or quotation system, as the Issuer and any Distribution Agent may agree. Notes which are "Series B" Notes will not be admitted to listing, trading and/or quotation by any listing authority, stock exchange and/or quotation system but may be offered to the public in the European Economic Area or the United Kingdom other than in circumstances where an exemption is available under Article 1.4 of the Prospectus Regulation or Article 1.4 of the UK Prospectus Regulation, as applicable.

The Issuer may, without the consent of Noteholders and provided certain conditions are satisfied, agree to (i) substitute a subsidiary of Morgan Stanley in place of the Issuer or (ii) substitute a non-Morgan Stanley Group entity in place of the Issuer (provided that such non-Morgan Stanley Group entity is of at least the equivalent creditworthiness to the Issuer). Any such substitution may result in a reduction in the value of the Notes. Additionally, if the Issuer substitutes an entity in place of the Issuer, the tax consequences (including the withholding tax consequences) of holding the Notes may change. Except as provided in Condition 12.1 (Additional Amounts), if withholding tax is required on the Notes, no additional amounts will be required to be paid.

#### 2. Risk Factors relating to some or all of the Notes

#### 2.1 The value of the Notes may be influenced by unpredictable factors

The value of the Notes may be influenced by several factors beyond the Issuer's and/or its Affiliates' control, including:

- (i) Interest Rates. Investments in the Notes may involve interest rate risk. The interest rate level may fluctuate on a daily basis and cause the value of the Notes to change on a daily basis. The interest rate risk is a result of the uncertainty with respect to future changes of the market interest rate level.
- (ii) Inflation. Investments in the Notes may involve inflation rate risk. Inflation rates may be affected by the economic, financial and political events in one or more jurisdictions. Rates of inflation may also be subject to significant fluctuations that may not correlate with changes in interest rates or currencies and investors should be aware that the timing of such changes may affect the value of the Notes, even if the average level of inflation is consistent with their expectations.
- (iii) Remaining Term. Generally, the effect of pricing factors over the term of the Notes will decrease as the maturity date approaches. However, this reduction in the effect of pricing factors will not necessarily develop consistently up until the maturity date, but may undergo temporary acceleration and/or deceleration.
- (iv) Creditworthiness. Any prospective investor who purchases the Notes is relying upon the creditworthiness of the Issuer, and has no rights against any other person. If the Issuer becomes insolvent, investors may suffer potential loss of their entire investment irrespective of any favourable development of the other value determining factors. The ability of the Issuer to make its full payment obligations is subject to the Issuer not being insolvent.

Some or all of the above factors will influence the price investors will receive if an investor sells its Notes prior to maturity, which is usually referred to as "secondary market practice". The secondary market price may be lower than the market value of the issued Notes as at the Issue Date to take into account, amongst other things, changes in market interest rates or inflation rates, amounts paid to distributors and other intermediaries relating to the issue and sale of the Notes and amounts relating to the hedging of the Issuer's obligations. As a result of all of these factors, any investor that sells the Notes before the stated expiration or maturity date may receive an amount in the secondary market which may be less than the then intrinsic market value of

the Notes and which may also be less than the amount the investor would have received had the investor held the Notes through to maturity.

#### 2.2 The Notes may be redeemed prior to maturity

Unless, in the case of any particular Series of Notes, the applicable Final Terms or Pricing Supplement specify otherwise, in the event that the Issuer would be obliged to increase the amounts payable in respect of any Notes due to any withholding or deduction for, or on account of, any taxes, duties, assessments or governmental charges of whatever nature imposed, levied, collected, withheld or assessed by or on behalf of any relevant jurisdiction, the Issuer may redeem all outstanding Notes in accordance with the Conditions at the early redemption amount specified in the applicable Final Terms or Pricing Supplement.

In addition, if, in the case of any particular Tranche of Notes, the applicable Final Terms or Pricing Supplement specify that the Notes are redeemable at the Issuer's option in certain other circumstances, the Issuer may choose to redeem the Notes at times when prevailing interest rates may be relatively low. In such circumstances, an investor may not be able to reinvest the redemption proceeds in a comparable security at an effective interest rate as high as that of the relevant Notes.

In addition, an optional redemption feature in any particular Tranche of Notes is likely to limit their market value. During any period when the Issuer may elect to redeem Notes, the market value of those Notes generally will not rise substantially above the price at which they can be redeemed. This also may be true prior to any redemption period.

In the case of certain Notes, if such Notes are redeemed early for any reason, the amount payable by the Issuer may be less than the amount that would have been paid had the Notes been redeemed at maturity.

In addition, in the circumstance of an event of default by the Issuer and acceleration of the Notes, the investor would have an unsecured claim against the Issuer for the amount due on the early redemption of the Notes.

#### 2.3 Notes issued at a substantial discount or premium

The market values of Notes issued at a substantial discount or premium from their principal amount tend to fluctuate more in relation to general changes in interest rates than do prices for conventional interest-bearing Notes. Generally, the longer the remaining term of such Notes, the greater the price volatility as compared to conventional interest-bearing Notes with comparable maturities.

#### 2.4 Secondary trading of the Notes may be limited

Potential investors should be willing to hold the Notes until maturity. The nature and extent of any secondary market in the Notes cannot be predicted and there may be little or no secondary market in the Notes. As a consequence, any person intending to hold the Notes should consider liquidity in the Notes as a risk. Where the Notes are listed or quoted on an exchange or quotation system, this does not imply greater or lesser liquidity than if equivalent Notes were not so listed or quoted and the Issuer cannot guarantee that the listing or quotation will be permanently maintained. Where the Notes are not listed or quoted, it becomes more difficult to purchase and sell such Notes and there may also be a lack of transparency with regard to pricing information.

Further, although an issuer may apply to have certain issuances of Notes admitted to listing on the Official List of the Luxembourg Stock Exchange and to trading on the Regulated Market or Euro MTF Market of the Luxembourg Stock Exchange, or admitted to listing and trading on the SIX Swiss Exchange, or admitted to listing, trading and/or quotation by any other listing authority, stock exchange and/or quotation system, approval for any listing is subject to meeting the relevant listing requirements. Even if there is a secondary market, it may not provide enough liquidity to allow the investor to sell or trade the Notes easily. Morgan Stanley & Co. International plc and other affiliates of Morgan Stanley may, from time to time, make a market in the Notes, but they are not required to do so, save to the extent required under the rules of any stock exchange on which the Notes are listed and admitted to trading. If Morgan Stanley & Co. International plc or one or more of its affiliates does make a market for the Notes, it may cease to do so at any time without notice to investors and it is not obligated to provide any quotation of bid or offer price(s) for the Notes which is favourable to investors. If at any time

Morgan Stanley & Co. International plc and other affiliates of the Issuer were to cease making a market in the Notes, it is likely that there would be little or no secondary market for the Notes. This may impact the ability of a Noteholder to sell the Notes at any time.

#### 2.5 *Modification and waiver*

The Conditions of the Notes contain provisions for calling meetings of Noteholders to consider matters affecting their interests generally. These provisions permit defined majorities to bind all holders of the relevant Notes, including holders who did not attend and vote at the relevant meeting and holders who voted in a manner contrary to the majority. Holders of the Notes should be aware that if they are not part of the defined majority, including if such holder did not attend the relevant meeting, they will be bound by the decision of the defined majority on matters which may negatively affect the interests of such holder.

#### 2.6 Restricted secondary trading if the electronic trading system is unavailable

Trading in the Notes may be conducted via one or more electronic trading systems so that "buy" and "sell" prices can be quoted for exchange and off-exchange trading. If an electronic trading system used by the Issuer and/or its Affiliates were to become partially or completely unavailable, such a development would have a corresponding effect on the ability of investors to trade the Notes.

#### 2.7 Payments on certain Notes may be subject to U.S. withholding tax

Payments on a Note may be subject to U.S. withholding tax of 30 per cent. if the beneficial owner of the Note does not meet the criteria for being exempt from this withholding tax, including the requirement that the beneficial owner (and any financial institution holding the Note on behalf of the beneficial owner) complies with certain U.S. tax identification and certification requirements, generally by furnishing the appropriate IRS Form W-8 on which the beneficial owner certifies under penalties of perjury that it is not a United States person, as defined in the U.S. Internal Revenue Code of 1986, as amended (the "Code"), and meets the criteria for exemption from such U.S. withholding tax.

As discussed in "Taxation – United States Federal Taxation", Sections 1471 through 1474 of the Code, an agreement entered into with the IRS pursuant to such sections of the Code, or an intergovernmental agreement (an "IGA") between the U.S. and another jurisdiction in furtherance of such sections of the Code (including any non-U.S. laws and regulations implementing such an IGA) (collectively referred to as "FATCA") may impose a withholding tax of 30 per cent. on payments made on the Notes (including payments made by financial intermediaries), unless various U.S. information reporting and due diligence requirements have been satisfied.

If U.S. withholding tax is imposed, including because a beneficial owner (or financial institution holding a Note on behalf of a beneficial owner) does not timely provide the required U.S. tax forms or meet the criteria for exemption from such U.S. withholding tax or if withholding is imposed under FATCA, none of the Issuer or any intermediary will be required to pay any additional amounts or otherwise indemnify a holder with respect to the amounts so withheld. See "Taxation – United States Federal Taxation" for further discussion of these rules. Prospective investors should therefore be aware that, if U.S. withholding tax is so imposed, investors will receive less than the amount that investors would have been entitled to receive under the terms of the Notes if such U.S. withholding tax had not been imposed.

#### 2.8 Issuer call option risk

If Call Option is specified in the applicable Final Terms or Pricing Supplement as being applicable, the Issuer will have the right to redeem the Notes on any "Optional Redemption Date (Call)". Following the exercise by the Issuer of such Call Option, the investors will be entitled to receive a pre-determined amount which may be less than the amount that the investors would have been entitled to receive under the terms of the Notes, if such Call Option had not been exercised.

The determination to redeem the Notes will be made by the Issuer taking into account a number of factors, including (in the case of Inflation-Linked Notes) the current level of the Inflation Index to which the Notes are linked, and the likelihood that such levels will be maintained or will decrease or increase, in the future and it is likely that the Issuer will exercise the Call Option

at a time in which the redemption of the Notes is least favourable for the investors. The Issuer shall make such determination without taking into account the interest of the investors. The Call Option therefore can limit the possibility for investors to realise in full the expected returns.

An optional redemption feature of the Notes is likely to limit their market value. During any period when the Issuer may elect to redeem the Notes, the market value of those Notes generally will not rise substantially above the price at which they can be redeemed.

If the Notes are Inflation-Linked Notes and the Issuer exercises the Call Option, investors in the Notes will no longer be able to participate in the performance of the Inflation Index or Inflation Indices to which the Notes are linked.

If the Issuer exercises the Call Option, investors generally might not be able to reinvest the redemption proceeds rate in the same market environment as it was available at the time in which they invested in the Notes and they might be unable to reinvest at a comparable rate of returns. Investors should consider reinvestment risk in light of other investments available at the time of their investment decision.

#### 2.9 The Issuer may amend the terms and conditions of the Notes without Noteholder consent

Condition 17.2 (*Modification*) allows the Issuer to amend the terms and conditions of the Notes without the consent of the Noteholders, if, in the Issuer's opinion, the amendment is: to correct a manifest error or to effect a modification which is of a formal, minor or technical nature; to cure any ambiguity or correct or supplement any defective provisions; to correct an error or omission such that, in the absence of such correction, the relevant terms proposed to be corrected would not otherwise represent the intended terms on which the relevant Notes were sold and have since traded; or not materially prejudicial to Noteholders. Prospective investors should be aware that the Issuer is not required to consult with any other party, including the Noteholders, prior to amending the terms and conditions of the Notes pursuant to Condition 17.2 (*Modification*). The Issuer is entitled to exercise its discretion in making these determinations and Noteholders will be bound by any such amendments made pursuant to Condition 17.2 (*Modification*), notwithstanding that the Noteholder's consent is not required for such amendments.

## 2.10 Investors may receive no or a limited amount of interest, payments may occur at a different time than expected and payments may be made in a different currency than expected

Potential investors should be aware that, depending on the terms of the relevant Notes, (i) they may receive no or a limited amount of interest, (ii) payments may occur at a different time than expected and/or (iii) payments may be made in a different currency than expected.

#### 2.11 Status of the Notes

The Notes constitute part of the Issuer's senior debt and will rank pari passu with all of the Issuer's other unsecured and unsubordinated debt.

Morgan Stanley intends that the Notes will, when issued, constitute "loss-absorbing capacity" within the meaning of the final rules issued by the Board of Governors of the Federal Reserve System and, accordingly, will have only those provisions described in this Base Prospectus that will permit compliance thereof at such time of issuance. In this respect, Morgan Stanley is a parent holding company and has no operations and depends on dividends, distributions and other payments from its subsidiaries to fund its debt obligations (including Notes). Under a support agreement that Morgan Stanley has entered with its material subsidiaries, upon the occurrence of a resolution scenario, including a single-point-of-entry resolution strategy as contemplated in its resolution plan, Morgan Stanley would be obligated to contribute or loan on a subordinated basis all of its material assets, other than shares in its subsidiaries and certain intercompany payables, to provide capital and liquidity, as applicable, to its material subsidiaries. That obligation will be secured, in accordance with an amended and restated secured support agreement, on a senior basis by Morgan Stanley's assets (other than shares in its subsidiaries). As a result, claims of Morgan Stanley's material subsidiaries against its assets (other than shares in its subsidiaries) will be effectively senior to its unsecured obligations, including Notes which would be at risk of absorbing Morgan Stanley's and its subsidiaries' losses.

## 2.12 Investors who hold less than the minimum Specified Denomination may be unable to sell their Notes and may be adversely affected if definitive Notes are subsequently required to be issued

In relation to any issue of Notes which have denominations consisting of a minimum Specified Denomination plus one or more higher integral multiples of another smaller amount, it is possible that such Notes may be traded in amounts in excess of the minimum Specified Denomination that are not integral multiples of such minimum Specified Denomination. In such a case, a holder who, as a result of trading such amounts, holds an amount which is less than the minimum Specified Denomination in his account with the relevant clearing system would not be able to sell the remainder of such holding without first purchasing a principal amount of Notes at or in excess of the minimum Specified Denomination such that its holding amounts to a Specified Denomination. Further, a holder who, as a result of trading such amounts, holds an amount which is less than the minimum Specified Denomination in his account with the relevant clearing system at the relevant time may not receive a definitive Note in respect of such holding (should definitive Notes be issued) and would need to purchase a principal amount of Notes at or in excess of the minimum Specified Denomination such that its holding amounts to a Specified Denomination.

If such Notes in definitive form are issued, holders should be aware that definitive Notes which have a denomination that is not an integral multiple of the minimum Specified Denomination may be illiquid and difficult to trade.

#### 2.13 Italian Tax changes may affect the tax treatment of the Notes

Italian Law No. 111 of 9 August 2023, published in the Official Gazette No. 189 of 14 August 2023 ("Italian Law 111"), delegates power to the Italian Government to enact, within twenty-four months from its publication, one or more legislative decrees implementing the reform of the Italian tax system (the "Italian Tax Reform").

According to Italian Law 111, the Italian Tax Reform could significantly change the statements set out under section "Italian Taxation" below and introduce various amendments in the Italian tax system at different levels. The precise nature, extent, and impact of these amendments cannot be quantified or foreseen with certainty at this stage, as not all legislative decrees implementing the Italian Tax Reform have been enacted yet.

The information provided in this Base Prospectus may not reflect the future tax landscape accurately.

Investors should be aware that the amendments that may be introduced could increase the taxation on income and/or capital gains accrued or realised under the Securities and could result in a lower return of their investment.

Prospective investors should consult their own tax advisors regarding the tax consequences of the Italian Tax Reform.

#### 3. Risk Factors relating to currencies, exchange rates and inflation

#### 3.1 Exchange rates and exchange controls may affect the value or return of the Notes

General Exchange Rate and Exchange Control Risks. An investment in a Note denominated in currencies other than the investor's home currency entails significant risks. These risks include the possibility of significant changes in rates of exchange between its home currency and the other relevant currencies and the possibility of the imposition or modification of exchange controls by the relevant governmental authorities. These risks generally depend on economic and political events over which the Issuer has no control. Such risks may impact the payments due under the Notes and therefore the value or return of the Notes.

Exchange Rates Will Affect the Investor's Investment. In recent years, rates of exchange between some currencies have been highly volatile and this volatility may continue in the future. Fluctuations in any particular exchange rate that have occurred in the past are not necessarily indicative, however, of fluctuations that may occur during the term of any Note. Depreciation against the investor's home currency or the currency in which a Note is payable would result in

a decrease in the effective yield of the Note below its coupon rate and could result in an overall loss to an investor on the basis of the investor's home currency.

The Issuer Has No Control Over Exchange Rates. Currency exchange rates can either float or be fixed. Exchange rates of most economically developed nations are permitted to fluctuate in value relative to each other. However, from time to time, governments may use a variety of techniques, such as intervention by a country's central bank, the imposition of regulatory controls or taxes, or changes in interest rate to influence the exchange rates of their currencies. Governments may also issue a new currency to replace an existing currency or alter the exchange rate or relative exchange characteristics by a devaluation or revaluation of a currency. These governmental actions could change or interfere with currency valuations and currency fluctuations that would otherwise occur in response to economic forces, as well as in response to the movement of currencies across borders.

As a consequence, these government actions could adversely affect yields or payouts in the investor's home currency for Notes denominated or payable in currencies other than the investor's home currency.

The Issuer will not make any adjustment or change in the terms of the Notes in the event that exchange rates should become fixed, or in the event of any devaluation or revaluation or imposition of exchange or other regulatory controls or taxes, or in the event of other developments affecting any currency. Therefore, the investor will bear those risks, which may adversely impact the return on and the value of the Notes.

Some Currencies May Become Unavailable. Governments have imposed from time to time, and may in the future impose, exchange controls that could also affect the availability of a Specified Currency (as defined herein). Even if there are no actual exchange controls, it is possible that the applicable currency for any security would not be available when payments on that security are due.

#### 3.2 Emerging market currencies

Where the Notes are denominated in an emerging market currency, such emerging market currencies can be significantly more volatile than currencies of more developed markets. Emerging markets currencies are highly exposed to the risk of a currency crisis happening in the future. In certain circumstances (including, without limitation, if an Inconvertibility Event occurs), the Determination Agent may be required to make certain adjustments to the terms and conditions applicable to the Notes and, in doing so, may be entitled to exercise substantial discretion. Such adjustments may have an adverse effect on the value or return of the Notes.

#### 3.3 Risks related to CNY Notes

In this Risk Factor, references to "CNY Notes" are to Notes denominated in CNY or Renminbi deliverable in Hong Kong, or such other CNY Centre as specified in the applicable Final Terms or Pricing Supplement.

Renminbi is not a completely freely convertible currency at present, and there are still significant restrictions on remittance of Renminbi into and outside the People's Republic of China ("PRC") which may affect the liquidity of the Notes.

The PRC government continues to regulate conversion between Renminbi and foreign currencies, including the Hong Kong dollar, despite a reduction in recent years by the PRC government of control over routine foreign exchange transactions for current account items such as payments for imported goods and salary payments. Participating banks in Hong Kong have been permitted to engage in the settlement of Renminbi trade transactions under a pilot scheme introduced in July 2009. The pilot scheme was extended in June 2010 to cover 20 provinces and cities in the PRC and was further extended in August 2011 to cover all of the PRC and to make Renminbi trade and other current account item settlement available in all countries worldwide.

However, remittance of Renminbi by foreign investors into the PRC for purposes such as capital contributions, known as capital account items, is generally only permitted upon obtaining specific approvals from, or completing specific regulations or filings with, the relevant authorities on a case-by-case basis and subject to a strict monitoring system. Regulations in the PRC on the remittance of Renminbi into the PRC for settlement of capital account items are developing gradually.

On 13 October 2011, the People's Bank of China (the "PBOC") promulgated the "Administrative Measures on Renminbi Settlement of Foreign Direct Investment" (the "PBOC FDI Measures") as part of the implementation of the PBOC's detailed foreign direct investments ("FDI") accounts administration system. The system covers almost all aspects in relation to FDI, including capital injections, payments for the acquisition of PRC domestic enterprises, repatriation of dividends and other distributions, as well as Renminbi-denominated cross-border loans. On 14 June 2012, the PBOC further issued the implementing rules for the PBOC FDI Measures. Under the PBOC FDI Measures, special approval for RMB FDI and shareholder loans from the PBOC, which was previously required, is no longer necessary. In some cases, however, post-event filing with the PBOC is still necessary.

On 3 December 2013, the Ministry of Commerce of the PRC ("MOFCOM") promulgated the "Circular on issues in relation to Cross-border Renminbi Foreign Direct Investment" (the "MOFCOM Circular"), which became effective on 1 January 2014, to further facilitate FDI by simplifying and streamlining the applicable regulatory framework. Pursuant to the MOFCOM Circular, written approval from the appropriate office of MOFCOM and/or its local counterparts specifying "Renminbi Foreign Direct Investment" and the amount of capital contribution is required for each FDI. Unlike previous MOFCOM regulations on FDI, the MOFCOM Circular removes the approval requirement for foreign investors who intend to change the currency of their existing capital contribution from a foreign currency to Renminbi. In addition, the MOFCOM Circular also clearly prohibits FDI funds from being used for any investments in securities and financial derivatives (except for investments in PRC-listed companies by strategic investors) or for entrustment loans in the PRC.

As the MOFCOM Circular and the PBOC FDI Measures are relatively new circulars, they will be subject to interpretation and application by the relevant authorities in the PRC.

Although the Renminbi was added to the Special Drawing Rights basket created by the International Monetary Fund on 1 October 2016, there is no assurance that the PRC government will continue to gradually liberalise control over cross-border remittance of Renminbi in the future, that any schemes for Renminbi cross-border utilisation will not be discontinued or that new regulations in the PRC will not be promulgated in the future which have the effect of restricting or eliminating the remittance of Renminbi into or outside the PRC. In the event that any regulatory restrictions inhibit the ability of the Issuer to repatriate funds outside the PRC to meet its obligations under CNY Notes, the Issuer will need to source Renminbi offshore to finance such obligations under CNY Notes, and its ability to do so will be subject to the overall availability of Renminbi outside the PRC.

The limited availability of Renminbi outside the PRC may affect the liquidity of the CNY Notes and the Issuer's ability to source Renminbi to make payments in respect of the CNY Notes.

As a result of the restrictions by the PRC government on cross-border Renminbi funds flows, there are limits on availability of Renminbi outside the PRC. Currently, licensed banks in Singapore and Hong Kong may offer limited CNY-denominated banking services to Singapore residents, Hong Kong residents and specified business customers. While the PBOC has entered into agreements on the clearing of Renminbi business with financial institutions in a number of financial centres and cities (the "CNY Clearing Bank"), including, but not limited to, Hong Kong (the "Settlement Agreements"), and are in the process of establishing a Renminbi clearing and settlement mechanisms in several other jurisdictions, the current size of Renminbidenominated financial assets outside the PRC is limited. Renminbi business participating banks do not have direct Renminbi liquidity support from PBOC. The CNY Clearing Banks only have access to onshore liquidity support from the PBOC for the purpose of squaring open positions of participating banks for limited types of transactions, including open positions resulting from conversion services for corporations relating to cross-border trade settlement. The relevant CNY Clearing Bank is not obliged to square for participating banks any open positions resulting from other foreign exchange transactions or conversion services and the participating banks will need to source Renminbi from outside the PRC to square such open positions.

Although it is expected that the offshore Renminbi market will continue to grow in depth and size, its growth is subject to many constraints as a result of PRC laws and regulations on foreign exchange. The Issuer cannot assure the investor that new PRC regulations will not be promulgated or the Settlement Agreement will not be terminated or amended in the future, which will have the effect of restricting the availability of Renminbi offshore. The limited

availability of Renminbi outside of the PRC may affect the liquidity of the Notes issued hereunder. The Issuer cannot assure the investor that it will be able to source Renminbi on satisfactory terms, if at all, to make payments on the Notes in such currency.

Investment in CNY Notes is subject to exchange rate risks

The value of Renminbi against the Hong Kong dollar and other foreign currencies fluctuates and is affected by developments in or affecting the PRC, international political and economic conditions and many other factors. In August 2015, the PBOC implemented changes to the way it calculates the midpoint against the U.S. dollar to take into account market-maker quotes before announcing the daily midpoint. This change, among others that may be implemented, may increase the volatility in the value of the Renminbi against other currencies. All payments of interest and principal will be made with respect to the Notes in CNY, except in the case of CNY Inconvertibility, CNY Non-Transferability or CNY Illiquidity (as defined in Condition 25 (CNY Disruption Events)), in which case all payments and settlement in CNY will be made in accordance with Condition 25 (CNY Disruption Events). As a result, the value of CNY payments may vary with the prevailing exchange rates in the marketplace. If the value of CNY depreciates against the relevant currency, the value of the investment in relevant currency will have declined. In the case of CNY Inconvertibility, CNY Non-Transferability or CNY Illiquidity (as defined in Condition 25 (CNY Disruption Events)), such a decline may be very substantial. In August 2015, PBOC changed the way it calculates the mid-point price of Renminbi against the U.S. dollar, requiring the market-makers who submit for the PBOC's reference rates to consider the previous day's closing spot rate, foreign-exchange demand and supply as well as changes in major currency rates. This change, and other changes such as widening the trading band that may be implemented, may increase volatility in the value of the Renminbi against foreign currencies. In May 2017, PBOC further decided to introduce counter-cyclical factors to offset the market pro-cyclicality, so that the midpoint quotes could adequately reflect PRC's actual economic performance. However, the volatility in the value of the Renminbi against other currencies still exists.

Payments for the CNY Notes will only be made to investors in the manner specified in the CNY Notes

All payments to investors in respect of the Notes will be made solely (i) for so long as the CNY Notes are represented by a Note held with the common depositary for Clearstream Banking, S.A. and Euroclear Bank SA/NV or any Relevant Clearing System by transfer to a CNY bank account maintained in the relevant offshore CNY centre(s) specified therein, or (ii) for so long as the Notes are in definitive form, by transfer to a CNY bank account maintained in the relevant offshore CNY centre(s) specified therein in accordance with prevailing rules and regulations. The Issuer cannot be required to make payment by any other means (including in any other currency or by transfer to a bank account in the PRC).

There may be PRC tax consequences with respect to investment in the CNY Notes

In considering whether to invest in the CNY Notes, investors should consult their individual tax advisers with regard to the application of PRC tax laws to their particular situations as well as any tax consequences arising under the laws of any other tax jurisdictions. The value of the holder's investment in the CNY Notes may be materially and adversely affected if the holder is required to pay PRC tax with respect to acquiring, holding or disposing of and receiving payments under those CNY Notes.

#### 3.4 Exchange rates may affect the value of a judgment

The Notes will be governed by the laws of the State of New York. If a New York court were to enter a judgment in an action on any securities denominated in a foreign currency, such court would either enter a judgment in U.S. dollars based on the prevailing rate of exchange between the foreign currency and U.S. dollars on the date such judgment is entered or enter judgment in the foreign currency and convert the judgment or decree into U.S. dollars at the prevailing rate of exchange on the date such judgment or decree is entered.

#### 3.5 Risks relating to inflation

Inflation is the general increase in prices and fall in the purchasing value of money over time. Due to the impact of inflation, the same amount of money will buy fewer goods and services over time.

The real return (or yield) on an investment in the Notes may be reduced by inflation. Consequently, the higher the rate of inflation, the lower the real yield on a Note will be. If the inflation rate is equal to or greater than the yield under a Note, the real yield a holder of such Note will achieve will be zero or even negative. Accordingly, inflation may have a negative effect on the value of and return on the Notes, and you should consider the potential impact of inflation (including if the rate of inflation is anticipated to rise over the term of the Notes) before purchasing Notes.

- 4. Risk Factors relating to the relevant underlying
- 4.1 Risks relating to "benchmark" rates
- (a) The regulation and reform of "benchmarks" may adversely affect the value of and return on Notes linked to or referencing such "benchmarks"

Regulation (EU) 2016/1011 on indices used as benchmarks in financial instruments and financial contracts or to measure the performance of investment funds (the "EU Benchmark Regulation") is a key element of the ongoing regulatory reform of benchmarks in the EU and has applied since 1 January 2018. The EU Benchmark Regulation has been amended by Regulation (EU) 2019/2089 as regards EU Climate Transition Benchmarks, EU Paris-aligned Benchmarks and sustainability-related disclosures, by Regulation (EU) 2019/2175 and by Regulation (EU) 2021/168, the latter of which introduced new powers for regulators to mandate one or more replacement rates for critical or systemically important benchmarks in certain limited circumstances and a limited exemption for certain foreign exchange rates. Regulation 2025/914 (discussed below) will also amend the EU Benchmark Regulation as of 1 January 2026.

Following the end of the Brexit transitional period at 11.00p.m (London time) on 31 December 2020 the EU Benchmark Regulation in its then current form was saved into UK domestic law subject to a number of modifications (the "UK Benchmark Regulation" and, together with the EU Benchmark Regulation, the "Benchmark Regulations").

The scope of each of the EU Benchmark Regulation and the UK Benchmark Regulation is wide and, in addition to so-called "critical benchmarks" other interest rates, foreign exchange rates and certain indices, will in most cases be within scope of the Benchmark Regulations as "benchmarks" where they are used to determine the amount payable under, or the value of, certain financial instruments (including Notes listed on an EU (in the case of the EU Benchmark Regulation) or UK (in the case of the UK Benchmark Regulation) regulated market or multilateral trading facility ("MTF")), and in a number of other circumstances.

Each Benchmark Regulation applies to the provision of benchmarks, the contribution of input data to a benchmark and the use of a benchmark within the EU (in the case of the EU Benchmark Regulation) or the UK (in the case of the UK Benchmark Regulation). Among other things, each Benchmark Regulation (i) requires benchmark administrators to be authorised or registered (or, if not based in the EU (in the case of the EU Benchmark Regulation) or UK (in the case of the UK Benchmark Regulation), to be subject to an equivalent regime or otherwise recognised or endorsed) and (ii) prevents certain uses by supervised entities of "benchmarks" provided by administrators that are not authorised or registered (or, if not based in the EU (in the case of the EU Benchmark Regulation) or UK (in the case of the UK Benchmark Regulation), not deemed equivalent or recognised or endorsed), subject in each case to transitional provisions for benchmarks provided by third-country benchmark administrators. Under the UK Benchmark Regulation, the transitional provisions for third country benchmark administrators continue until 31 December 2030. However, under the EU Benchmark Regulation the transitional provisions for third country benchmark administrators expire on 31 December 2025, although (in summary) if ESMA has received an application for recognition or endorsement of a third country administrator by such date, such benchmark can be used in existing and new financial instruments and financial contracts, unless and until the administrator's application is refused.

This means that third country administrators of benchmarks remaining in scope of the EU Benchmark Regulation on 1 January 2026 will need to apply for recognition or endorsement imminently (to the extent they have not already) or benefit from equivalence for supervised entities to reference such benchmarks in new in-scope instruments from that date and, in relation to significant benchmarks, to avoid the application of certain restrictions on use of such benchmarks in existing in-scope instruments.

The Benchmark Regulations also gives regulators additional powers to intervene in relation to critical benchmarks (such as EURIBOR under the EU Benchmark Regulation or WMR London 4PM Closing Spot Rate under the UK Benchmark Regulation), including to support the orderly wind-down of a critical benchmark.

The Benchmark Regulations could have a material impact on any Notes linked to or referencing a "benchmark". For example:

- a rate or index which is a "benchmark" in scope of a Benchmark Regulation may not be used in certain ways by a supervised entity if (subject to applicable transitional provisions) its administrator does not obtain or maintain authorisation or registration (or, if a non-EU or non-UK (as the case may be) entity, does not satisfy the "equivalence" conditions and is not "recognised" pending an equivalence decision). If the benchmark administrator does not obtain or maintain (as applicable) such authorisation or registration or, if a non-EU entity, "equivalence" is not available and it is not recognised, then the Notes may be redeemed prior to maturity; and
- the methodology or other terms of the "benchmark" could be changed in order to comply with the requirements of the relevant Benchmark Regulation, and such changes could reduce or increase the rate or level or affect the volatility of the published rate or level, and (depending on the terms of the particular Notes) could lead to adjustments to the terms of the Notes as the Determination Agent deems necessary or appropriate.

In addition Regulation 2025/914, which amends the EU Benchmark Regulation will apply from 1 January 2026. Only benchmarks perceived to have the greatest economic relevance for the EU market will be in mandatory scope of the new regime. Such benchmarks will be those defined as critical or significant (determined based on quantitative or qualitative criteria), EU Paris-aligned benchmarks, EU Climate Transition benchmarks, and certain commodity benchmarks which will remain in scope of the mandatory application of the EU Benchmark Regulation. An exemption will apply for certain FX benchmarks.

Other benchmarks will fall out of mandatory EU Benchmark Regulation scope (other than certain limited provisions including in relation to statutory replacement of a benchmark, connected with cessation and/or non-representativeness). For benchmarks that are in scope of the revised regime, similar risks will apply to those which apply to benchmarks in scope of the current regime. Investors should note however that benchmarks that fall out of scope of the revised regime (which have not been opted-in) will no longer be regulated in the same way from 1 January 2026. This means that previously mandatory requirements, for example, regulating governance, conflicts of interest, oversight functions, input data requirements, methodology and transparency of the methodology, requirements for contributors and in relation to input data, will fall away. Among other things, there is a risk that this could mean that the methodology of such benchmarks may be less robust, resilient or transparent (potentially being capable of being materially amended without consultation). This may reduce or increase or affect the volatility of the level of such benchmarks, or if the methodology is materially amended, could lead to adjustments to the terms of the Notes or redemption of the Notes prior to maturity.

The UK Benchmark Regulation is also expected to be repealed and reformed in the near future. It remains to be seen what, if any, changes will be proposed and consequently what, if any, impact any such changes may have on the Notes.

Any of the international or national reforms, or the general increased regulatory scrutiny of "benchmarks", could increase the costs and risks of administering or otherwise participating in the setting of a "benchmark" and complying with any such regulations or requirements. Such factors may have the following effects on certain "benchmarks": (i) discourage market participants from continuing to administer or contribute to the "benchmark"; (ii) trigger

changes in the rules or methodologies used in the "benchmark" and/or (iii) lead to the disappearance of the "benchmark". Any of the above changes or any other consequential changes as a result of international or national reforms or other initiatives or investigations, could have a material adverse effect on the value of and return on any Notes linked to or referencing a "benchmark" and the Determination Agent may be entitled to make corresponding adjustments to the conditions of the Notes.

## (b) Reform of EURIBOR and Other Interest Rate Index and Equity, Commodity and Foreign Exchange Rate Index "Benchmarks"

The Euro Interbank Offered Rate ("EURIBOR") and other indices which are deemed "benchmarks" are the subject of recent national, international and other regulatory guidance and reform aimed at supporting the transition to robust benchmarks. Most reforms have now reached their planned conclusion (including the transition away from LIBOR), and "benchmarks" remain subject to ongoing monitoring. These reforms may cause such "benchmarks" to perform differently than in the past, or to disappear entirely, or have other consequences which cannot be predicted. Any such consequence could have a material adverse effect on any Notes linked to a "benchmark".

#### (c) Swap Rates may be materially amended or discontinued

Publication of many IBOR-based swap rates (such as the USD LIBOR ICE Swap Rate, the GBP LIBOR ICE Swap Rate and the JPY LIBOR Tokyo Swap Rate) have ceased and been replaced with new swap rates based on risk free rates, such as USD SOFR ICE Swap Rate, and GBP SONIA ICE Swap Rate. Whilst there is also a EUR-€STR Swap Rate, EURIBOR is still used as the floating leg in the calculation of the EUR EURIBOR Swap Rate and other IBORs that are still in existence may still be used in other swap rates (collectively, the "Swap Rates", and each a "Swap Rate") and these may be used as CMS Reference Rates, or other Relevant Rates Benchmarks, for the Notes. Consequently, if EURIBOR and/or other relevant "IBORs" are discontinued, it may not be possible to calculate the relevant Swap Rate(s), and the Swap Rate may be discontinued. The occurrence of these events may trigger the applicable fallbacks that are contained in Conditions 6.17 (*Relevant Rates Benchmark Discontinuance or Prohibition on Use*) to 6.19 (*General Fallback Arrangements*) having the consequences and risks described below.

# (d) EURIBOR, CMS Reference Rates, SOFR, SONIA, €STR, SARON, TONA and other benchmark rate discontinuance or prohibition on use may lead to adjustments to the terms of the Notes or an early redemption of the Notes

Fallback arrangements where (i) the Relevant Rates Benchmark is other than SOFR or a CMS Reference Rate and (ii) the provisions of Condition 6.17 (Relevant Rates Benchmark Discontinuance or Prohibition on Use) are applicable

Where any variable by reference to which interest is payable under the Notes is an index, benchmark, rate or price source which is specified in the Conditions as a "Relevant Rates Benchmark", the administrator or sponsor (or the Relevant Rates Benchmark) may be required to be authorised, registered, recognised, endorsed or otherwise included in an official register or, in the case of a benchmark in scope of the amended EU Benchmark Regulation, not be the object of a public notice of non-compliance with such regulation, in order for the Issuer, the Determination Agent or the Calculation Agent to be permitted to use the Relevant Rates Benchmark in certain ways and potentially to perform their respective obligations under the Notes. If the Determination Agent determines that such a requirement applies to the administrator or sponsor (or the Relevant Rates Benchmark) but it has not been satisfied, and if the applicable Final Terms or Pricing Supplement specifies that the provisions of Condition 6.17 (*Relevant Rates Benchmark Discontinuance or Prohibition on Use*) are applicable, then an "Administrator/Benchmark Event" will occur.

In order to address the risk of an Administrator/Benchmark Event occurring and the risk of discontinuance of reference rates, the Conditions include certain fallback provisions. These provisions apply to "Relevant Rates Benchmarks" (which will include EURIBOR, SONIA, ESTR, SARON and TONA and other similar interbank rates). Unless otherwise specified in the applicable Final Terms or Pricing Supplement, where ISDA Determination is specified in the applicable Final Terms or Pricing Supplement as the manner in which the Floating Interest Rate is to be determined, the fallbacks described below will only apply after application of any ISDA

Bespoke Fallbacks specified in the relevant Floating Rate Option to apply and the application of such ISDA Bespoke Fallbacks fails to provide a means of determining the relevant Floating Rate

The fallback provisions will be triggered if the Determination Agent determines that (i) the administrator or regulatory supervisor (or other applicable regulatory body) in connection with such Relevant Rates Benchmark announces that the administrator has ceased or will cease permanently or indefinitely to provide such Relevant Rates Benchmark and there is no successor administrator that will continue to provide the Relevant Rates Benchmark or (ii) unless otherwise specified in the applicable Final Terms or Pricing Supplement, an Administrator/Benchmark Event occurs in relation to such Relevant Rates Benchmark.

Following the occurrence of any of these events the Determination Agent may replace the Relevant Rates Benchmark with any "Alternative Pre-nominated Reference Rate" which has been specified in the applicable Final Terms or Pricing Supplement or if no Alternative Prenominated Reference Rate is specified in the applicable Final Terms or Pricing Supplement, with an alternative rate that is consistent with accepted market practice (the Alternative Prenominated Reference Rate or any such other alternative rate, the "Alternative Rate"). If an Alternative Rate is used then the Determination Agent may also make other adjustments to the Notes, including to the new Alternative Rate and to the Margin, which are consistent with accepted market practice for the use of such Alternative Rate for debt obligations such as the Notes. If the Determination Agent is unable to identify an Alternative Rate and determine the necessary adjustments to the terms of the Notes then the Issuer may redeem the Notes. The replacement of the Relevant Rates Benchmark by an Alternative Rate and the making of other adjustments to the Notes and other determinations, decisions or elections that may be made under the terms of the Notes in connection with the replacement of a Relevant Rates Benchmark could adversely affect the value of the Notes, the return on the Notes and the price at which the Noteholder can sell such Notes. Any early redemption of the Notes will result in the Noteholder losing any future return on the Notes and may result in the Noteholder incurring a loss on its investment in the Notes.

Any determination or decision of the Determination Agent described above will be made in the Determination Agent's discretion (in some cases after consultation with the Issuer).

Potential investors in any Notes that reference a Relevant Rates Benchmark (other than SOFR for the purposes of this risk factor) should be aware that (i) the composition and characteristics of the Alternative Rate will not be the same as those of the Relevant Rates Benchmark which it replaces, the Alternative Rate will not be the economic equivalent of the Relevant Rates Benchmark that it replaces, there can be no assurance that the Alternative Rate will perform in the same way as the Relevant Rates Benchmark that it replaces would have at any time and there is no guarantee that the Alternative Rate will be a comparable substitute for the Relevant Rates Benchmark which it replaces, (each of which means that the replacement of the Relevant Rates Benchmark by the Alternative Rate could adversely affect the value of the Notes, the return on the Notes and the price at which the Noteholder can sell such Notes), (ii) any failure of the Alternative Rate to gain market acceptance could adversely affect the Notes, (iii) the Alternative Rate may have a very limited history and the future performance of the Alternative Rate cannot be predicted based on historical performance, (iv) the secondary trading market for Notes linked to the Alternative Rate may be limited and (v) the administrator of the Alternative Rate may make changes that could change the value of the Alternative Rate or discontinue the Alternative Rate and has no obligation to consider the Noteholder's interests in doing so.

Fallback arrangements where the Relevant Rates Benchmark is SOFR: If SOFR is discontinued, any Floating Rate Notes referencing SOFR will bear interest by reference to a different base rate, which could adversely affect the value of the Notes, the return on the Notes and the price at which the Noteholder can sell such Notes; there is no guarantee that any Benchmark Replacement will be a comparable substitute for SOFR.

If the Issuer or its designee determines that a Benchmark Transition Event and its related Benchmark Replacement Date have occurred in respect of SOFR (in the case of Notes referencing SOFR), then the interest rate on the Notes will no longer be determined by reference to SOFR, but instead will be determined by reference to a different base rate, which will be a different benchmark than SOFR, plus a spread adjustment, which is referred to as a "Benchmark Replacement," as further described in the relevant terms and conditions.

If a particular Benchmark Replacement or Benchmark Replacement Adjustment cannot be determined, then the next-available Benchmark Replacement or Benchmark Replacement Adjustment will apply. These replacement rates and adjustments may be selected, recommended or formulated by (i) the Relevant Governmental Body, (ii) ISDA or (iii) in certain circumstances, the Issuer or its designee. In addition, the terms of the Notes expressly authorise the Issuer or its designee to make Benchmark Replacement Conforming Changes with respect to, among other things, changes to the definition of "interest period," timing and frequency of determining rates and making payments of interest and other administrative matters. The determination of a Benchmark Replacement, the calculation of the interest rate on the Notes by reference to a Benchmark Replacement (including the application of a Benchmark Replacement Adjustment), any implementation of Benchmark Replacement Conforming Changes and any other determinations, decisions or elections that may be made under the terms of the Notes in connection with a Benchmark Transition Event could adversely affect the value of the Notes, the return on the Notes and the price at which the Noteholder can sell such Notes.

Any determination, decision or election described above will be made in the Issuer's or its designee's sole discretion.

Potential investors in any Notes that reference SOFR should be aware that (i) the composition and characteristics of the Benchmark Replacement will not be the same as those of SOFR, the Benchmark Replacement will not be the economic equivalent of SOFR, there can be no assurance that the Benchmark Replacement will perform in the same way as SOFR would have at any time and there is no guarantee that the Benchmark Replacement will be a comparable substitute for SOFR (each of which means that a Benchmark Transition Event could adversely affect the value of the Notes, the return on the Notes and the price at which the Noteholder can sell such Notes), (ii) any failure of the Benchmark Replacement to gain market acceptance could adversely affect the Notes, (iii) the Benchmark Replacement may have a very limited history and the future performance of the Benchmark Replacement cannot be predicted based on historical performance, (iv) the secondary trading market for Notes linked to the Benchmark Replacement may be limited and (v) the administrator of the Benchmark Replacement may make changes that could change the value of the Benchmark Replacement or discontinue the Benchmark Replacement and has no obligation to consider the Noteholder's interests in doing so.

See also the risk factors entitled "Risk Factors — Risk factors relating to the relevant underlying-Risks relating to "benchmark" rates" — "EURIBOR, CMS Reference Rates, SOFR, SONIA, ESTR, SARON, TONA and other benchmark rate discontinuance or prohibition on use may lead to adjustments to the terms of the Notes or an early redemption of the Notes" above.

Fallback arrangements where the Relevant Rates Benchmark is a CMS Reference Rate: If the CMS Reference Rate is discontinued, any Floating Rate Notes referencing that CMS Reference Rate will bear interest by reference to a different base rate, which could adversely affect the value of the Notes, the return on the Notes and the price at which the Noteholder can sell such Notes; there is no guarantee that any Benchmark Replacement will be a comparable substitute for the current CMS Reference Rate.

If the applicable Final Terms or Pricing Supplement specifies that the provisions of Condition 6.17 (Relevant Rates Benchmark Discontinuance or Prohibition on Use) are applicable to the Notes and an Index Cessation Event and its related Index Cessation Effective Date (as each term is defined in Condition 6.18 (CMS Reference Rate - Effect of Index Cessation Event)) have occurred with respect to the applicable tenor of the CMS Reference Rate, then the interest rate on the Notes will no longer be determined by reference to the CMS Reference Rate. Instead, the interest rate will be determined by reference to a different base rate, which will be a different benchmark than the initial or then current CMS Reference Rate, which is referred to as a "Benchmark Replacement," plus any adjustment spread (which may be positive, negative or zero), all as further described Condition 6.18 (CMS Reference Rate - Effect of Index Cessation Event). In such a case, in the first instance, the interest rate on the Notes will be determined based on any alternative reference rate, index or benchmark that is specified for such purpose in the Final Terms or Pricing Supplement (an "Alternative Pre-nominated Reference Rate"). In the absence of an Alternative Pre-nominated Reference Rate, the interest rate on the Notes will be determined based on (1) the alternate rate of interest that has been selected or recommended by the relevant governmental body or agency with jurisdiction over the then

current CMS Reference Rate for the applicable index maturity, or (2) if no such rate of interest has been selected or recommended by such a governmental body or agency, the alternate rate of interest that has been selected by the Determination Agent as the replacement for the then-current CMS Reference Rate for the applicable index maturity giving due consideration to any industry-accepted rate of interest as a replacement for the then-current CMS Reference Rate for floating rate notes denominated in the Index Currency at such time, including any alternate rate of interest recommended by the International Swaps and Derivatives Association, Inc. or any successor thereto There can be no assurance that an alternate rate of interest to the CMS Reference Rate will be selected or recommended by a governmental body or agency with the consequence that the replacement rate will be selected by the Determination Agent.

In addition, the terms of the Notes expressly authorise the Determination Agent or its designee to make Benchmark Replacement Conforming Changes with respect to, among other things, changes to the definition of "interest period," timing and frequency of determining rates and making payments of interest and other administrative matters. The determination of a Benchmark Replacement, the calculation of the interest rate on the Notes by reference to a Benchmark Replacement (including the determination by the Determination Agent of any "adjustment spread" that will be added or subtracted from the Benchmark Replacement), any implementation of Benchmark Replacement Conforming Changes and any other determinations, decisions, selections or elections that may be made under the terms of the Notes in connection with a Benchmark Transition Event could adversely affect the value of the Notes, the return on the Notes and the price at which the Noteholder can sell such Notes.

Potential investors in any Notes that reference one or more CMS Reference Rates should be aware that (i) the composition and characteristics of the Benchmark Replacement will not be the same as those of the initial or then current CMS Reference Rate, the Benchmark Replacement will not be the economic equivalent of the initial or then current CMS Reference Rate, there can be no assurance that the Benchmark Replacement will perform in the same way as the initial or then current CMS Reference Rate would have at any time and there is no guarantee that the Benchmark Replacement will be a comparable substitute for the initial or then current CMS Reference Rate (each of which means that an Index Cessation Event could adversely affect the value of the Notes, the return on the Notes and the price at which the Noteholder can sell such Notes), (ii) any failure of the Benchmark Replacement to gain market acceptance could adversely affect the Notes, (iii) the Benchmark Replacement may have a very limited history and the future performance of the Benchmark Replacement cannot be predicted based on historical performance, (iv) the secondary trading market for Notes linked to the Benchmark Replacement may be limited and (v) the administrator of the Benchmark Replacement may make changes that could change the value of the Benchmark Replacement or discontinue the Benchmark Replacement and has no obligation to consider the Noteholder's interests in doing so. If the implementation of any Benchmark Replacement or Benchmark Replacement Conforming Changes results in a calculation of the CMS Reference Rate that is not consistent with market practice as determined by the Determination Agent, the Issuer may, in its reasonable discretion, redeem the Notes as of any later date.

Any determination, decision, selection or election described above that may be made by the Issuer, the Determination Agent or their respective designees will be made in such person's sole discretion.

See also the risk factors entitled "Risk Factors—Risk factors relating to the relevant underlying-Risks relating to "benchmark" rates – EURIBOR, CMS Reference Rates, SOFR, SONIA, &STR, SARON, TONA and other benchmark rate discontinuance or prohibition on use may lead to adjustments to the terms of the Notes or an early redemption of the Notes" above.

Fallback arrangements - general

The application of any of these fallbacks may adversely affect the value of the Noteholder's investment in the Notes.

If (a) none of the fallbacks described above in (1) "Fallback arrangements where (i) the Relevant Rates Benchmark is other than SOFR or a CMS Reference Rate and (ii) the provisions of Condition 6.17 (Relevant Rates Benchmark Discontinuance or Prohibition on Use) are applicable" or (2) "Fallback arrangements where the Relevant Rates Benchmark is SOFR: If

SOFR is discontinued, any Floating Rate Notes referencing SOFR will bear interest by reference to a different base rate, which could adversely affect the value of the Notes, the return on the Notes and the price at which the Noteholder can sell such Notes; there is no guarantee that any Benchmark Replacement will be a comparable substitute for SOFR" or (3) "Fallback arrangements where the Relevant Rates Benchmark is a CMS Reference Rate: If the CMS Reference Rate is discontinued, any Floating Rate Notes referencing that CMS Reference Rate will bear interest by reference to a different base rate, which could adversely affect the value of the Notes, the return on the Notes and the price at which the Noteholder can sell such Notes; there is no guarantee that any Benchmark Replacement will be a comparable substitute for the current CMS Reference Rate" applies; and (b) EURIBOR, SONIA, €STR, SARON or TONA has been permanently discontinued, the Determination Agent will use, as a substitute for EURIBOR, SONIA, €STR, SARON or TONA (as the case may be), and for each future Interest Determination Date, the alternative reference rate selected by the central bank, reserve bank, monetary authority or any similar institution (including any committee or working group thereof) in the jurisdiction of the applicable index currency that is consistent with accepted market practice. The Determination Agent will also make other adjustments to the Notes, including to the new rate and to the Margin, which are consistent with accepted market practice for the use of such alternative rate for debt obligations such as the Notes. However, in the case of EURIBOR only, if the Determination Agent determines that no such alternative rate exists on the relevant date, it will make a determination of an alternative rate as a substitute for EURIBOR, for debt obligations such as the Notes, as well as other adjustments to the Notes, including to the new rate and to the Margin, that is consistent with accepted market practice.

Unless otherwise specified in the applicable Final Terms or Pricing Supplement, where ISDA Determination is specified in the applicable Final Terms or Pricing Supplement as the manner in which the Floating Interest Rate is to be determined, the fallbacks described above will only apply after application of any ISDA Bespoke Fallbacks specified in the relevant Floating Rate Option to apply and the application of such ISDA Bespoke Fallbacks fails to provide a means of determining the relevant Floating Rate.

The replacement of EURIBOR, SONIA,  $\in$ STR, SARON or TONA by an alternative rate and the making of other adjustments to the Notes and other determinations, decisions or elections that may be made under the terms of the Notes in connection with the replacement of EURIBOR, SONIA,  $\in$ STR, SARON or TONA could adversely affect the value of the Notes, the return on the Notes and the price at which the Noteholder can sell such Notes.

Any determination or decision described above will be made in the Determination Agent's discretion (after consultation with the Issuer).

Potential investors in any Notes that reference EURIBOR, SONIA, €STR, SARON or TONA should be aware that (i) the composition and characteristics of the alternative rate will not be the same as those of the Relevant Rates Benchmark which it replaces, the alternative rate will not be the economic equivalent of the Relevant Rates Benchmark that it replaces, there can be no assurance that the alternative rate will perform in the same way as the Relevant Rates Benchmark that it replaces would have at any time and there is no guarantee that the alternative rate will be a comparable substitute for the Relevant Rates Benchmark which it replaces, (each of which means that the replacement of the Relevant Rates Benchmark by the alternative rate could adversely affect the value of the Notes, the return on the Notes and the price at which the Noteholder can sell such Notes), (ii) any failure of the alternative rate to gain market acceptance could adversely affect the Notes, (iii) the alternative rate may have a very limited history and the future performance of the alternative rate cannot be predicted based on historical performance, (iv) the secondary trading market for Notes linked to the alternative rate may be limited and (v) the administrator of the alternative rate may make changes that could change the value of the alternative rate or discontinue the alternative rate and has no obligation to consider the Noteholder's interests in doing so.

#### (e) ISDA Determination and Fallbacks

In the case where ISDA Determination is specified in the applicable Final Terms or Pricing Supplement as the manner in which the Floating Interest Rate is to be determined, and the application of any ISDA Bespoke Fallbacks specified in the relevant Floating Rate Option results in a replacement of, modification to, or change in the method of calculating, the Floating Rate (or the index, benchmark or other price source that is referred to in the Floating Rate

Option), the Determination Agent may, after consultation with the Issuer, determine any adjustments to the Floating Rate and the Margin (including any adjustment spread) as well as the applicable Business Day Convention, Interest Determination Dates (or any other rate fixing dates) and related provisions and definitions of the Notes, in each case that are consistent with accepted market practice for the use of such replacement or modified Floating Rate for debt obligations such as the Notes. The making of such adjustments to the Notes and other determinations could adversely affect the value of the Notes, the return on the Notes and the price at which the Noteholder can sell such Notes.

Furthermore, if, at any time, the relevant ISDA Rate is specified as being the 10-year constant maturity French treasury rate (commonly referred to as CNO TEC10) published by the Bank of France and it ceases to represent the actual yield to maturity of a notional Obligation assimilable du Trésor ("OAT") with a maturity of exactly 10 years, the ISDA Rate will not be calculated in accordance with the standard ISDA Determination. Instead, for the purposes of the Conditions and in respect of the relevant Interest Period, the ISDA Rate shall be deemed to be the yield to maturity of a notional OAT with a maturity of exactly 10 years, as determined by the Determination Agent. Such determination may differ from the results that would be obtained under an ISDA Determination or from determinations made in the market under similar circumstances.

#### (f) Specific risks relating to Notes referencing SOFR, SONIA, ESTR, SARON or TONA

The following sets out a number of additional risks specific to Notes that reference SOFR, SONIA, €STR, SARON or TONA (each of which is referred to as a (nearly) risk free rate or an ''RFR'').

Certain RFRs have limited histories; the future performance of SOFR or SONIA cannot be predicted based on historical performance.

The publication of €STR began on 2 October 2019 and publication of SOFR began on 3 April 2018 and these RFRs therefore have very limited histories. The publication of SONIA on the basis of its present methodology began on 24 April 2018. The publication of SARON began on 25 August 2009. In addition, the future performance of RFRs cannot be predicted based on the limited historical performance. The level of an RFR during the term of the Notes may bear little or no relation to its historical level. Prior observed patterns, if any, in the behaviour of market variables and their relation to an RFR, such as correlations, may change in the future. In the case of SOFR, while some pre-publication historical data have been released by the Federal Reserve Bank of New York (the "New York Federal Reserve"), such analysis inherently involves assumptions, estimates and approximations. The future performance of an RFR is impossible to predict and therefore no future performance of an RFR or the Notes may be inferred from any of the historical performance or historical simulations. Hypothetical or historical performance data are not indicative of, and have no bearing on, the potential performance of an RFR or the Notes. Changes in the levels of the relevant RFR referenced by the Notes will affect the return on the Notes and the trading price of such Notes, but it is impossible to predict whether such levels will rise or fall. There can be no assurance that the relevant RFR referenced by the Notes will be positive.

The composition and characteristics of an RFR are not the same as those of LIBOR and there is no guarantee that an RFR is a comparable substitute for LIBOR.

In December 2016, the Japanese Study Group on Risk-Free Reference Rates announced TONA as its preferred risk free rate for Japanese yen. In April 2017, the Working Group on Sterling Risk-Free Reference Rates announced SONIA as its preferred risk free rate for sterling. In June 2017, the ARRC announced SOFR as its recommended alternative to U.S. Dollar LIBOR. In October 2017, the Swiss National Working Group on Swiss Franc Reference Rates recommended SARON as the alternative to Swiss franc LIBOR. In September 2018 the Working Group on euro risk free rates recommended €STR as the euro risk free rate. However, the composition and characteristics of each of these RFRs are not the same as those of LIBOR.

SOFR is a broad Treasury repo financing rate that represents overnight secured funding transactions. SARON represents the overnight interest rate of the secured money market for

Swiss francs. This means that each of SOFR and SARON is fundamentally different from LIBOR for two key reasons. First, each of SOFR and SARON is a secured rate, while LIBOR is an unsecured rate. Second, each of SOFR and SARON is an overnight rate, while LIBOR represents interbank funding over different maturities.

SONIA is a measure of the rate at which interest is paid on sterling short-term wholesale funds in circumstances where credit, liquidity and other risks are minimal. €STR is a rate which reflects the wholesale euro unsecured overnight borrowing costs of euro area banks. TONA represents the weighted average of call rates for uncollateralised overnight transactions in Japanese yen. While SONIA, €STR, TONA and LIBOR are all unsecured rates, SONIA, €STR and TONA are solely overnight rates unlike LIBOR which represents interbank funding over different maturities.

As a result, there can be no assurance that an RFR will perform in the same way as LIBOR would have at any time, including, without limitation, as a result of changes in interest and yield rates in the market, market volatility or global, national or regional economic, financial, political, regulatory, judicial or other events. For example, since publication of SOFR began on 3 April 2018, daily changes in SOFR have, on occasion, been more volatile than daily changes in comparable benchmark or other market rates. For additional information regarding SOFR, see "Secured Overnight Financing Rate" below.

The secondary trading market for Notes linked to an RFR may be limited.

Since some of the RFRs are relatively new market rates or have only recently been adopted as a benchmark rate for bonds, the trading market in debt securities such as the Notes may not develop or may not be very liquid. Market terms for debt securities linked to an RFR (such as the Notes) may evolve over time and, as a result, trading prices of the Notes may be lower than those of later-issued debt securities that are linked to the same RFR. Similarly, if an RFR does not prove to be widely used in debt securities similar to the Notes, the trading price of the Notes may be lower than that of debt securities linked to rates that are more widely used. Investors in the Notes may not be able to sell such Notes at all or may not be able to sell such Notes at prices that will provide them with a yield comparable to similar investments that have a developed secondary market. Further, investors wishing to sell the Notes in the secondary market will have to make assumptions as to the future performance of the relevant RFR. As a result, investors may suffer from increased pricing volatility and market risk.

The administrator of the relevant RFR may make changes that could change the value of the benchmark or discontinue the benchmark and has no obligation to consider Noteholders' interests in doing so.

The New York Federal Reserve (or a successor), as administrator of SOFR, the Bank of England (or a successor), as administrator of SONIA, the European Central Bank (or a successor) as administrator of ESTR, SIX Swiss Exchange (or a successor), as administrator of SARON or the Bank of Japan (or a successor), as administrator of TONA may make methodological or other changes that could change the value of the relevant RFR, including changes related to the method by which the relevant rate is calculated, eligibility criteria applicable to the transactions used to calculate the relevant rate, or timing related to the publication of the relevant rate. In addition, the administrator may alter, discontinue or suspend calculation or dissemination of the relevant RFR (in which case a fallback method of determining the interest rate on the Notes will apply). The administrator has no obligation to consider Noteholders' interests in calculating, adjusting, converting, revising or discontinuing the relevant rate and any such calculations, adjustments, conversion, revision or discontinuation could adversely affect the return on the Notes, the value of the Notes and the price at which the Noteholder can sell such Notes.

The interest rate on the Notes is based on a daily compounded RFR, which is relatively new in the marketplace; different conventions exist for calculating interest on RFR-linked Notes

For each Interest Period for Notes linked to an RFR, the interest rate on the Notes is based on a daily compounded RFR calculated using the specific formula specified in the Conditions and

the applicable Final Terms or Pricing Supplement, or the specified ISDA Rate not the RFR published on or in respect of a particular date during such Interest Period, or an average of the relevant RFRs during such period. For this and other reasons, the interest rate on the Notes during any Interest Period will not be the same as the interest rate on other investments linked to the same RFR that use an alternative basis to determine the applicable interest rate. Further, unless in the case of an ISDA Rate "Daily Floored Rate" is specified as applicable in the applicable Final Terms or Pricing Supplement and the Daily Floored Rate is zero or above, if the relevant RFR in respect of a particular date during an Interest Period is negative, the portion of the accrued compounded interest compounding factor specifically attributable to such date will be less than one, resulting in a reduction to the accrued interest compounding factor used to calculate the interest payable on the Notes on the Interest Payment Date for such Interest Period.

Limited market precedent exists for securities that use SOFR and certain other RFRs as the interest rate and, in addition, for each RFR, different market conventions exist for calculating interest on debt securities. Accordingly, the specific formula for the daily compounded RFR used in the Notes may not be widely adopted by other market participants, if at all. If the market adopts a different convention for calculating interest, that would likely adversely affect the market value of such Notes.

The amount of interest payable with respect to each Interest Period will be determined near the end of the Interest Period.

The amount of interest payable with respect to such Interest Period will be determined on a date near the end of such Interest Period, Noteholders will not know the amount of interest payable with respect to each such Interest Period until shortly prior to the related Interest Payment Date and it may be difficult for Noteholders to reliably estimate the amount of interest that will be payable on each such Interest Payment Date.

The Issuer, its subsidiaries or affiliates may publish research that could affect the market value of the Notes. They also may hedge the Issuer's obligations under such Notes.

The Issuer or one or more of its affiliates may, at present or in the future, publish research reports with respect to movements in interest rates generally, the LIBOR transition or any of the RFRs specifically. This research is modified from time to time without notice and may express opinions or provide recommendations that are inconsistent with purchasing or holding the Notes. Any of these activities may affect the market value of such Notes. In addition, the issuer's subsidiaries may hedge the Issuer's obligations under the Notes and they may realize a profit from that hedging activity even if investors do not receive a favourable investment return under the terms of such Notes or in any secondary market transaction.

#### Reliance on third parties

Each RFR is published and calculated by third parties based on data received from other sources and none of the Issuer, the Determination Agent or the Calculation Agent has any control over the determinations, calculations or publications of any such third parties.

#### Market Adoption

The market or a significant part thereof may adopt an application of the relevant RFR (one using a different convention to calculating interest including using an RFR screen based rate) that differs significantly from that set out in the Conditions and used in relation to Notes that reference a risk-free rate issued under this Base Prospectus and this may adversely affect the value of the Notes.

Potential investors in the Notes should carefully consider how any mismatch between the adoption of such reference rates in the bond, loan and derivatives markets may impact any hedging or other financial arrangements which they may put in place in connection with any acquisition, holding or disposal of any Notes.

# **Risk Factors Relating to the Notes**

Where "Payment Delay" applies, in determining the compounded RFR for the final Interest Period, the level of the relevant RFR for any day from and including the relevant SOFR/SONIA/ESTR/SARON/TONA Rate Cut-Off Date to but excluding the Maturity Date or redemption date, as applicable, will be the level of the relevant RFR in respect of such Rate Cut-off Date.

Where "Payment Delay" applies, for the final Interest Period, because the level of the relevant RFR for any day from and including the SOFR/SONIA/ESTR/SARON/TONA Rate Cut-off Date to but excluding the Maturity Date or redemption date, as applicable, will be the level of the relevant RFR in respect of such Rate Cut-Off Date, Noteholders will not receive the benefit of any increase in the level in respect of the relevant RFR beyond the level for such date in connection with the determination of the interest payable with respect to such Interest Period, which could adversely impact the amount of interest payable with respect to that Interest Period.

# 4.2 Notes linked to one or more inflation indices

The Issuer may issue Notes with interest determined by reference to interest rates. In addition, the Issuer may issue Notes with principal or interest determined by reference to inflation indices, or with principal or interest payable in one or more currencies which may be different from the currency in which the Notes are denominated. Potential investors should be aware that:

- (a) the market price of such Notes may be very volatile;
- (b) investors in Notes may receive no interest;
- (c) historic performance of an inflation index is not an indication of future performance of the inflation index over the term of the Notes;
- (d) an inflation index may be subject to significant fluctuations that may not correlate with changes in interest rates, currencies, other indices or the actual levels of inflation affecting Noteholders; and
- (e) the timing of changes in an inflation index may affect the actual yield to investors, even if the average level is consistent with their expectations. In general, the earlier the change in the inflation index, the greater the effect on yield.

# 5. Risk Factors relating to Notes that include certain features

# 5.1 Caps and floors on interest rates

The rate of interest payable on certain Notes may be subject to a maximum rate of interest (or interest cap) or a minimum rate of interest (or interest floor) specified in the applicable Final Terms or Pricing Supplement. If a maximum rate of interest is specified, the rate of interest payable on such Notes will be capped at the maximum rate specified. However, if a floor or a minimum rate of interest is specified in respect of any Notes, the rate of interest payable on such Notes may entitle holders to receive payment(s) greater than they would have received, if the relevant rate of interest had not been subject to the floor.

# 5.2 If the interest rate on any Notes may be the subject of an automatic conversion, this may affect the secondary market and the market value of the Notes concerned

Fixed/Floating Rate Notes may bear interest at a rate that converts from a fixed rate to a floating rate, or from a floating rate to a fixed rate. Where the Notes may be subject to such an automatic conversion, this will affect the secondary market in, and the market value of, the Notes since the converted rate may be a rate that is likely to result in a lower overall cost of borrowing for the Issuer. If the interest rate on any Note is automatically converted from a fixed rate to a floating rate in such circumstances, the spread on the Fixed/Floating Rate Notes may be less favourable than then prevailing spreads on comparable Floating Rate Notes tied to the same reference rate. In addition, the new rate at any time may be lower than the rates on other Notes. If the Notes automatically convert from a floating rate to a fixed rate in such circumstances, the fixed rate may be lower than then prevailing market rates.

# 5.3 Automatic change of interest basis

Notes shall have (where the applicable Final Terms or Pricing Supplement specify "Automatic Change of Interest Basis" to be applicable) more than one interest basis applicable to different interest periods and/or interest payment dates. These Notes may be Zero Coupon Notes, Fixed

Rate Notes, Floating Rate Notes or Inflation-Linked Notes (or any combination of the foregoing).

One or more independent credit rating agencies may assign credit ratings to the Issuer. The ratings may not reflect the potential impact of all risks related to structure, market, additional factors discussed above, and other factors that may affect the value of the Notes. A credit rating is not a recommendation to buy, sell or hold Notes and may be revised or withdrawn by the rating agency at any time.

# 1.2 Change of law

The Conditions of the Notes are based on New York law in effect as at the date of this Base Prospectus. No assurance can be given as to the impact of any possible judicial decision or change to New York law or regulation in New York after the date of this Base Prospectus.

# 1.3 Independent review and advice

Each prospective investor must determine, based on its own independent review and such professional advice as it deems appropriate under the circumstances, that its acquisition of the Notes is (i) fully consistent with its (or if it is acquiring the Notes in a fiduciary capacity, the beneficiary's) financial needs, objectives and condition, (ii) complies and is fully consistent with all investment policies, guidelines and restrictions applicable to it (whether acquiring the Notes as principal or in a fiduciary capacity) and (iii) is a fit, proper and suitable investment for it (or if it is acquiring the Notes in a fiduciary capacity, for the beneficiary), notwithstanding the clear and substantial risks inherent in investing in or holding the Notes. Each of the Issuer and the Distribution Agent disclaims any responsibility to advise prospective investors of any matters arising under the law of the country in which they reside that may affect the purchase of, or holding of, or the receipt of payments or deliveries on the Notes.

#### 1.4 Selling Agent remuneration

The Issuer may enter into distribution agreements with various financial institutions and other intermediaries as determined by the Issuer (each a "Selling Agent"). Each Selling Agent will agree, subject to the satisfaction of certain conditions, to subscribe for the Notes at a price equivalent to or below the Issue Price. Any difference between the price at which the Selling Agent subscribes the Notes and the price at which the Selling Agent sells the Notes to investors will be a remuneration of the Selling Agent. ("Clearstream, Luxembourg"), and/or any other clearing system as may be specified in the applicable Final Terms or Pricing Supplement (such system or systems hereinafter referred to as the "Relevant Clearing System"), investors will have to rely on their procedures for transfer, payment and communication with the Issuer.

Notes issued under the Program pursuant to this Base Prospectus may be represented by interests in a global note certificate (a "Global Note Certificate"). Such Global Note Certificates may be registered in the name of a common depositary (or its nominee) or common

safekeeper (or its nominee) for Euroclear and/or Clearstream, Luxembourg. Except in the circumstances described in the relevant Global Note Certificate, investors will not be entitled to receive definitive Notes. The Relevant Clearing System will maintain records of the beneficial interests in the Global Note Certificates. While the Notes are represented by one or more Global Note Certificates, investors will be able to trade their beneficial interests only through the Relevant Clearing System.

While the Notes are represented by one or more Global Note Certificates, the Issuer will discharge its payment obligations under the Notes by making payments through the Relevant Clearing System for distribution to their account holders. A holder of an interest in a Global Note Certificate must rely on the procedures of the Relevant Clearing System to receive payments under the relevant Notes. The Issuer does not have responsibility or liability for the records relating to, or payments made in respect of, beneficial interests in the Global Note Certificates.

- (ii) such Noteholder (a) has consulted with its own legal, regulatory, tax, business, investments, financial and accounting advisers to the extent that it has deemed necessary, and has made its own investment, hedging and trading decisions based upon its own judgement and upon any advice from such advisers as it has deemed necessary and not upon any view expressed by the Issuer or any Affiliate or any of their

# 1. **INTRODUCTION**

1.1 **Program**: Morgan Stanley ("Morgan Stanley"), Morgan Stanley & Co. International plc ("MSI plc"), Morgan Stanley B.V. ("MSBV"), Morgan Stanley Finance LLC ("MSFL"), Morgan Stanley Finance II Ltd ("MSFII") and Morgan Stanley Europe SE ("MSESE") have established, or acceded to, the Regulation S Program for the issuance of Notes, Series A and Series B, Warrants and Certificates (the "Program") which provides for the issuance of, *inter alia*, of notes by Morgan Stanley. The Series A Notes and Series B Notes offered pursuant to

- the Base Prospectus dated 21 July 2025 (the "**Notes**") will be governed by New York law. References to the "**Issuer**" in these terms and conditions shall mean Morgan Stanley.
- 1.2 *Final Terms or Pricing Supplement*: The Notes are issued in series (each a "Series") and each Series may comprise one or more tranches (each a "Tranche") of Notes. Each Tranche is the subject of a set of final terms (a "Final Terms") or pricing supplement (a "Pricing Supplement") which complete these terms and conditions (the "Conditions"), if any, applicable in relation to such Series.
- Issue and Paying Agency Agreement: The Notes are the subject of an issue and paying agency 1.3 agreement dated 21 July 2025 (such agreement as from time to time further modified and/or restated, the "Issue and Paving Agency Agreement") between Morgan Stanley, The Bank of New York Mellon SA/NV, Luxembourg Branch as registrar (the "Registrar", which expression includes any successor registrar appointed from time to time in connection with the Notes), the transfer agents named therein (together with the Registrar, the "Transfer Agents", which expression includes any successor or additional transfer agents appointed from time to time in connection with the Notes) and The Bank of New York Mellon, London Branch as fiscal agent (the "Fiscal Agent", which expression includes any successor fiscal agent appointed from time to time in connection with the Notes and, together with any additional paying agents appointed pursuant thereto, the "Paying Agents", which expression includes any successor paying agents appointed from time to time in connection with the Notes). The Fiscal Agent is also appointed as initial calculation agent. In these Conditions, references to the "Agents" are to the Paying Agents and the Transfer Agents, and any reference to an "Agent" is to any one of them.
- 1.4 **The Notes**: All subsequent references in these Conditions to "**Notes**" are to the Notes which are the subject of the applicable Final Terms or Pricing Supplement. Copies of the applicable Final Terms or Pricing Supplement are available for inspection by Noteholders during normal business hours at the Specified Office of the Fiscal Agent, the initial Specified Office of which is set out below.
- 1.5 **Summaries**: Certain provisions of these Conditions are summaries of the Issue and Paying Agency Agreement and are subject to its detailed provisions. The holders of the Notes (the "Noteholders") are bound by, and are deemed to have notice of, all the provisions of the Issue and Paying Agency Agreement as are applicable to them. Copies of the Issue and Paying Agency Agreement are available for inspection by Noteholders during normal business hours at the Specified Offices of each of the Paying Agents, the initial Specified Offices of which are set out below.

# 2. **INTERPRETATION**

# 2.1 **Definitions**

In the Conditions, the following expressions have the following meanings:

- "Accrual Yield" means the rate specified as such in the applicable Final Terms or Pricing Supplement;
- "Additional Business Centre(s)" means the city or cities specified as such in the applicable Final Terms or Pricing Supplement;
- "Additional Financial Centre(s)" means the city or cities specified as such in the applicable Final Terms or Pricing Supplement;
- "Administrator/Benchmark Event" means, in respect of any Notes, a determination made by the Determination Agent that:
  - (a) any authorisation, registration, recognition, endorsement, equivalence decision, approval or inclusion in any official register in respect of the Relevant Rates Benchmark or the administrator or sponsor of the Relevant Rates Benchmark has not been, or will not be, obtained or has been, or will be, rejected, refused, suspended or withdrawn by the relevant competent authority or other relevant official body, in each case with the effect that any of the Issuer, the Determination Agent or the Calculation Agent is not, or will not be, permitted under any applicable law or regulation to use the Relevant Rates Benchmark to perform its or their respective obligations in respect of the Notes or any related hedging arrangements; or

(b) any relevant competent authority or other relevant official body issues a public notice with respect to the Relevant Rates Benchmark pursuant to the EU Benchmark Regulation (Regulation (EU) 2016/1011), as amended from time to time with the effect that any of the Issuer, the Determination Agent or the Calculation Agent is not, or may not be, permitted under any applicable law or regulation to use the Relevant Rates Benchmark to perform its or their respective obligations in respect of the Notes or any related hedging arrangements,

provided that if in the determination of the Determination Agent any event may be an Administrator/Benchmark Event pursuant to both paragraph (a) and paragraph (b) above, the applicable Administrator/Benchmark Event for the purposes of the Notes shall occur pursuant to whichever paragraph the Determination Agent determines is first satisfied.

For the avoidance of doubt, Administrator/Benchmark Event shall not apply where the Notes are denominated in U.S. dollars and the Relevant Rates Benchmark is SOFR (see Condition 6.8 (*Provisions specific to SOFR as Reference Rate*) below);

"Administrator/Benchmark Event Date" means, in respect of any Notes and an Administrator/Benchmark Event, the date on which:

- (a) the authorisation, registration, recognition, endorsement, equivalence decision, approval or inclusion in any official register is (as applicable):
  - (i) required under any applicable law or regulation; or
  - (ii) rejected, refused, suspended or withdrawn, if the applicable law or regulation provides that the Relevant Rates Benchmark is not permitted to be used under the Notes following rejection, refusal, suspension or withdrawal; or
- (b) the public notice is issued,

or, in each case, if such date occurs before the Issue Date, the Issue Date;

- "Affiliate" means, in relation to any person, (a) any entity controlled, directly or indirectly, by the person, (b) any entity that controls, directly or indirectly, the person or (c) any entity directly or indirectly under common control with the person (for such purposes, "control" of any entity or person means ownership of a majority of the voting power of the entity or person);
- "Benchmark" means, if SOFR is specified in the relevant Final Terms or Pricing Supplement as the Reference Rate, the Secured Overnight Financing Rate with the applicable period of maturity (which shall be daily); provided that if a Benchmark Transition Event and its related Benchmark Replacement Date have occurred with respect to the Secured Overnight Financing Rate with the applicable period of maturity (which shall be daily), or the then-current Benchmark, then "Benchmark" means the applicable Benchmark Replacement;
- **"Benchmark Replacement"** means the first alternative set forth in the order below that can be determined by the Issuer or its designee as of the Benchmark Replacement Date:
  - (a) the sum of: (i) the alternate rate of interest that has been selected or recommended by the Relevant Governmental Body as the replacement for the then-current Benchmark for the applicable Corresponding Tenor and (ii) the Benchmark Replacement Adjustment;
  - (b) the sum of: (i) the ISDA Fallback Rate and (ii) the Benchmark Replacement Adjustment;
  - (c) the sum of: (i) the alternate rate of interest that has been selected by the Issuer or its designee as the replacement for the then-current Benchmark for the applicable Corresponding Tenor giving due consideration to any industry-accepted rate of interest as a replacement for the then-current Benchmark for U.S. dollar-denominated floating rate notes at such time and (ii) the Benchmark Replacement Adjustment;

"Broken Amount" means the amount specified as such in the applicable Final Terms or Pricing Supplement;

"Business Day" means any day, other than a Saturday or Sunday,

- (a) that is neither a legal holiday nor a day on which banking institutions are authorised or required by law or regulation to close (i) for Notes denominated in U.S. dollars, in The City of New York, (ii) for Notes denominated in Sterling, in London, (iii) for Notes denominated in Australian dollars, in Sydney, (iv) for Notes denominated in a Specified Currency other than U.S. dollars, euro, Sterling or Australian dollars, in the principal Financial Centre of the country of the Specified Currency and (v) in each (if any) Additional Business Centre;
- (b) for Notes denominated in euro, that is also a TARGET Settlement Day and a day that is neither a legal holiday nor a day on which banking institutions are authorised or required by law or regulation to close in each (if any) Additional Business Centre,

and, in each case, if "Additional Business Centre" is specified to be or to include: (i) "U.S. Government Securities Business Day", then "Business Day" shall also be any day other than a Saturday, a Sunday or a day on which the Securities Industry and Financial Markets Association recommends that the fixed income departments of its members be closed for the entire day for purposes of trading in U.S. government securities; or (ii) "TARGET" or "TARGET Settlement Day", then "Business Day" shall include a TARGET Settlement Day;

"Business Day Convention" means, in relation to any particular date referred to in the Conditions or in the applicable Final Terms or Pricing Supplement which is specified to be adjusted in accordance with a Business Day Convention, the convention for adjusting such date if it would otherwise fall on a day that is not a Business Day, any one or more of: Following Business Day Convention, Modified Following Business Day Convention (or Modified Business Day Convention), Preceding Business Day Convention, FRN Convention (or Floating Rate Convention or Eurodollar Convention), No Adjustment (or Unadjusted) or No Adjustment Other Than For Payment Purposes, as specified in the applicable Final Terms or Pricing Supplement. In this context, if the Business Day Convention specified in the applicable Final Terms or Pricing Supplement is:

- (a) **"Following Business Day Convention"**, the relevant date shall be postponed to the first following day that is a Business Day;
- (b) "Modified Following Business Day Convention" or "Modified Business Day Convention", the relevant date shall be postponed to the first following day that is a Business Day unless that day falls in the next calendar month, in which case that date will be the first preceding day that is a Business Day;
- (c) "Preceding Business Day Convention", the relevant date shall be brought forward to the first preceding day that is a Business Day;
- (d) "FRN Convention", "Floating Rate Convention" or "Eurodollar Convention", each relevant date shall be the date which numerically corresponds to the preceding such date in the calendar month which is the number of months specified in the applicable Final Terms or Pricing Supplement as the Specified Period after the calendar month in which the preceding such date occurred **provided**, **however**, **that**:
  - (i) if there is no such numerically corresponding day in the calendar month in which any such date should occur, then such date will be the last day which is a Business Day in that calendar month;
  - (ii) if any such date would otherwise fall on a day which is not a Business Day, then such date will be the first following day which is a Business Day unless that day falls in the next calendar month, in which case it will be the first preceding day which is a Business Day; and
  - (iii) if the preceding such date occurred on the last day in a calendar month which was a Business Day, then all subsequent such dates will be the last day which is a Business Day in the calendar month which is the specified number of months after the calendar month in which the preceding such date occurred;
- (e) "No Adjustment" or "Unadjusted", the relevant date shall not be adjusted in accordance with any Business Day Convention; and

(f) "No Adjustment Other Than For Payment Purposes", the relevant date shall be adjusted in accordance with any of the Business Day Conventions referred to in (a) to (d) above (as specified in the applicable Final Terms or Pricing Supplement) for the purposes of determining the date upon which when any payment should be made, but for all other purposes (including the calculation of any Interest Amount, Fixed Coupon Amount, Broken Amount and any other payment due in respect of the Notes) the relevant date shall not be adjusted in accordance with any Business Day Convention.

provided that if ISDA Determination and "Unscheduled Holiday" are applicable in the applicable Final Terms or Pricing Supplement, then in the case where Modified Following Business Day Convention, Modified Business Day Convention, Preceding Business Day Convention, FRN Convention, Floating Rate Convention or Eurodollar Convention apply to a particular date (including, for the avoidance of doubt, when specified in "No Adjustment Other Than For Payment Purposes") and that date would otherwise fall on a day that is not a Business Day as a result of an Unscheduled Holiday (as defined in the 2021 ISDA Definitions but disregarding references to Valuation Business Day and Exercise Business Day and construing references to the Confirmation to mean the applicable Final Terms or Pricing Supplement) notwithstanding the provisions of (ii) to (iv) above, such day will instead fall on the first following day that is a Business Day;

"Calculation Agent" means, in respect of any Series of Notes, the Fiscal Agent or such other Person specified in the applicable Final Terms or Pricing Supplement as the party responsible for calculating the Rate(s) of Interest and Interest Amount(s), subject as otherwise provided in these Conditions (including, without limitation, as provided in Condition 6 (*Floating Rate Note Provisions*)), and/or any other amount(s) which may be specified as being calculated by the Calculation Agent in the Conditions;

"Calculation Amount" means, unless otherwise specified in the Final Terms or Pricing Supplement, in relation to any Series of Notes, (a) where the Notes have only one Specified Denomination, such Specified Denomination and (b) where Notes of such Series may have more than one Specified Denomination, the lowest common factor of those Specified Denominations;

"Clearstream, Luxembourg" means Clearstream Banking, S.A.;

"CMS Reference Rate" means the rate determined in accordance with the Condition 6.7 (CMS Rate Determination);

- "Principal Financial Centre" means, in relation to any currency, other than the euro, the principal financial centre for that currency, **provided**, **however**, **that**, in relation to Australian dollars, it means Sydney and Melbourne and, in relation to New Zealand dollars, it means Wellington and Auckland;
- "Publication Calendar Day" means, in respect of a benchmark, any day on which the administrator is due to publish the rate for such benchmark pursuant to its publication calendar, as updated from time to time:
- "Rate of Interest" means, in respect of any relevant period or any relevant day (including any Interest Payment Date), the rate or rates (expressed as a percentage per annum) of interest payable in respect of the Notes as specified in applicable Final Terms or Pricing Supplement or calculated or determined in accordance with the Conditions. If more than one Rate of Interest is specified for the Notes, "Rate of Interest" shall be construed to refer to each rate defined or specified as such in respect of the relevant period or day as specified in the applicable Final Terms or Pricing Supplement;
- "Rate Table" means a table specified as such in the applicable Final Terms or Pricing Supplement;
- "Redemption Amount" means, as appropriate, the Final Redemption Amount, the Optional Redemption Amount (Call), the Early Redemption Amount or such other amount in the nature of a redemption amount as may be specified in the applicable Final Terms or Pricing Supplement or determined in accordance with the Conditions;
- "Reference Banks" means the banks specified as such in the applicable Final Terms or Pricing Supplement or, if none are specified, four major banks selected by the Determination Agent in the market that is most closely connected with the Reference Rate. Where the applicable Final Terms or Pricing Supplement specifies "CMS Rate Determination" to be applicable, "Reference Rate" shall be construed to include a CMS Reference Rate. If more than one Reference Rate is specified, "Reference Rate" shall be construed to refer to each rate defined or specified as such, or determined, in respect of the relevant period or day as specified in the applicable Final Terms or Pricing Supplement;
- "Reference Price" means the currency specified as such in the applicable Final Terms or Pricing Supplement;
- "Reference Price" means a numerical value or percentage as specified in the applicable Final Terms or Pricing Supplement;
- "Reference Rate" means, in respect of any relevant period or day, any of the following as specified in the applicable Final Terms or Pricing Supplement: (a) a Fixed Interest Rate; (b) a Floating Interest Rate; or (c) any interest rate, swap rate, index, benchmark or price source specified as a "Reference Rate" in the applicable Final Terms or Pricing Supplement, or determined in accordance with the Conditions, in each case, for such period or such day. Where the applicable Final Terms or Pricing Supplement specify

"CMS Rate Determination" to be applicable, "Reference Rate" shall be construed to include a CMS Reference Rate. If more than one Reference Rate is specified, "Reference Rate" shall be construed to refer to each rate defined or specified as such, or determined, in respect of the relevant period or day as specified in the applicable Final Terms or Pricing Supplement;

"Reference Time" with respect to any determination of the Benchmark means the time determined by the Issuer or its designee in accordance with the Benchmark Replacement Conforming Changes;

"Relevant Governmental Body" means the Federal Reserve Board and/or the Federal Reserve Bank of New York, or a committee officially endorsed or convened by the Federal Reserve Board and/or the Federal Reserve Bank of New York or any successor thereto;

# "Relevant Rates Benchmark" means, in respect of any Notes:

- (a) each Reference Rate (or, if applicable, the index, benchmark or other price source that is referred to in the Reference Rate) other than a Fixed Interest Rate;
- (b) each Floating Rate Option (or, if applicable, the index, benchmark or other price source that is referred to in the Floating Rate Option); or
- (c) any other index, benchmark or other price source specified as a "Relevant Rates Benchmark" in the applicable Final Terms or Pricing Supplement;
- "Register" shall have the meaning given to it in the Issue and Paying Agency Agreement;
- "Relevant Clearing System" means, as appropriate, Clearstream, Luxembourg and/or Euroclear and/or such other relevant clearing system, as the case may be, through which interests in Notes are to be held and through an account at which the Notes are to be cleared, as specified in the applicable Final Terms or Pricing Supplement;

- "Relevant Screen Page" means, in respect of a Reference Rate, the page, section or other part of a particular information service (including, without limitation, Reuters) specified as such in the applicable Final Terms or Pricing Supplement in relation to such Reference Rate, or such other page, section or other part as may replace it on that information service or such other information service, in each case, as may be nominated by the Person providing or sponsoring the information appearing there for the purpose of displaying rates or prices comparable to such Reference Rate;
- "Relevant Time" means, for the purposes of a determination of a Reference Rate, the time (in the place) specified as such in the applicable Final Terms or Pricing Supplement corresponding to such Reference Rate:
- "Reserved Matter" means any proposal to change any date fixed for payment of principal or interest in respect of the Notes, to reduce the amount of principal or interest payable on any date in respect of the Notes, to alter the method of calculating the amount of any payment in respect of the Notes or the date for any such payment, to change the currency of any payment under the Notes or to change the quorum requirements relating to meetings or the majority required to pass an Extraordinary Resolution;

  - "SONIA", in respect of any London Banking Day, means the Sterling Overnight Index Average rate administered by the Bank of England (or any successor administrator) for such London Banking Day as provided by the administrator of such rate to authorised distributors and as then published on the Relevant Screen Page or, if the Relevant Screen Page is unavailable, as otherwise published by such authorised distributors, in each case as of 9.00a.m. (London time) (or any amended publication time as specified by the administrator of such rate in the benchmark methodology) on the London Banking Day immediately following such London Banking Day;
  - "SONIA Rate Cut-Off Date" means the date that is the number of London Banking Days specified in the applicable Final Terms or Pricing Supplement (or if none are specified, the second London Banking Day) prior to the Maturity Date or the redemption date, as applicable;
- "Specified Currency" means the currency or currencies specified as such in the applicable Final Terms or Pricing Supplement;
- "Specified Day(s)" means such number of Business Day(s), Clearing System Business Day(s) or calendar days as specified in the applicable Final Terms or Pricing Supplement;
- "Specified Denomination(s)" means, in relation to Notes of any Series, the denomination or denominations of such Notes specified as such in the applicable Final Terms or Pricing Supplement and may be expressed as (a) currency amounts or (b) a currency amount and integral multiples of a second currency amount in excess of such currency amount;
- "Specified Fixed Leg" means any of the following as specified in the applicable Final Terms or Pricing Supplement: (a) the annual fixed leg; (b) the semi-annual fixed leg; (c) quarterly-annual fixed leg; or (d) the quarterly-quarterly fixed leg;
- "Specified Office" has the meaning given to it in the Issue and Paying Agency Agreement;
- "Specified Period" means a period specified as such in the applicable Final Terms or Pricing Supplement;
- "Specified Rate" has the meaning given it in the applicable Final Terms or Pricing Supplement;

"Specified Swap Rate" means any of the following as specified in the applicable Final Terms or Pricing Supplement: (a) the swap rate; (b) the annual swap rate; (c) the semi-annual swap rate; (d) the quarterly swap rate; (e) the quarterly-annual swap rate; or (f) the quarterly quarterly swap rate;

"Spread" has the value given to it in the applicable Final Terms or Pricing Supplement;

"Subsidiary" means, in relation to any Person (the "first Person") at any particular time, any other Person (the "second Person"):

- (a) whose affairs and policies the first Person controls or has the power to control, whether by ownership of share capital, contract, the power to appoint or remove members of the governing body of the second Person or otherwise; or
- (b) whose financial statements are, in accordance with applicable law and generally accepted accounting principles, consolidated with those of the first Person;

"T2" means the real time gross settlement system operated by the Eurosystem, or any successor system;

"TARGET Settlement Day" means any day on which T2 is open for the settlement of payments in euro;

"Taxes" means any tax, duty, impost, levy, charge or contribution in the nature of taxation or any withholding or deduction for or on account thereof, including (but not limited to) any applicable stock exchange tax, turnover tax, stamp duty, stamp duty reserve tax and/or other taxes chargeable or payable in connection with any redemption of a Note and/or payment of the Redemption Amount;

"Tokyo Banking Day" or "TBD" means any day on which commercial banks are open for general business (including dealing in foreign exchange and foreign currency deposits) in Tokyo;

"TONA", in respect of any Tokyo Banking Day, means the Tokyo Overnight Average Rate administered by the Bank of Japan (or any successor administrator) for such Tokyo Banking Day as provided by the administrator of such rate to authorised distributors and as then published on the Relevant Screen Page or, if the Relevant Screen Page is unavailable, as otherwise published by the administrator of TONA or by such authorised distributors, in each case as of approximately 10.00a.m. (Tokyo time) (or any amended publication time as specified by the administrator of such rate in the benchmark methodology) on the Tokyo Banking Day immediately following such Tokyo Banking Day;

"TONA Rate Cut-Off Date" means the date that is the number of Tokyo Banking Days specified in the applicable Final Terms or Pricing Supplement (or if none are specified, the second Tokyo Banking Day) prior to the Maturity Date or the redemption date, as applicable;

"Trade Date" means, in relation to any Series of Notes, the date specified as such in the applicable Final Terms or Pricing Supplement;

"Treaty" means the Treaty establishing the European Union, as amended;

**"Unadjusted Benchmark Replacement"** means the Benchmark Replacement excluding the Benchmark Replacement Adjustment;

"U.S. Government Securities Business Day" means any day except for a Saturday, Sunday or a day on which the Securities Industry and Financial Markets Association recommends that the fixed income departments of its members be closed for the entire day for the purposes of trading in U.S. government securities;

"Zero Coupon Note" means a Note specified as such in the applicable Final Terms or Pricing Supplement; and

"Zurich Banking Day" or "ZBD" means any day on which commercial banks are open for general business (including dealing in foreign exchange and foreign currency deposits) in Zurich.

# 2.2 **Interpretation**

In these Conditions:

- (a) any reference to a numbered "Condition" shall be construed as a reference to the relevant Condition:
- (b) any reference to principal shall be deemed to include the Redemption Amount, any additional amounts in respect of principal which may be payable under Condition 12 (*Taxation*), any premium payable in respect of a Note and any other amount in the nature of principal payable pursuant to the Conditions;
- (c) any reference to interest shall be deemed to include any additional amounts in respect of interest which may be payable under Condition 12 (*Taxation*), and any other amount in the nature of interest payable pursuant to the Conditions;
- (d) references to Notes being **"outstanding"** shall be construed in accordance with the Issue and Paying Agency Agreement; and
- (e) if an expression is stated in Condition 2.1 (*Definitions*) to have the meaning given or specified in the applicable Final Terms or Pricing Supplement, but the applicable Final Terms or Pricing Supplement gives no such meaning or specifies that such expression is "not applicable", then such expression is not applicable to the Notes.

# 3. FORM AND TITLE

3.1 *Form*: The Issuer will issue Notes in registered form.

# 3.2 Notes

- (a) Form of Certificate: Notes may be in either individual certificate form or in global certificate form.
- (b) *Title*: Title to the Notes passes by registration in the Register which is kept by the Registrar in accordance with the provisions of the Issue and Paying Agency Agreement. A certificate (each a "Note Certificate") will be issued to each holder of Notes in respect of its registered holding. Each Note Certificate will be numbered serially with an identifying number which will be recorded in the Register. "Holder" and "holder" means, in the case of Notes, the person in whose name such Note is for the time being registered in the Register (or, in the case of a joint holding, the first named thereof) and "Noteholder" shall be construed accordingly.
- (c) *Interest*: A Note may be a Fixed Rate Note, a Floating Rate Note, an Inflation-Linked Note, a Zero Coupon Note or a combination of any of the foregoing, depending upon the Interest Basis shown in the applicable Final Terms or Pricing Supplement.
- (d) *Ownership*: The holder of any Note shall (except as otherwise required by law) be treated as its absolute owner for all purposes (whether or not it is overdue and regardless of any notice of ownership, trust or any other interest therein, any writing thereon or on the Note Certificate relating thereto (other than the endorsed form of transfer) or any notice of any previous loss or theft thereof) and no Person shall be liable for so treating such holder.
- (e) Transfers: Subject to Conditions 3.2(h) (Closed Periods) and 3.2(i) (Regulations concerning Transfers and Registration), a Note may be transferred upon surrender of the relevant Note Certificate, with the endorsed form of transfer duly completed, at the Specified Office of the Registrar or any Transfer Agent, together with such evidence as the Registrar or (as the case may be) such Transfer Agent may reasonably require to prove the title of the transferor and the authority of the individuals who have executed the form of transfer; provided, however, that a Note may not be transferred unless the principal amount of Note transferred and (where not all of the Notes held by a holder are being transferred) the principal amount of the balance of Notes not transferred are Specified Denominations. Where not all the Notes represented by the surrendered Note Certificate are the subject of the transfer, a new Note Certificate in respect of the balance of the Notes will be issued to the transferor.

- (f) **Registration and Delivery**: Within five business days of the surrender of a Note Certificate in accordance with Condition 3.2(e) (*Transfers*), the Registrar will register the transfer in question and deliver a new Note Certificate of a like principal amount to the Notes transferred to each relevant holder at its Specified Office or (as the case may be) the Specified Office of any Transfer Agent or (at the request and risk of any such relevant holder) by uninsured first class mail (airmail if overseas) to the address specified for the purpose by such relevant holder. In this Condition 3.2(f) (*Registration and Delivery*), "business day" means a day on which commercial banks are open for general business (including dealings in foreign currencies) in the city where the Registrar or (as the case may be) the relevant Transfer Agent has its Specified Office.
- (g) **No Charge**: The transfer of a Note will be effected without charge by or on behalf of the Issuer or the Registrar or any Transfer Agent but against such indemnity as the Registrar or (as the case may be) such Transfer Agent may require in respect of any tax or other duty of whatsoever nature which may be levied or imposed in connection with such transfer.
- (h) *Closed Periods*: Holders of Notes may not require transfers to be registered during the period of 15 days ending on the due date for any payment of principal or interest in respect of the Notes.
- (i) Regulations concerning Transfers and Registration: All transfers of Notes and entries on the Register are subject to the detailed regulations concerning the transfer of Notes scheduled to the Issue and Paying Agency Agreement. The regulations may be changed by the Issuer with the prior written approval of the Registrar. A copy of the current regulations will be mailed (free of charge) by the Registrar to any holder of Notes who requests in writing a copy of such regulations.

#### 4. STATUS

The Notes constitute part of the Issuer's senior debt and will rank pari passu with all of the Issuer's other unsecured and unsubordinated debt.

Morgan Stanley intends that the Notes will, when issued, constitute "loss-absorbing capacity" within the meaning of the final rules issued by the Board of Governors of the Federal Reserve System and, accordingly, will have only those provisions described in this Base Prospectus that will permit compliance thereof at such time of issuance. In this respect, Morgan Stanley is a parent holding company and has no operations and depends on dividends, distributions and other payments from its subsidiaries to fund its debt obligations (including Notes). Under a support agreement that Morgan Stanley has entered with its material subsidiaries, upon the occurrence of a resolution scenario, including a single-point-of-entry resolution strategy as contemplated in its resolution plan, Morgan Stanley would be obligated to contribute or loan on a subordinated basis all of its material assets, other than shares in its subsidiaries and certain intercompany payables, to provide capital and liquidity, as applicable, to its material subsidiaries. That obligation will be secured, in accordance with an amended and restated secured support agreement, on a senior basis by Morgan Stanley's assets (other than shares in its subsidiaries). As a result, claims of Morgan Stanley's material subsidiaries against its assets (other than shares in its subsidiaries) will be effectively senior to its unsecured obligations, including Notes which would be at risk of absorbing Morgan Stanley's and its subsidiaries' losses.

### 5. FIXED RATE NOTE PROVISIONS

- 5.1 **Application**: This Condition 5 (*Fixed Rate Note Provisions*) is applicable to the Notes only if the Fixed Rate Note Provisions are specified in the applicable Final Terms or Pricing Supplement as being applicable in each case, in respect of an Interest Period and/or Interest Payment Date(s).
- 5.2 *Fixed Interest Rate*: The Rate of Interest in respect of each Interest Period and/or Interest Payment Date which is subject to the Fixed Rate Note Provisions will be the Fixed Interest Rate. A different Fixed Interest Rate may apply in respect of different Interest Periods and/or Interest Payment Dates, as specified in the applicable Final Terms or Pricing Supplement. If a Rate of Interest or a Reference Rate for any period or any relevant day is specified in the Conditions or in the applicable Final Terms or Pricing Supplement to be a "Fixed Interest Rate", the relevant

- Rate of Interest or Reference Rate will be determined in accordance with the provisions set out in this Condition 5 (*Fixed Rate Note Provisions*).
- 5.3 Accrual of Interest: The Notes bear interest from (and including) the Interest Commencement Date at the Rate(s) of Interest. Interest will be payable in arrear on each Interest Payment Date, subject as provided in Condition 11 (Payments). Each Note will cease to bear interest from the date for its final redemption, unless upon such date, the Redemption Amount remains unpaid when due and payable, in which case it will continue to bear interest on unpaid amounts in accordance with this Condition 5 (Fixed Rate Note Provisions) (as well after as before judgment) until the day on which the Redemption Amount has been paid or duly made available for payment.
- Fixed Coupon Amount: If "Fixed Coupon Amount" is specified as applicable in the applicable Final Terms or Pricing Supplement, the amount of interest payable in respect of each Note on each Interest Payment Date shall be the relevant Fixed Coupon Amount and, if the Notes are in more than one Specified Denomination, shall be the relevant Fixed Coupon Amount in respect of the relevant Specified Denomination, provided that, if a Broken Amount is specified in the Final Terms or Pricing Supplement as applicable in respect of an Interest Payment Date in respect of each Calculation Amount, the Interest Amount payable on such Interest Payment Date in respect of such Note per Calculation Amount shall be the Broken Amount.
  - Different Fixed Coupon Amounts may apply in respect of different Interest Periods and/or Interest Payment Dates, as specified in the applicable Final Terms or Pricing Supplement.
- 5.5 Calculation of Interest: If "Fixed Coupon Amount" is specified as not applicable in the applicable Final Terms or Pricing Supplement, the amount of interest payable in respect of each Note in respect of any Interest Period shall be an amount per Calculation Amount calculated by applying the Rate of Interest to the Calculation Amount, multiplying the product by the applicable Day Count Fraction and rounding the resulting figure to the nearest sub-unit of the Specified Currency (half of any such sub-unit being rounded upwards). For this purpose, a "sub-unit" means, in the case of any currency other than euro, the lowest amount of such currency that is available as legal tender in the country of such currency and, in the case of euro, means one cent.
- 5.6 **Day Count Fraction**: The relevant day count fraction shall be determined in accordance with the definition of **''Day Count Fraction''** set out in Condition 2.1 (*Definitions*).

### 6. FLOATING RATE NOTE PROVISIONS

- 6.1 **Application**: This Condition 6 (*Floating Rate Note Provisions*) is applicable to the Notes only if one or more of the Floating Rate Note Provisions are specified in the applicable Final Terms or Pricing Supplement as being applicable, in each case, in respect of an Interest Period and/or Interest Payment Date(s).
- Floating Interest Rate: The Rate of Interest in respect of each Interest Period and/or Interest Payment Date which is subject to the Floating Rate Note Provisions will be the Floating Interest Rate. A different Floating Interest Rate may apply in respect of different Interest Periods and/or Interest Payment Dates, as specified in the applicable Final Terms or Pricing Supplement. If a Rate of Interest or a Reference Rate for any period or any relevant day is specified in the Conditions or in the applicable Final Terms or Pricing Supplement to be a "Floating Interest Rate", the relevant Rate of Interest or Reference Rate will be determined in accordance with the provisions set out in Condition 6.5 (Screen Rate Determination), Condition 6.6 (ISDA Determination), Condition 6.7 (CMS Rate Determination), Condition 6.8 (Provisions specific to SOFR as Reference Rate), Condition 6.9 (Provisions specific to SONIA as Reference Rate), Condition 6.10 (Provisions specific to ESTR as Reference Rate), Condition 6.11 (Provisions specific to SARON as Reference Rate) or Condition 6.12 (Provisions specific to TONA as Reference Rate), as specified in the applicable Final Terms or Pricing Supplement.
- 6.3 Accrual of Interest: Each Floating Rate Note bears interest from (and including) the Interest Commencement Date at the Floating Interest Rate in respect of each Interest Period (each being a "Rate of Interest" in respect of Floating Rate Notes) payable in arrear on each Interest Payment Date, subject as provided in Condition 11 (Payments). Each Note will cease to bear interest from the date for its final redemption unless, upon such date, the Redemption Amount remains unpaid when due and payable, in which case it will continue to bear interest on unpaid

amounts in accordance with this Condition 6 (*Floating Rate Note Provisions*) (as well after as before judgment) until the day on which the Redemption Amount has been paid or duly made available for payment. The Rate of Interest in respect of all or any Interest Periods shall, if so specified in the applicable Final Terms or Pricing Supplement, be zero.

- 6.4 *Linear Interpolation*: In respect of any Notes for which the Floating Rate Notes Provisions are applicable, if "Linear Interpolation" is specified to be applicable in respect of any Interest Period, the Floating Interest Rate for such Interest Period shall be determined by the Determination Agent through the use of straight-line interpolation by reference to:
  - (a) if "Screen Rate Determination" is specified as the manner in which the Floating Interest Rate is to be determined, two rates based on the relevant Reference Rate, one of which shall be determined as if the Designated Maturity were the period of time, for which rates are available, next shorter than the length of such Interest Period and the other of which shall be determined as if the Designated Maturity were the period of time, for which rates are available, next longer than the length of such Interest Period;
  - (b) if "ISDA Determination" is specified as the manner in which the Floating Interest Rate is to be determined, unless "2021 ISDA Definitions Linear Interpolation" is specified as applicable in the relevant Final Terms or Pricing Supplement, two rates based on the relevant Floating Rate Option one of which shall be determined as if the Designated Maturity were the period of time, for which rates are available, next shorter than the length of such Interest Period and the other of which shall be determined as if the Designated Maturity were the period of time, for which rates are available, next longer than the length of such Interest Period; and
  - (c) if "CMS Rate Determination" is specified as the manner in which the Floating Interest Rate is to be determined, two rates based on the relevant CMS Reference Rate one of which shall be determined as if the Designated Maturity were the period of time, for which rates are available, next shorter than the length of such Interest Period and the other of which shall be determined as if the Designated Maturity were the period of time, for which rates are available, next longer than the length of such Interest Period.
- 8.5 Screen Rate Determination: Subject to Condition 6.8 (Provisions specific to SOFR as Reference Rate), Condition 6.9 (Provisions specific to SONIA as Reference Rate), Condition 6.10 (Provisions Specific to &STR as Reference Rate), Condition 6.11 (Provisions specific to SARON as Reference Rate), Condition 6.12 (Provisions specific to TONA as Reference Rate), Condition 6.17 (Relevant Rates Benchmark Discontinuance or Prohibition on Use), where such provisions are specified to apply in the applicable Final Terms or Pricing Supplement, Condition 6.18 (CMS Reference Rate Effect of Index Cessation Event) or Condition 6.19 (General Fallback Arrangements), if "Screen Rate Determination" is specified in the applicable Final Terms or Pricing Supplement as the manner in which a Floating Interest Rate is to be determined, the Floating Interest Rate for an Interest Period or any relevant day (each a "Relevant Day") will be the Screen Rate for such Interest Period or such Relevant Day, plus or minus (as indicated in the applicable Final Terms or Pricing Supplement) the Margin (if any is specified in the applicable Final Terms or Pricing Supplement in relation to such Screen Rate), and multiplied by the Interest Participation Rate (if any is specified in the applicable Final Terms or Pricing Supplement in relation to such Screen Rate).

The Screen Rate applicable to the Notes for an Interest Period or a Relevant Day will be determined by the Determination Agent on the following basis:

- (a) if the Reference Rate is a composite quotation or customarily supplied by one entity, the Screen Rate will be the Reference Rate which appears on the Relevant Screen Page as of the Relevant Time on the relevant Interest Determination Date in respect of such Interest Period or such Relevant Day, as determined by the Determination Agent;
- (b) in any other case, the Screen Rate will be the arithmetic mean of the Reference Rates which appear on the Relevant Screen Page as of the Relevant Time on the relevant Interest Determination Date in respect of such Interest Period or such Relevant Day, as determined by the Determination Agent;
- (c) if, in the case of Condition 6.5(a) (*Screen Rate Determination*), such rate does not appear on that page or, in the case of Condition 6.5(b) (*Screen Rate Determination*),

fewer than two such rates appear on that page or if, in either case, the Relevant Screen Page is unavailable, the Determination Agent will:

- (i) request the principal Relevant Financial Centre office of each of the Reference Banks to provide a quotation of the Reference Rate at approximately the Relevant Time on the Interest Determination Date in respect of such Interest Period or such Relevant Day to prime banks in the Relevant Financial Centre interbank market in an amount that is representative for a single transaction in that market at that time; and
- (ii) determine the arithmetic mean of such quotations; and
- (d) if fewer than two such quotations are provided as requested, the Determination Agent will determine the arithmetic mean of the rates (being the nearest to the Reference Rate, as determined by the Determination Agent) quoted by major banks in the Principal Financial Centre of the Specified Currency, selected by the Determination Agent, at approximately 11:00 a.m. (local time in the Principal Financial Centre of the Specified Currency) on the first day of the relevant Interest Period for loans in the Specified Currency to leading European banks for a period equal to the relevant Interest Period or for a Relevant Day and in an amount that is representative for a single transaction in that market at that time,

and the Rate of Interest for such Interest Period shall be the sum of the Margin and the rate or (as the case may be) the arithmetic mean so determined, **provided**, **however**, **that**, if the Determination Agent is unable to determine a rate or (as the case may be) an arithmetic mean in accordance with the above provisions in relation to any Interest Period or any Relevant Day, the Screen Rate applicable to the Notes in respect of such Interest Period or such Relevant Day will be the rate (or as the case may be) the arithmetic mean last determined in relation to the Notes in respect of a preceding Interest Period or Relevant Day.

- ISDA Determination: Subject to Condition 6.17 (Relevant Rates Benchmark Discontinuance 6.6 or Prohibition on Use), where such provisions are specified to apply in the applicable Final Terms or Pricing Supplement, Condition 6.18 (CMS Reference Rate - Effect of Index Cessation Event) or Condition 6.19 (General Fallback Arrangements), if "ISDA Determination" is specified in the applicable Final Terms or Pricing Supplement as the manner in which a Floating Interest Rate is to be determined, the Floating Interest Rate applicable to the Notes for each Interest Period will be the relevant ISDA Rate, plus or minus (as indicated in the applicable Final Terms or Pricing Supplement) the Margin (if any is specified in the applicable Final Terms or Pricing Supplement in relation to such ISDA Rate), and multiplied by the Interest Participation Rate (if any is specified in the applicable Final Terms or Pricing Supplement in relation to such ISDA Rate). The "ISDA Rate" in relation to any Interest Period, means a rate equal to the Floating Rate (as defined in the ISDA Definitions) that would be determined by the Determination Agent under an interest rate swap transaction if the Determination Agent were acting as calculation agent for that interest rate swap transaction under the terms of an agreement incorporating the ISDA Definitions and under which:
  - (i) the Floating Rate Option (as defined in the ISDA Definitions) is as specified in the applicable Final Terms or Pricing Supplement;
  - (ii) except in the case of Overnight Floating Rate Options (as defined in the ISDA Definitions), the Designated Maturity (as defined in the ISDA Definitions), if applicable, is a period specified in the applicable Final Terms or Pricing Supplement;
  - (iii) the relevant Fixing Day (as defined in the ISDA Definitions) is as specified in the applicable Final Terms or Pricing Supplement;
  - (iv) the relevant Reset Date (as defined in the ISDA Definitions) is as specified in the applicable Final Terms or Pricing Supplement;

- (1) Compounding with Lookback is applicable if specified in the relevant Final Terms or Pricing Supplement and, if so, (a) Lookback is the number of Applicable Business Days specified in the relevant Final Terms or Pricing Supplement or, if not so specified in the relevant Final Terms or Pricing Supplement, in the ISDA Definitions and (b) Daily Capped Rate and/or Daily Floored Rate are applicable if specified in the relevant Final Terms or Pricing Supplement and, if so, the Daily Capped Rate and the Daily Floored Rate are the rates specified in the relevant Final Terms or Pricing Supplement;
- (2) Compounding with Observation Period Shift is applicable if specified in the relevant Final Terms or Pricing Supplement and, if so, (a) Set-in-Advance is applicable if specified as such in the relevant Final Terms or Pricing Supplement, (b) Observation Period Shift is the number of Observation Period Shift Business Days specified in the applicable Final Terms or Pricing Supplement or, if not so specified in the applicable Final Terms or Pricing Supplement, in the ISDA Definitions, (c) Observation Period Shift Additional Business Days are the days, if any, specified as such in the applicable Final Terms or Pricing Supplement and (d) Daily Capped Rate and/or Daily Floored Rate are applicable if specified in the relevant Final Terms or Pricing Supplement and, if so, the Daily Capped Rate and the Daily Floored Rate are the rates specified in the applicable Final Terms or Pricing Supplement;

- (3) Averaging with Observation Period Shift is applicable if specified in the relevant Final Terms or Pricing Supplement and, if so, Set-in-Advance is applicable if specified as such in the relevant Final Terms or Pricing Supplement and, if so, (a) Set-in-Advance is applicable if specified as such in the relevant Final Terms or Pricing Supplement, (b) Observation Period Shift is the number of Observation Period Shift Business Days specified in the applicable Final Terms or Pricing Supplement or, if not so specified in the applicable Final Terms or Pricing Supplement, in the ISDA Definitions, (c) Observation Period Shift Additional Business Days are the days, if any, specified as such in the applicable Final Terms or Pricing Supplement and (d) Daily Capped Rate and/or Daily Floored Rate are applicable if specified in the relevant Final Terms or Pricing Supplement and, if so, the Daily Capped Rate and the Daily Floored Rate are the rates specified in the applicable Final Terms or Pricing Supplement;
- (4) Averaging with Lockout is applicable if specified in the relevant Final Terms or Pricing Supplement and, if so, (a) Lockout is the number of Lockout Period Business Days specified in the applicable Final Terms or Pricing Supplement or, if not so specified in the applicable Final Terms or Pricing Supplement, in the ISDA Definitions, (b) Lockout Period Business Days are the days specified as such in the applicable Final Terms or Pricing Supplement or, if not so specified in the applicable Final Terms or Pricing Supplement, in the ISDA Definitions and (c) Daily Capped Rate and/or Daily Floored Rate are applicable if specified in the relevant Final Terms or Pricing Supplement and, if so, the Daily Capped Rate and the Daily Floored Rate are the rates specified in the applicable Final Terms or Pricing Supplement; or

- (vi) if an Index Floating Rate Option (as defined in the ISDA Definitions) is specified as applicable in the relevant Final Terms or Pricing Supplement and an Index Method is specified in the relevant Final Terms or Pricing Supplement:
  - (C) Standard Index Method is applicable if specified in the relevant Final Terms or Pricing Supplement;
  - (D) Compounded Index Method is applicable if specified in the relevant Final Terms or Pricing Supplement; or
  - (E) Compounded Index Method with Observation Period Shift is applicable if specified in the relevant Final Terms or Pricing Supplement and, if so, (a) Set-in-Advance is applicable if specified as such in the relevant Final Terms or Pricing Supplement, (b) Observation Period Shift is the number of Observation Period Shift Business Days specified in the applicable Final Terms or Pricing Supplement or, if not so specified in the applicable Final Terms or Pricing Supplement, in the ISDA Definitions and (c) Observation Period Shift Additional

Business Days are the days, if any, specified as such in the applicable Final Terms or Pricing Supplement;

- (vii) in connection with any Overnight Rate Compounding Method, Overnight Rate Averaging Method or Index Method specified in the applicable Final Terms or Pricing Supplement, references in the ISDA Definitions to: (1) numbers, financial centers or other items specified in the Confirmation shall be deemed to be references to the numbers, financial centers or other items specified for such purpose in the relevant Final Terms or Pricing Supplement; (2) "Business Day in the financial centers, if any, specified for such purpose in the Confirmation" shall be deemed to be references to Business Day; (3) "Calculation Period" shall be deemed to be references to the relevant Interest Period; (4) "Floating Rate Day Count Fraction" shall be deemed to be references to the relevant Interest Period End Date" shall be deemed to be references to the relevant Interest Period End Date; (6) "Termination Date" shall be deemed to be references to the final Interest Period End Date; and (7) "Effective Date" shall be deemed to be references to the Interest Commencement Date:
- (viii) Delayed Payment is applicable if specified in the relevant Final Terms or Pricing Supplement and the relevant delay is the number of Business Days specified in respect of Delayed Payment in the applicable Final Terms or Pricing Supplement;
- (ix) Period End Date/ Termination Date adjustment for Unscheduled Holiday (as defined in the 2021 ISDA Definitions) will apply if specified in the applicable Final Terms or Pricing Supplement to be applicable;
- (x) Non-Representative (as defined in the 2021 ISDA Definitions) will apply if specified in the relevant Final Terms or Pricing Supplement to be applicable;
- (xi) Successor Benchmark and Successor Benchmark Effective Date (as defined in the 2021 ISDA Definitions) will be as specified in the applicable Final Terms or Pricing Supplement;
- (xii) if any fallbacks would otherwise be required to be determined in accordance with Section 8.6 (Generic Fallback Provisions) of the ISDA Definitions, such fallbacks shall not be so determined, but shall instead be determined in accordance with Condition 6.17 (Relevant Rates Benchmark Discontinuance or Prohibition on Use), where such provisions are specified to apply in the applicable Final Terms or Pricing Supplement, Condition 6.18 (CMS Reference Rate Effect of Index Cessation Event), where the Relevant Rates Benchmark is the CMS Reference Rate, or Condition 6.19 (General Fallback Arrangements) and the ISDA Definitions shall be construed accordingly;
- (xiii) Sections 1.2.2 (Calculation Agent Standard) and 1.2.4 (Determinations by Calculation Agent) of the ISDA Definitions are deemed to be deleted;
- (xiv) Section 6.10 (Linear Interpolation) of the ISDA Definitions is deemed to be deleted unless "2021 ISDA Definitions Linear Interpolation" is specified as applicable in the relevant Final Terms or Pricing Supplement;
- (xv) in any circumstance where the ISDA Definitions provide for anything to be determined by agreement between the parties or a discretion is given thereunder to the Calculation Agent to make any determination, the Determination Agent will make such determination or exercise such discretion; and
- (xvi) notwithstanding any other Conditions, and unless "TEC10 Adjustment" is specified as "Not Applicable" in the applicable Final Terms or Pricing Supplement, if in respect of any Interest Period the Determination Agent determines that the 10-year constant maturity French treasury rate (known as CNO TEC10) published by the Bank of France no longer represents the actual yield to maturity of a notional *Obligations assimilables du Trésor* ("**OAT**") with a maturity of exactly 10 years (based on executable prices available to the Determination Agent for OATs with a maturity most closely matching a 10-year maturity) (which event may occur in connection with or following any default or potential default of the Republic of France or unexpected volatility or illiquidity in markets in trading of OATs), then the ISDA Rate shall not be calculated in accordance with this Condition 6.6 (*ISDA Determination*) and instead the ISDA Rate in respect of such Interest Period for the purposes of the Conditions shall be deemed to be the yield

to maturity of a notional OAT with a maturity of exactly 10 years, as determined by the Determination Agent acting in good faith and a commercially reasonable manner by reference to bid prices for OATs with a maturity most closely matching a 10-year maturity and having regard to such pricing sources, methods and models (which may include, without limitation, any available firm or indicative prices for such OATs or internal valuation or recovery models) as the Determination Agent considers appropriate .

6.7 **CMS Rate Determination**: Subject to Condition 6.18 (*CMS Reference Rate - Effect of Index Cessation Event*), if CMS Rate Determination is specified in the applicable Final Terms or Pricing Supplement as the manner in which a Floating Interest Rate is to be determined, the Floating Interest Rate applicable to the Notes for each Interest Period will be the relevant CMS Interest Rate determined in accordance with paragraphs (a) or (b) below, as applicable.

## (a) Single CMS Rate

If the CMS Interest Rate is specified in the applicable Final Terms or Pricing Supplement to be "Single CMS Rate", the CMS Interest Rate in respect of an Interest Period or any relevant day will be equal to the CMS Reference Rate for such Interest Period or such relevant day, plus or minus (as indicated in the applicable Final Terms or Pricing Supplement) the Margin (if any is specified in the applicable Final Terms or Pricing Supplement in relation to such CMS Reference Rate), and multiplied by the Interest Participation Rate (if any is specified in the applicable Final Terms or Pricing Supplement in relation to such CMS Reference Rate).

# (b) Spread CMS Rate

If the CMS Interest Rate is specified in the applicable Final Terms or Pricing Supplement to be "Spread CMS Rate", the CMS Interest Rate in respect of an Interest Period or any relevant day will be equal to the difference between (1) CMS Reference Rate 1 for such Interest Period or such relevant day, plus or minus (as specified in the applicable Final Terms or Pricing Supplement) Margin 1 (if any is specified in the applicable Final Terms or Pricing Supplement in relation to such CMS Reference Rate 1), and multiplied by Interest Participation Rate 1 (if any is specified in the applicable Final Terms or Pricing Supplement in relation to such CMS Reference Rate 1), minus (2) CMS Reference Rate 2 for such Interest Period or such relevant day, plus or minus (as specified in the applicable Final Terms or Pricing Supplement) Margin 2 (if any is specified in the applicable Final Terms or Pricing Supplement in relation to such CMS Reference Rate 2), and multiplied by Interest Participation Rate 2 (if any is specified in the applicable Final Terms or Pricing Supplement in relation to such CMS Reference Rate 2).

### (c) Determination of CMS Reference Rate

The CMS Reference Rate in respect of an Interest Period or any relevant day (as applicable) will be the Specified Swap Rate for swap transactions in the Reference Currency with a maturity of the Designated Maturity (expressed as a percentage rate per annum) (the "Relevant Swap Rate") which appears on the Relevant Screen Page as at the Relevant Time on the Interest Determination Date in respect of such Interest Period or such relevant day, all as determined by the Determination Agent. If the Relevant Swap Rate does not appear on the Relevant Screen Page at the Relevant Time, the CMS Reference Rate in respect of an Interest Period or a relevant day (as applicable) will be determined by the Determination Agent in accordance with the first applicable Fallback Rate Determination that provides a CMS Reference Rate, and if the applicable Final Terms or Pricing Supplement specifies:

- (i) "Fallback Screen Page" to be applicable, the Determination Agent will, acting in good faith and in a commercially reasonable manner, determine an alternative or successor page or publication to the Relevant Screen Page for the Relevant Swap Rate;
- (ii) "Mid-Market Quotations" to be applicable, the Determination Agent will determine the CMS Reference Rate on the basis of the arithmetic mean of the Mid-Market Quotations provided by the Reference Banks at approximately the Relevant Time on the Interest Determination Date in respect of such Interest Period or such day by requesting the principal Relevant Financial Centre office of each of the Reference Banks to provide Mid-Market Quotations. If at least five Mid-Market Quotations are provided, the

Determination Agent will determine the arithmetic mean of such Mid-Market Quotations provided by discarding the highest of such Mid-Market Quotations (or in event of equality, one of the highest) and lowest of such Mid-Market Quotations (or in event of equality, one of the lowest). If four Mid-Market Quotations are provided, the Determination Agent will determine the arithmetic mean of such Mid-Market Quotations provided. If less than four Mid-Market Quotations are provided, the next Fallback Rate Determination specified in the applicable Final Terms or Pricing Supplement will apply, or if none is specified, Determination Agent Fallback will apply. All calculations of the arithmetic mean of the relevant number of Mid-Market Quotations provided pursuant to this paragraph will be rounded to the nearest one thousandth of a percentage point, with 0.0005 being rounded upwards; and

(iii) "Determination Agent Fallback" to be applicable, the Determination Agent will, acting in good faith and in a commercially reasonable manner, determine the CMS Reference Rate by using available and relevant public information and having regard to comparable benchmarks available.

If any Fallback Rate Determination(s) are specified in the applicable Final Terms or Pricing Supplement, then only that or those (as the case may be) Fallback Rate Determinations shall apply, and if two or more Fallback Rate Determinations are specified, those Fallback Rate Determinations shall apply in the order as specified in the applicable Final Terms or Pricing Supplement, such that if the Determination Agent determines that the CMS Reference Rate cannot be determined by applying a Fallback Rate Determination, then the next Fallback Rate Determination specified shall apply.

# 6.8 Provisions specific to SOFR as Reference Rate

- (i) If Screen Rate Determination is specified in the applicable Final Terms or Pricing Supplement as the manner in which a Floating Interest Rate is to be determined and SOFR is specified in the applicable Final Terms or Pricing Supplement as the Reference Rate, the Floating Interest Rate for an Interest Period will be the relevant SOFR Benchmark plus or minus (as indicated in the applicable Final Terms or Pricing Supplement) the Margin (as specified in the applicable Final Terms or Pricing Supplement), subject to a minimum of zero per cent. per annum
- (ii) The **"SOFR Benchmark"** will be determined based on SOFR Compound with Lookback, SOFR Compound with Observation Period Shift, SOFR Compound with Payment Delay or SOFR Index Average, as follows:
  - (1) if SOFR Compound with Lookback ("SOFR Compound with Lookback") is specified as applicable in the relevant Final Terms or Pricing Supplement, the SOFR Benchmark for each Interest Period shall be equal to the rate of return of a daily compound SOFR interest investment calculated in accordance with the following formula (with the resulting percentage rounded, if necessary, to the nearest one hundred-thousandth of a percentage point, with 0.000005 being rounded upwards to 0.00001):

$$\left[ \prod_{i=1}^{d_0} \left( 1 + \frac{SOFR_{i-xUSBD} \times n_i}{360} \right) - 1 \right] x \frac{360}{d}$$

where:

"d" means the number of calendar days in the relevant Interest Period;

"do", for any Interest Period, means the number of U.S. Government Securities Business Days in the relevant Interest Period;

"i" is a series of whole numbers from one to d<sub>0</sub>, each representing the relevant U.S. Government Securities Business Days in chronological order from, and including, the first U.S. Government Securities Business Day in the relevant Interest Period;

"Lookback Days" means the number of U.S. Government Securities Business Days specified in the relevant Final Terms or Pricing Supplement;

"n<sub>i</sub>" for any U.S. Government Securities Business Day "i" in the relevant Interest Period, means the number of calendar days from, and including, such day "i" up to, but excluding, the following U.S. Government Securities Business Day ("i+1");

"SOFR<sub>i</sub>", for any U.S. Government Securities Business Day "i" in the relevant Interest Period, is equal to SOFR in respect of that day; and

"SOFR<sub>i-xUSBD</sub>", for any U.S. Government Securities Business Day "i" in the relevant Interest Period, is equal to SOFR in respect of the U.S. Government Securities Business Days falling a number of U.S. Government Securities Business Days prior to that day "i" equal to the number of Lookback Days;

(2) if SOFR Compound with Observation Period Shift ("SOFR Compound with Observation Period Shift") is specified as applicable in the relevant Final Terms or Pricing Supplement, the SOFR Benchmark for each Interest Period shall be equal to the rate of return of a daily compound SOFR interest investment calculated in accordance with the following formula (with the resulting percentage rounded, if necessary, to the nearest one hundred-thousandth of a percentage point, with 0.000005 being rounded upwards to 0.00001):

where:

"d" means the number of calendar days in the relevant Observation Period;

### (iii) Effect of Benchmark Transition Event

- (A) Benchmark Replacement. If the Issuer or its designee determines that a Benchmark Transition Event and its related Benchmark Replacement Date have occurred in respect of any determination of the Benchmark on any date, the Benchmark Replacement will replace the then-current Benchmark for all purposes relating to the Notes in respect of such determination on such date and all determinations on all subsequent dates.
- (B) Benchmark Replacement Conforming Changes. In connection with the implementation of a Benchmark Replacement, the Issuer or its designee will have the right to make Benchmark Replacement Conforming Changes from time to time. In no event shall the Fiscal Agent, Calculation Agent, Registrar or Transfer Agent be responsible for determining any substitute for SOFR, or for making any adjustments to any alternative benchmark or spread thereon, the business day convention, interest determination dates or any other relevant methodology for calculating any such substitute or successor benchmark. In connection with the foregoing, the Calculation Agent will be entitled to conclusively rely on any determinations made by the Issuer or its designee and will have no liability for such actions taken at the direction of the Issuer or its designee.
- (C) Decisions and Determinations. Any determination, decision or election that may be made by the Issuer or its designee pursuant to this Condition 6.8(iii) (Effect of Benchmark Transition Event), including any determination with respect to a tenor, rate or adjustment or of the occurrence or non-occurrence of an event, circumstance or date and any decision to take or refrain from taking any action or any selection, will be conclusive and binding absent manifest error, will be made in the Issuer's or its designee's sole discretion, and, notwithstanding anything to the contrary in the documentation relating to the Notes, shall become effective without consent from the holders of the Notes or any other party. None of the Fiscal Agent, the Calculation Agent, the Registrar or the Transfer Agent will have any liability for any determination made by or on behalf of the Issuer or its designee in connection with a Benchmark Transition Event or a Benchmark Replacement.

# 6.9 Provisions specific to SONIA as Reference Rate

- 6.13 *Maximum or Minimum Rate of Interest*: If any Maximum Rate of Interest or Minimum Rate of Interest is specified in the applicable Final Terms or Pricing Supplement, then the Rate of Interest shall in no event be greater than the maximum or be less than the minimum so specified.
- 6.14 *Calculation of Interest Amount*: In respect of Floating Rate Notes, the Determination Agent will, as soon as practicable after the time at which the Rate of Interest is to be determined in relation to each Interest Period, and subject as provided below, calculate the Interest Amount payable in respect of each Floating Rate Note for such Interest Period. The Interest Amount will be calculated by applying the Rate of Interest for such Interest Period to the Calculation Amount, multiplying the product by the relevant Day Count Fraction, rounding the resulting figure to the nearest sub-unit of the Specified Currency (half of any such sub-unit being rounded upwards) and multiplying such rounded figure by a fraction equal to the Specified Denomination of the relevant Note divided by the Calculation Amount. For this purpose, a "sub-unit" means, in the case of any currency other than euro, the lowest amount of such currency that is available as legal tender in the country of such currency and, in the case of euro, means one cent.

Other than where ISDA Determination is specified in the applicable Final Terms or Pricing Supplement, in the event that any rate (a "Relevant Rate") used to calculate a Rate of Interest in respect of the Floating Rate Notes is subsequently corrected by the administrator or (if none) provider of such rate (the "Administrator"), and the correction (the "Corrected Rate") is published after the original publication but no later than (a) the Correction Cut-off Time specified in the applicable Final Terms or Pricing Supplement or, if none, (b) the longer of (i) one hour after such original publication and (ii) any other period for corrections specified by the Administrator in its methodology for the Relevant Rate, then PROVIDED THAT such Corrected Rate is published on or prior to the date falling two Business Days prior to the date on which a related payment is scheduled to be made under the Notes (the "Relevant Scheduled Payment Date"), then such Corrected Rate shall be deemed to be the relevant Relevant Rate

and the Determination Agent shall use such Corrected Rate in determining any relevant amount payable in respect of the Notes. Any corrections published after the second Business Day prior to the Relevant Scheduled Payment Date shall be disregarded for the purposes of determining the relevant Relevant Rate.

- 6.15 *Publication*: The Determination Agent will cause each Rate of Interest and Interest Amount determined by it, together with the relevant Interest Payment Date, and any other amount(s) required to be determined by it together with any relevant payment date(s) to be notified to the Paying Agents and each listing authority, stock exchange and/or quotation system (if any) by which the Notes have been admitted to listing, trading and/or quotation as soon as practicable after such determination, but (in the case of each Rate of Interest, Interest Amount and Interest Payment Date) in any event not later than the first day of the relevant Interest Period. Notice thereof shall also promptly be given to the Noteholders. The Determination Agent will be entitled to recalculate any Interest Amount (on the basis of the foregoing provisions) without notice in the event of an extension or shortening of the relevant Interest Period. If the Calculation Amount is less than the minimum Specified Denomination, the Determination Agent shall not be obliged to publish each Interest Amount but instead may publish only the Calculation Amount and the Interest Amount in respect of a Note having the minimum Specified Denomination.
- Notifications etc.: All notifications, opinions, determinations, certificates, calculations, quotations and decisions given, expressed, made or obtained for the purposes of this Condition 6 (Floating Rate Note Provisions) by the Calculation Agent will (in the absence of manifest error) be binding on the Issuer, the Paying Agents, the Noteholders and (subject as aforesaid) no liability to any such Person will attach to the Calculation Agent in connection with the exercise or non-exercise by it of its powers, duties and discretions for such purposes.

# 6.17 Relevant Rates Benchmark Discontinuance or Prohibition on Use:

- If (i) Condition 6.18 (CMS Reference Rate Effect of Index Cessation Event) does not apply, (ii) the applicable Final Terms or Pricing Supplement specifies that the provisions of this Condition 6.17 (Relevant Rates Benchmark Discontinuance or Prohibition on Use) are applicable and (iii) unless otherwise specified in the applicable Final Terms or Pricing Supplement, where ISDA Determination is specified in the applicable Final Terms or Pricing Supplement as the manner in which the Floating Interest Rate is to be determined, after application of any ISDA Bespoke Fallbacks specified in the relevant Floating Rate Option (as defined in the ISDA Definitions) to apply following the occurrence of any of the following events and the application of such ISDA Bespoke Fallbacks fails to provide a means of determining the relevant Floating Rate (as defined in the ISDA Definitions), then notwithstanding the terms set forth elsewhere in these Conditions, if the Determination Agent determines that any of the following events has occurred:
- (a) a public statement or publication of information by or on behalf of the administrator of the Relevant Rates Benchmark announcing that it has ceased or will cease to provide the Relevant Rates Benchmark permanently or indefinitely, provided that, at the time of statement or publication, there is no successor administrator that will continue to provide the Relevant Rates Benchmark; or
- (b) a public statement or publication of information by the regulatory supervisor for the administrator of the Relevant Rates Benchmark, the central bank for the currency of the Relevant Rates Benchmark, an insolvency official with jurisdiction over the administrator of the Relevant Rates Benchmark, a resolution authority with jurisdiction over the administrator of the Relevant Rates Benchmark or a court or an entity with similar insolvency or resolution authority over the administrator of the Relevant Rates Benchmark, which states that the administrator of the Relevant Rates Benchmark has ceased or will cease to provide the Relevant Rates Benchmark permanently or indefinitely, provided that, at the time of the statement or publication, there is no successor administrator that will continue to provide the Relevant Rates Benchmark; or
- (c) unless otherwise specified in the Final Terms or Pricing Supplement, an Administrator/Benchmark Event occurs in relation to a Relevant Rates Benchmark,

then the Determination Agent may use, as a substitute for the Relevant Rates Benchmark, and for each future Interest Determination Date (or other rate fixing date), the alternative rates benchmark determined in accordance with the following provisions:

- (i) if an alternative reference rate, index or benchmark is specified in the Final Terms or Pricing Supplement for this purpose (an "Alternative Pre-nominated Reference Rate"), such Alternative Pre-nominated Reference Rate; or
- (ii) if an Alternative Pre-nominated Reference Rate is not specified in the Final Terms or Pricing Supplement, the alternative reference rate, index or benchmark selected by the central bank, reserve bank, monetary authority or any similar institution (including any committee or working group thereof) in the jurisdiction of the applicable index currency that is consistent with accepted market practice (the rate determined under sub-paragraph (i) above or this sub-paragraph (ii), the "Alternative Rate").

The Determination Agent may, after consultation with the Issuer, determine any adjustments to the Alternative Rate or the Margin (which may include the addition of an adjustment spread, which may be positive or negative, in order to reduce or eliminate, to the extent reasonably practicable, any transfer of economic value to or from the Issuer as a result of the replacement of the Relevant Rates Benchmark with the Alternative Rate), as well as the applicable Business Day Convention, Interest Determination Dates (or any other rate fixing dates) and related provisions and definitions of the Notes, in each case that are consistent with accepted market practice for the use of such Alternative Rate for debt obligations such as the Notes.

If the Determination Agent determines, after consultation with the Issuer, that no such Alternative Rate exists on the relevant date, it may, after consultation with the Issuer, determine an alternative rate to be used as a substitute for the Relevant Rates Benchmark (which shall be the "Alternative Rate" for the purposes of these provisions), as well as any adjustments to the Margin (including any adjustment spread), the Business Day Convention, the Interest Determination Dates (or any other rate fixing dates) and related provisions and definitions in respect of the Notes, in each case, that are consistent with accepted market practice for the use of such Alternative Rate for debt obligations such as the Notes.

The Issuer will then provide a notice, in accordance with Condition 19 (Notices), to Noteholders to inform them of the occurrence of any of the events listed in Conditions 6.17(a) to 6.17(d) (*Relevant Rates Benchmark Discontinuance or Prohibition of Use*) above, the Alternative Rate and any adjustment determinations which will apply to the Notes. The notice shall also confirm the effective date of the Alternative Rate and any adjustments.

Notwithstanding anything else in this Condition 6.17 (*Relevant Rates Benchmark Discontinuance or Prohibition of Use*), if the Determination Agent determines that the selection of a particular index, benchmark or other price as an "Alternative Rate" (taking into account any necessary adjustments that would need to be made in accordance with this Condition 6.17 (*Relevant Rates Benchmark Discontinuance or Prohibition of Use*)) (1) is or would be unlawful under any applicable law or regulation; or (2) would contravene any applicable licensing requirements; or (3) would result in the Determination Agent, the Issuer or the Calculation Agent being considered to be administering a benchmark, index or other price source whose production, publication, methodology or governance would subject the Determination Agent, the Issuer or the Calculation Agent to material additional regulatory obligations which it is unwilling to undertake, then the Determination Agent shall not select such index, benchmark or price source as the Alternative Rate).

If the Determination Agent is unable to identify an Alternative Rate and determine the necessary adjustments to the terms of the Notes, then the Issuer may, in its reasonable discretion, determine that the Notes shall be redeemed as of any later date. If the Issuer so determines that the Notes shall be redeemed, then the Issuer shall give not less than five Business Days' notice to the Noteholders to redeem the Notes and upon redemption the Issuer will pay in respect of each Note an amount equal to the Early Redemption Amount.

1. if "Fixed Redemption (Benchmark Trigger Event) (Accrued)" is specified in the applicable Final Terms or Pricing Supplement, an amount per Calculation Amount (expressed

as a percentage) as specified in the applicable Final Terms or Pricing Supplement, together with accrued interest (if any);

- 2. if "Fixed Redemption (Benchmark Trigger Event) (Unaccrued)" is specified in the applicable Final Terms or Pricing Supplement, an amount per Calculation Amount (expressed as a percentage) as specified in the applicable Final Terms or Pricing Supplement, excluding any interest;
- 3. if "Fixed Redemption (Benchmark Trigger Event) Less Costs (Accrued)" is specified in the applicable Final Terms or Pricing Supplement, an amount per Calculation Amount (expressed as a percentage) as specified in the applicable Final Terms or Pricing Supplement less the reasonable cost to and/or the loss realised by, the Issuer and/or any Affiliate in respect of break funding costs for the Issuer term financing associated with such early redemption of the Notes, in each case as calculated by the Determination Agent in its reasonable discretion, together with accrued interest (if any); or
- 4. if "Fixed Redemption (Benchmark Trigger Event) Less Costs (Unaccrued)" is specified in the applicable Final Terms or Pricing Supplement, an amount per Calculation Amount (expressed as a percentage) as specified in the applicable Final Terms or Pricing Supplement less the reasonable cost to and/or the loss realised by, the Issuer and/or any Affiliate in respect of break funding costs for the Issuer term financing associated with such early redemption of the Notes, in each case as calculated by the Determination Agent in its reasonable discretion, excluding any interest;
- 5. if "Fair Market Value (Benchmark Trigger Event)" is specified in the applicable Final Terms or Pricing Supplement, an amount equal to the fair market value of such Note, on such day as is selected by the Determination Agent in its reasonable discretion (provided that such day is not more than 15 days before the date fixed for redemption of the Note; or
- 6. if "Fair Market Value (Benchmark Trigger Event) Less Costs" is specified in the applicable Final Terms or Pricing Supplement, an amount equal to the fair market value of such Note, on such day as is selected by the Determination Agent in its reasonable discretion (provided that such day is not more than 15 days before the date fixed for redemption of the Note), less the proportion attributable to that Note of the reasonable cost to the Issuer and/or any Affiliate of, or the loss realised by the Issuer and/or any Affiliate on, unwinding any related hedging arrangements or in respect of break funding costs for the Issuer's term financing associated with such early redemption of the Notes, in each case as calculated by the Determination Agent in its reasonable discretion.

The Issuer's obligations under the Notes shall be satisfied in full upon payment of such amount.

In the case where ISDA Determination is specified in the applicable Final Terms or Pricing Supplement as the manner in which the Floating Interest Rate is to be determined, and the application of any ISDA Bespoke Fallbacks specified in the relevant Floating Rate Option results in a replacement of, modification to, or change in the method of calculating, the Floating Rate (or the index, benchmark or other price source that is referred to in the Floating Rate Option), the Determination Agent may, after consultation with the Issuer, determine any adjustments to the Floating Rate and the Margin (including any adjustment spread) as well as the applicable Business Day Convention, Interest Determination Dates (or any other rate fixing dates) and related provisions and definitions of the Notes, in each case that are consistent with accepted market practice for the use of such replacement or modified Floating Rate for debt obligations such as the Notes. The Issuer will provide a notice, in accordance with Condition 19 (*Notices*), to Noteholders to inform them of any adjustment determinations which will apply to the Notes. The notice shall also confirm the effective date of any adjustments.

# 6.18 CMS Reference Rate – Effect of Index Cessation Event

This Condition 6.18 (*CMS Reference Rate - Effect of Index Cessation Event*) applies where (i) the Relevant Rates Benchmark is a CMS Reference Rate and (ii) the applicable Final Terms or Pricing Supplement specifies that the provisions of this Condition 6.18 (*CMS Reference Rate – Effect of Index Cessation Event*) are applicable.

(a) *Index Cessation.* If, as of an Interest Determination Date or any other relevant day on which a CMS Reference Rate is to be determined, an Index Cessation Effective Date with respect to the

applicable tenor of the then-current CMS Reference Rate has occurred, then the CMS Reference Rate in respect of such Interest Determination Date or other relevant day (as applicable) and each subsequent Interest Determination Date or other relevant day (as applicable) shall be the sum of (i) the Benchmark Replacement; and (ii) any adjustment spread (which may be a positive or negative value or zero), in each case determined on that Interest Determination Date or other relevant day (as applicable) by the Determination Agent acting in good faith and in a commercially reasonable manner. Following the occurrence of an Index Cessation Effective Date in respect of one or more Index Cessation Events, the determination of the Benchmark Replacement and any adjustment spread will be a one-time process and will apply to each following Interest Determination Date or other relevant day (as applicable).

- (b) Early Redemption: If the implementation of any Benchmark Replacement or Benchmark Replacement Conforming Changes results in a calculation of the CMS Reference Rate that is not consistent with market practice as determined by the Determination Agent, the Issuer may, in its reasonable discretion, determine that the Notes shall be redeemed as of any later date. If the Issuer so determines that the Notes shall be redeemed, then the Issuer shall give not less than five Business Days' notice to the Noteholders to redeem the Notes and upon redemption the Issuer will pay in respect of each Note an amount equal to:
  - (i) if "Early Redemption Amount (CMS Reference Rate) Fixed Redemption (Accrued)" is specified in the applicable Final Terms or Pricing Supplement, an amount per Calculation Amount (expressed as a percentage) as specified in the applicable Final Terms or Pricing Supplement, together with accrued interest (if any);
  - (ii) if "Early Redemption Amount (CMS Reference Rate) Fixed Redemption (Unaccrued)" is specified in the applicable Final Terms or Pricing Supplement, an amount per Calculation Amount (expressed as a percentage) as specified in the applicable Final Terms or Pricing Supplement, excluding any interest;
  - (iii) if "Early Redemption Amount (CMS Reference Rate) Fixed Redemption Less Costs (Accrued)" is specified in the applicable Final Terms or Pricing Supplement, an amount per Calculation Amount (expressed as a percentage) as specified in the applicable Final Terms or Pricing Supplement less the reasonable cost to and/or the loss realised by, the Issuer and/or any Affiliate on unwinding any related hedging arrangements, in each case as calculated by the Determination Agent in its reasonable discretion, together with accrued interest (if any);
  - (iv) if "Early Redemption Amount (CMS Reference Rate) Fixed Redemption Less Costs (Unaccrued)" is specified in the applicable Final Terms or Pricing Supplement, an amount per Calculation Amount (expressed as a percentage) as specified in the applicable Final Terms or Pricing Supplement less the reasonable cost to and/or the loss realised by, the Issuer and/or any Affiliate on unwinding any related hedging arrangements, in each case as calculated by the Determination Agent in its reasonable discretion, excluding any interest;
  - (v) if "Early Redemption Amount (CMS Reference Rate) Fair Market Value Less Costs" is specified in the applicable Final Terms or Pricing Supplement, an amount equal to the fair market value of such Note, on such day as is selected by the Determination Agent in its reasonable discretion (provided that such day is not more than 15 days before the date fixed for redemption of the Note), less the proportion attributable to that Note of the reasonable cost to the Issuer and/or any Affiliate of, or the loss realised by the Issuer and/or any Affiliate on, unwinding any related hedging arrangements, in each case as calculated by the Determination Agent in its reasonable discretion; or
  - (vi) if "Early Redemption Amount (CMS Reference Rate) Fair Market Value" is specified in the applicable Final Terms or Pricing Supplement, the fair market value of such Note, on such day as is selected by the Determination Agent in its reasonable discretion (provided that such day is not more than 15 days before the date fixed for redemption of the Note), as calculated by the Determination Agent in its reasonable discretion.

The Issuer's obligation under the Notes shall be satisfied in full upon payment of such amount.

- (c) Decisions and Determinations. Any determination, decision, selection or election that may be made by the Issuer, the Determination Agent or their respective designees, pursuant to this Condition 6.18 (CMS Reference Rate Effect of Index Cessation Event), including any determination with respect to a tenor, rate, spread or adjustment or of the occurrence or non-occurrence of an event, circumstance or date and any decision to take or refrain from taking any action or any determination, decision, selection or election:
  - (i) will be conclusive and binding absent manifest error;
  - (ii) will be made in such person's sole discretion; and
  - (iii) notwithstanding anything to the contrary in the documentation relating to the Notes, shall become effective without consent from the holders of the Notes or any other party.
- (d) For the purposes of this Condition 6.18 (*CMS Reference Rate Effect of Index Cessation Event*), the following terms shall bear the following meanings:
  - "Benchmark Replacement" means the first alternative benchmark set forth in the order below that can be determined by the Determination Agent as of the Interest Determination Date or other relevant day on which a CMS Reference Rate is to be determined, in each case next succeeding the relevant Index Cessation Effective Date (or, if the Index Cessation Effective Date occurs on the Interest Determination Date or other relevant day, that Interest Determination Date or other relevant day (as applicable)):
  - (i) if an alternative reference rate, index or benchmark is specified in the applicable Final Terms or Pricing Supplement for this purpose (an "Alternative Pre-nominated Reference Rate"), such Alternative Pre-nominated Reference Rate;
  - (ii) the alternate rate of interest that has been selected or recommended by the relevant governmental body or agency with jurisdiction over the then-current CMS Reference Rate or the administrator thereof as the replacement for the then-current CMS Reference Rate for the applicable index maturity; or
  - (iii) the alternate rate of interest that has been selected by the Determination Agent as the replacement for the then-current CMS Reference Rate for the applicable index maturity giving due consideration to any industry-accepted rate of interest as a replacement for the then-current CMS Reference Rate for floating rate notes denominated in the Index Currency at such time, including any alternate rate of interest recommended by the International Swaps and Derivatives Association, Inc. or any successor thereto.

In connection with the implementation of a Benchmark Replacement, the Determination Agent or its designee will have the right to make Benchmark Replacement Conforming Changes from time to time.

"Benchmark Replacement Conforming Changes" means, with respect to any Benchmark Replacement, any changes (including changes to the definition of "Interest Period", the timing and frequency of determining rates and making payments of interest, and other administrative matters) that the Determination Agent or its designee determines may be appropriate to reflect the adoption of such Benchmark Replacement in a manner substantially consistent with market practice (or, if the Determination Agent or its designee determines that adoption of any portion of such market practice is not administratively feasible or if the Determination Agent or its designee determines that no market practice for use of the Benchmark Replacement exists, in such other manner as the Determination Agent or its designee determines is reasonably necessary).

"CMS Reference Rate" means, initially, the CMS Reference Rate specified in the applicable Final Terms or Pricing Supplement; provided that if an Index Cessation Effective Date has occurred with respect to such rate or the then-current CMS Reference Rate, then "CMS Reference Rate" means the applicable Benchmark Replacement. For the avoidance of doubt,

such Benchmark Replacement will replace the then-current CMS Reference Rate for all purposes relating to the Notes.

"Index Cessation Effective Date" means, in respect of the then-current CMS Reference Rate and one or more Index Cessation Events, the first date on which the CMS Reference Rate would ordinarily have been published or provided and is no longer published or provided. If the CMS Reference Rate ceases to be provided on an Interest Determination Date or other relevant day, but it was provided at the time at which it is to be observed pursuant to these Conditions, then the Index Cessation Effective Date will be the next day on which the rate would ordinarily have been published or provided.

"Index Cessation Event" means, in respect of the then-current CMS Reference Rate:

- (i) a public statement or publication of information by or on behalf of the administrator of the CMS Reference Rate announcing that it has ceased or will cease to provide the CMS Reference Rate permanently or indefinitely; provided that, at the time of the statement or publication, there is no successor administrator or provider, as applicable, that will continue to provide the CMS Reference Rate:
- (ii) a public statement or publication of information by the regulatory supervisor for the administrator of the CMS Reference Rate, the central bank for the currency of the CMS Reference Rate, an insolvency official with jurisdiction over the administrator for the CMS Reference Rate, a resolution authority with jurisdiction over the administrator for the CMS Reference Rate or a court or an entity with similar insolvency or resolution authority over the administrator for the CMS Reference Rate, which states that the administrator of the CMS Reference Rate has ceased or will cease to provide the CMS Reference Rate permanently or indefinitely; provided that, at the time of the statement or publication, there is no successor administrator or provider that will continue to provide the CMS Reference Rate; or
- (iii) unless otherwise specified in the applicable Final Terms or Pricing Supplement, an Administrator/Benchmark Event occurs with respect to the CMS Reference Rate (with the CMS Reference Rate being the Relevant Rates Benchmark for the purpose of the definition of "Administrator/Benchmark Event").

"Index Currency" means the currency in respect of which the relevant CMS Reference Rate is calculated or expressed, as determined by the Determination Agent.

- (e) Application to multiple CMS Reference Rates: If either:
  - (i) the CMS Interest Rate is specified in the applicable Final Terms or Pricing Supplement to be "Spread CMS Rate"; or
  - (ii) the Notes otherwise reference more than one CMS Reference Rate,

the foregoing provisions of this Condition 6.18 (CMS Reference Rate - Effect of Index Cessation Event) shall apply separately for each CMS Reference Rate so referenced (including each of CMS Reference Rate 1 and CMS Reference Rate 2 in the case where the CMS Interest Rate is a "Spread CMS Rate") and for the purpose of construing such provisions, each of CMS Reference Rate 1 and CMS Reference Rate 2 shall be the "CMS Reference Rate". However, if an Index Cessation Effective Date has occurred in respect of one or more CMS Reference Rate(s) (the "Impacted CMS Reference Rate(s)") but not all of the CMS Reference Rate(s) referenced by the Notes (the "Non-Impacted CMS Reference Rate(s)"), the Issuer or its designee may elect to treat each of the Non-Impacted CMS Reference Rate(s) as if an Index Cessation Effective Date had occurred in respect of such Non-Impacted CMS Reference Rate and apply the foregoing provisions accordingly.

### 6.19 General Fallback Arrangements

The following provisions of this Condition 6.19 (*General Fallback Arrangements*) shall apply where:

- (i) the Relevant Rates Benchmark is EURIBOR, SONIA, €STR, SARON or TONA;
- (ii) such Relevant Rates Benchmark has been permanently discontinued;
- (iii) the applicable Final Terms or Pricing Supplement specify that the provisions of Condition 6.17 (*Relevant Rates Benchmark Discontinuance or Prohibition of Use*) do not apply; and
- (iv) unless otherwise specified in the applicable Final Terms or Pricing Supplement, where ISDA Determination is specified in the applicable Final Terms or Pricing Supplement as the manner in which the Floating Interest Rate is to be determined, application of any ISDA Bespoke Fallbacks specified in the relevant Floating Rate Option (as defined in the ISDA Definitions) following the permanent discontinuation of the Relevant Rates Benchmark fails to provide a means of determining the relevant Floating Rate (as defined in the ISDA Definitions).

If this Condition 6.19 (General Fallback Arrangements) applies, then notwithstanding the terms set forth elsewhere in these Conditions; the Determination Agent will use, as a substitute for such Relevant Rates Benchmark, and for each future Interest Determination Date, the alternative reference rate selected by the central bank, reserve bank, monetary authority or any similar institution (including any committee or working group thereof) in the jurisdiction of the applicable index currency that is consistent with accepted market practice (the "Alternative Rate"). The Determination Agent will, after consultation with the Issuer, make such adjustments to the Alternative Rate or the Margin (or Margin 1 or Margin 2, as applicable), as well as the applicable Business Day Convention, Interest Determination Dates and related provisions and definitions of the Notes, in each case that are consistent with accepted market practice for the use of such Alternative Rate for debt obligations such as the Notes. However, in the case of EURIBOR only, if the Determination Agent determines, after consultation with the Issuer, that no such Alternative Rate exists on the relevant date, it shall make a determination, after consultation with the Issuer, of an alternative rate as a substitute for EURIBOR, for debt obligations such as the Notes, as well as the Margin, the Business Day Convention and the Interest Determination Dates in respect of the Notes, that is consistent with accepted market practice.

In the case where ISDA Determination is specified in the applicable Final Terms or Pricing Supplement as the manner in which the Floating Interest Rate is to be determined, and the application of any ISDA Bespoke Fallbacks specified in the relevant Floating Rate Option results in a replacement of, modification to, or change in the method of calculating, the Floating Rate (or the index, benchmark or other price source that is referred to in the Floating Rate Option), the Determination Agent may, after consultation with the Issuer, determine any adjustments to the Floating Rate and the Margin (or Margin 1 or Margin 2, as applicable), (including any adjustment spread) as well as the applicable Business Day Convention, Interest Determination Dates (or any other rate fixing dates) and related provisions and definitions of the Notes, in each case that are consistent with accepted market practice for the use of such replacement or modified Floating Rate for debt obligations such as the Notes. The Issuer will provide a notice, in accordance with Condition 19 (*Notices*), to Noteholders to inform them of any adjustment determinations which will apply to the Notes. The notice shall also confirm the effective date of any adjustments.

### 7. ZERO COUPON NOTE PROVISIONS

- 7.1 **Application**: This Condition 7 (Zero Coupon Note Provisions) is applicable to the Notes only if the Zero Coupon Note Provisions are specified in the applicable Final Terms or Pricing Supplement as being applicable.
- 7.2 *Late Payment on Zero Coupon Notes*: If the Redemption Amount payable in respect of any Zero Coupon Note remains unpaid when due and payable, the Redemption Amount in respect

of each Note shall thereafter be an amount equal to the product of (a) the Calculation Amount of such Note and (b) the percentage produced by:

(a) if Compounded Zero Coupon is specified as applicable in the applicable Final Terms or Pricing Supplement, the following formula:

Reference Price × (1+Accrual Yield)<sup>n</sup>

(b) if Linear Zero Coupon is specified as applicable in the applicable Final Terms or Pricing Supplement, the following formula:

Reference Price × n × Accrual Yield

where "n" means the number of years from (and including) the Issue Date (or such other date as may be specified in the applicable Final Terms or Pricing Supplement as the "Accrued Value Commencement Date") to (but excluding) the day on which all such sums due in respect of such Note have been paid or duly made available for payment and the calculation shall be made on the basis of such Day Count Fraction as may be specified in the applicable Final Terms or Pricing Supplement or, if none is so specified, a Day Count Fraction of 30/360.

# 8. INFLATION-LINKED NOTE PROVISIONS

The Issuer may issue Notes the payment of interest, or the repayment or payment of principal, in respect of which is linked to an inflation index ("Inflation-Linked Notes") in accordance with these Conditions which are specified as being applicable in the applicable Final Terms or Pricing Supplement, in accordance with the elections made in the applicable Final Terms or Pricing Supplement.

This Condition 8 (*Inflation-Linked Note Provisions*) is applicable only in relation to Notes specified in the applicable Final Terms or Pricing Supplement as being Inflation-Linked Notes.

- 8.1 **Delay of Publication**: If any level of an Inflation Index for a Reference Month which is relevant to the calculation of a payment under the Notes (a "Relevant Level") has not been published or announced by the Inflation Determination Date, the Determination Agent shall determine a Substitute Inflation Index Level (in place of such Relevant Level) by using the following methodology:
  - (a) if applicable, the Determination Agent will take the same action to determine the Substitute Inflation Index Level in respect of the relevant Inflation Determination Date as that taken by the calculation agent pursuant to the terms and conditions of the Related Bond;
  - (b) if (i) above does not result in a Substitute Inflation Index Level in respect of such Inflation Determination Date for any reason, then the Determination Agent shall determine the Substitute Inflation Index Level in a commercial reasonable manner in its reasonable discretion.

If a Relevant Level is published or announced at any time after the Inflation Determination Date, such Relevant Level will not be used in any calculations. The Substitute Inflation Index Level so determined pursuant to this Condition 8.1 (*Delay of Publication*), will be the definitive level for that Reference Month.

- 8.2 *Cessation of Publication*: If a level for the Inflation Index has not been published or announced for two consecutive months or the Inflation Index Sponsor announces that it will no longer continue to publish or announce the Inflation Index, then the Determination Agent shall determine a Successor Inflation Index (in lieu of any previously applicable Inflation Index) for the purposes of the Notes by using the following methodology:
  - if at any time a Successor Inflation Index has been designated by the Calculation Agent pursuant to the terms and conditions of the Related Bond, such Successor Inflation Index shall be designated a "Successor Inflation Index" for the purposes of all subsequent specified Interest Payment Dates or other relevant payment date as may be specified in the applicable Final Terms or Pricing Supplement in relation to the Notes, notwithstanding that any other Successor Inflation Index may previously have been determined under Condition 8.2(b), 8.2(c) or 8.2(d) (Cessation of Publication);

- (b) if a Successor Inflation Index has not been determined under Condition 8.2(a) (Cessation of Publication) and a notice has been given or an announcement has been made by the Inflation Index Sponsor, specifying that the Inflation Index will be superseded by a replacement index specified by the Inflation Index Sponsor, and the Determination Agent determines that such replacement index is calculated using the same or substantially similar formula or method of calculation as used in the calculation of the previously applicable Inflation Index, such replacement index shall be the Inflation Index for purposes of the Notes from the date that such replacement index comes into effect;
- (c) if a Successor Inflation Index has not been determined under Condition 8.2(a) or 8.2(b) (Cessation of Publication), the Determination Agent shall ask five leading independent dealers to state what the replacement Inflation Index for the Inflation Index should be. If between four and five responses are received, and of those four or five responses, three or more leading independent dealers state the same Inflation Index, this Inflation Index will be deemed the "Successor Inflation Index". If three responses are received, and two or more leading independent dealers state the same Inflation Index, this Inflation Index will be deemed the "Successor Inflation Index". If fewer than three responses are received, the Determination Agent will proceed to Condition 8.2(d) (Cessation of Publication);
- (d) if no Successor Inflation Index has been determined under Condition 8.2(a), 8.2(b) or 8.2(c) (*Cessation of Publication*) by the next Inflation Determination Date, the Determination Agent will determine an appropriate alternative index, and such index will be deemed a "Successor Inflation Index"; or
- (e) If the Determination Agent determines that there is no appropriate alternative index, the Issuer shall give not less than five Inflation Business Days' notice to redeem the Notes and the Issuer's obligations under the Notes shall be satisfied in full upon payment in respect of each Note of:
  - (1) if "Fixed Redemption (Inflation Index Cessation) (Accrued)" is specified in the applicable Final Terms or Pricing Supplement, an amount per Calculation Amount (expressed as a percentage) as specified in the applicable Final Terms or Pricing Supplement, together with accrued interest (if any);
  - (2) if "Fixed Redemption (Inflation Index Cessation) (Unaccrued)" is specified in the applicable Final Terms or Pricing Supplement, an amount per Calculation Amount (expressed as a percentage) as specified in the applicable Final Terms or Pricing Supplement, excluding any interest;
  - if "Fixed Redemption (Inflation Index Cessation) Less Costs (Accrued)" is specified in the applicable Final Terms or Pricing Supplement, an amount per Calculation Amount (expressed as a percentage) as specified in the applicable Final Terms or Pricing Supplement less the reasonable cost to and/or the loss realised by, the Issuer and/or any Affiliate in respect of break funding costs for the Issuer term financing associated with such early redemption of the Notes, in each case as calculated by the Determination Agent in its reasonable discretion, together with accrued interest (if any);
  - (4) if "Fixed Redemption (Inflation Index Cessation) Less Costs (Unaccrued)" is specified in the applicable Final Terms or Pricing Supplement, an amount per Calculation Amount (expressed as a percentage) as specified in the applicable Final Terms or Pricing Supplement less the reasonable cost to and/or the loss realised by, the Issuer and/or any Affiliate in respect of break funding costs for the Issuer term financing associated with such early redemption of the Notes, in each case as calculated by the Determination Agent in its reasonable discretion, excluding any interest;
  - (5) if "Fair Market Value (Inflation Index Cessation)" is specified in the applicable Final Terms or Pricing Supplement, an amount equal to the fair market value of such Note, on such day as is selected by the Determination Agent in its reasonable discretion (provided that such day is not more than 15 days before the date fixed for redemption of the Note); or

- if "Fair Market Value (Inflation Index Cessation) Less Costs" is specified in the applicable Final Terms or Pricing Supplement, an amount equal to the fair market value of such Note, on such day as is selected by the Determination Agent in its reasonable discretion (provided that such day is not more than 15 days before the date fixed for redemption of the Note), less the proportion attributable to that Note of the reasonable cost to the Issuer and/or any Affiliate of, or the loss realised by the Issuer and/or any Affiliate on, unwinding any related hedging arrangements or in respect of break funding costs for the Issuer's term financing associated with such early redemption of the Notes, in each case as calculated by the Determination Agent in its reasonable discretion.
- 8.3 **Rebasing of the Inflation Index**: If the Determination Agent determines that an Inflation Index has been or will be rebased at any time, the Inflation Index as so rebased (the "**Rebased Inflation Index**") will be used for purposes of determining the level of such Inflation Index from the date of such rebasing; provided, however, that the Determination Agent shall make such adjustments as are made by the Calculation Agent pursuant to the terms and conditions of the Related Bond, if any, to the levels of the Rebased Inflation Index so that the Rebased Inflation Index levels reflect the same rate of inflation as the Inflation Index before it was rebased. If there is no Related Bond, the Determination Agent shall make adjustments to the levels of the Rebased Inflation Index so that the Rebased Inflation Index levels reflect the same rate of inflation as the Inflation Index before it was rebased. Any such rebasing shall not affect any prior payments made under the Notes.
- 8.4 **Material Modification Prior to Payment Date**: If, on or prior to the Inflation Determination Date, an Inflation Index Sponsor announces that it will make a material change to an Inflation Index, then the Determination Agent shall make any such adjustments to the Inflation Index consistent with adjustments made to the Related Bond, or, if there is no Related Bond, only those adjustments necessary for the modified Inflation Index to continue as the Inflation Index.
- 8.5 Manifest Error in Publication: If, within 30 days of publication and prior to any relevant Interest Payment Date or other relevant payment date in relation to the Notes, the Determination Agent determines that the Inflation Index Sponsor has corrected the level of the Inflation Index to remedy a manifest error in its original publication, the Determination Agent will notify the holders of the Notes in accordance with Condition 19 (Notices) of (a) that correction, (b) the adjusted amount that is then payable under the Notes as a result of that correction and (c) take such other action as it may deem necessary to give effect to such correction, provided that any amount payable pursuant to (b) above shall be paid (with no interest accruing thereon) (i) in connection with an Inflation Index Sponsor's correction to remedy a manifest error in the level of an Inflation Index for a Reference Month for which such Interest Payment Date or other relevant payment date in relation to the Notes has occurred, within five Inflation Business Days after notice of such amount payable by the Determination Agent, (ii) in connection with an Inflation Index Sponsor's correction to remedy a manifest error in the level of an Inflation Index for a Reference Month for which such Interest Payment Date, or other relevant payment date in relation to the Notes has not occurred, as an adjustment to the payment obligation on the next specified Interest Payment Date or (iii) if there is no further Interest Payment Date or other relevant payment date in relation to the Notes, within five Inflation Business Days after notice of such amount payable by the Determination Agent.
- 8.6 *Index Level Adjustment Correction*: In relation to any Inflation Index, as specified in the Final Terms or Pricing Supplement, either: (a) the first publication or announcement of the level of the Inflation Index (disregarding estimates) by the relevant Inflation Index Sponsor for any Reference Month shall be final and conclusive and, subject to this Condition 8 (*Inflation-Linked Note Provisions*), later revisions to the level of the Inflation Index for such Reference Month will not be used in any calculations; or (b) the first publication or announcement of a level of the Inflation Index (disregarding estimates) published by the relevant Inflation Index Sponsor or, if revised, any subsequent revision of such level for a Reference Month shall be final and conclusive for such Reference Month, provided that such revisions are published or announced up to and including the day that is two Business Days prior to any relevant Interest Payment Date, Maturity Date or any other payment in respect of the Notes. The Issuer shall give notice to holders of Inflation-Linked Notes of any valid revision in accordance with Condition 19 (*Notices*).

### 8.7 Inflation-Linked Rates of Interest

If the Notes are specified in the applicable Final Terms or Pricing Supplement as Inflation-Linked Notes and the applicable Final Terms or Pricing Supplement specify:

(a) "Leveraged Inflation Coupon", the Issuer shall, on each Interest Payment Date, pay interest on the Notes in an amount (which may be zero) per Calculation Amount determined by the Determination Agent in accordance with the following formula:

provided that, if the applicable Final Terms or Pricing Supplement specify:

- (ii) an Interest Floor, the amount calculated in accordance with the above formula shall not be less than the Interest Floor; or
- (iii) an Interest Cap and an Interest Floor, the amount calculated in accordance with the above formula shall not exceed the Interest Cap and shall not be less than the Interest Floor.
- (b) "Real Inflation Coupon", the Issuer shall, on each Interest Payment Date, pay interest on the Notes in an amount (which may be zero) per Calculation Amount determined by the Determination Agent in accordance with the following formula:

provided that, if the applicable Final Terms or Pricing Supplement specify:

- (i) an Interest Cap, the amount calculated in accordance with the above formula shall not exceed the Interest Cap;
- (ii) an Interest Floor, the amount calculated in accordance with the above formula shall not be less than the Interest Floor; or
- (iii) an Interest Cap and an Interest Floor, the amount calculated in accordance with the above formula shall not exceed the Interest Cap and shall not be less than the Interest Floor.
- (c) "Cumulative Inflation Coupon", the Issuer shall, on each Interest Payment Date, pay interest on the Notes in an amount (which may be zero) per Calculation Amount determined by the Determination Agent in accordance with the following formula:

provided that, if the applicable Final Terms or Pricing Supplement specify:

- (i) an Interest Cap, the amount calculated in accordance with the above formula shall not exceed the Interest Cap;
- (ii) an Interest Floor, the amount calculated in accordance with the above formula shall not be less than the Interest Floor; or
- (iii) an Interest Cap and an Interest Floor, the amount calculated in accordance with the above formula shall not exceed the Interest Cap and shall not be less than the Interest Floor.
- (d) "Interpolated Inflation Linked Coupon", the Issuer shall on each Interest Payment Date, pay interest on the Notes in an amount (which may be zero) per Calculation Amount determined by the Determination Agent in accordance with the following formula:

where:

- (i) "Inflation Index (End) " means, in respect of an Interest Period, the DIR Index Level in respect of the Interest Period End Date falling at the end of such Interest Period, as determined by the Determination Agent; and
- (ii) "Inflation Index (Start)" means, the DIR Index Level in respect of the Issue Date, as specified in the applicable Final Terms or Pricing Supplement.
- 8.8 Calculation of Interest Amount: In respect of Inflation-Linked Notes, the Determination Agent will, as soon as practicable after the time at which the Rate of Interest is to be determined in relation to each Interest Period, calculate the Interest Amount payable in respect of each Inflation-Linked Note for such Interest Period. The Interest Amount will be calculated by the Determination Agent in accordance with the formula set out above, rounding the resulting figure to the nearest sub-unit of the Specified Currency (half of any such sub-unit being rounded upwards) and multiplying such rounded figure by a fraction equal to the Specified Denomination of the relevant Note divided by the Calculation Amount. For this purpose, a "sub-unit" means, in the case of any currency other than euro, the lowest amount of such currency that is available as legal tender in the country of such currency and, in the case of euro, means one cent.
- 8.9 **Publication**: The Determination Agent will cause each Rate of Interest and Interest Amount determined by it, together with the relevant Interest Payment Date, and any other amount(s) required to be determined by it together with any relevant payment date(s) to be notified to the Paying Agents and each listing authority, stock exchange and/or quotation system (if any) by which the Notes have been admitted to listing, trading and/or quotation as soon as practicable after such determination, but (in the case of each Rate of Interest, Interest Amount and Interest Payment Date) in any event not later than the first day of the relevant Interest Period. Notice thereof shall also promptly be given to the Noteholders. The Determination Agent will be entitled to recalculate any Interest Amount (on the basis of the foregoing provisions) without notice in the event of an extension or shortening of the relevant Interest Period. If the Calculation Amount is less than the minimum Specified Denomination, the Determination Agent shall not be obliged to publish each Interest Amount but instead may publish only the Calculation Amount and the Interest Amount in respect of a Note having the minimum Specified Denomination.
- 8.10 *Notifications etc.*: All notifications, opinions, determinations, certificates, calculations, quotations and decisions given, expressed, made or obtained for the purposes of this Condition 8 (*Inflation-Linked Note Provisions*) by the Calculation Agent will (in the absence of manifest error) be binding on the Issuer, the Paying Agents, the Noteholders and (subject as aforesaid) no liability to any such Person will attach to the Calculation Agent in connection with the exercise or non-exercise by it of its powers, duties and discretions for such purposes.
- 8.11 Inflation-Linked Final Redemption Amount
  - (a) If "Linear Inflation Linked Redemption" is specified as being applicable in respect of a Note in the applicable Final Terms or Pricing Supplement, the Final Redemption Amount shall be an amount per Calculation Amount determined by the Determination Agent in accordance with the following formula:

(b) If "Interpolated Inflation Linked Redemption" is specified as being applicable in respect of a Note in the applicable Final Terms or Pricing Supplement, the Final Redemption Amount shall be an amount per Calculation Amount determined by the Determination Agent in accordance with the following formula:

"Inflation Index (Start)" means, the DIR Index Level in respect of the Issue Date, as specified in the applicable Final Terms or Pricing Supplement.

# 8.12 Additional Disruption Events

- (a) Following the occurrence of an Additional Disruption Event, the Issuer will, in its reasonable discretion, determine whether or not the relevant Notes shall continue or be redeemed early.
- (b) If the Issuer determines that the relevant Notes shall continue, the Determination Agent may make such adjustment as the Determination Agent, in its reasonable discretion, considers appropriate, if any, to any variable relevant to the interest, redemption, settlement, or payment terms of the relevant Notes and/or any other adjustment which change or adjustment shall be effective on such date as the Determination Agent shall determine. The Fiscal Agent shall provide notice to the Noteholders of any such adjustment in accordance with Condition 19 (*Notices*), giving summary details of the adjustment, provided that any failure to give such notice shall not affect the validity of any such adjustment.
- (c) If the Issuer determines that the relevant Notes shall be redeemed early, then the Issuer shall give not less than five Inflation Business Days' notice to redeem the Notes and the Issuer's obligations under the Notes shall be satisfied in full upon payment in respect of each Note of an amount (the "Early Redemption Amount (Additional Disruption Event)") equal to:
  - (i) If "Early Redemption Amount (Additional Disruption Event) Linear Inflation Linked Redemption" is specified in the applicable Final Terms or Pricing Supplement, an amount per Calculation Amount determined by the Determination Agent in accordance with the following formula:

(ii) If "Early Redemption Amount (Additional Disruption Event) – Interpolated Inflation Linked Redemption" is specified in the applicable Final Terms or Pricing Supplement, an amount per Calculation Amount determined by the Determination Agent in accordance with the following formula:

"Coupon Amount" means the amount determined by the Determination Agent to be accrued but unpaid Interest Amount in respect of such Calculation Amount, on the date fixed for early redemption of the Notes as if such date were an Interest Payment Date;

- "Inflation Index (E)" means the DIR Index Level in respect of the date fixed for early redemption of the Notes, as determined by the Determination Agent; and
- "Inflation Index (Start)" means the DIR Index Level in respect of the Issue Date, as specified in the applicable Final Terms or Pricing Supplement.
- (iii) If "Early Redemption Amount (Additional Disruption Event) Fixed Redemption" is specified in the applicable Final Terms or Pricing Supplement, an amount per Calculation Amount (expressed as a percentage) as specified in the applicable Final Terms or Pricing Supplement;

# 8.13 Definitions Applicable to Inflation-Linked Notes

In relation to Inflation-Linked Notes, the following expressions have the meanings set out below:

- "Additional Disruption Event" means, with respect to any Series of Inflation-Linked Notes, such of Change in Law, Hedging Disruption and/or Increased Cost of Hedging as are applicable as specified in the applicable Final Terms or Pricing Supplement.
- "Affected Payment Date" means each Interest Payment Date or other relevant payment date as may be specified in the applicable Final Terms or Pricing Supplement in relation to the Notes in respect of which an Inflation Index has not been published or announced;
- "Change in Law" means that, on or after the Trade Date (a) due to the adoption of or any change in any applicable law or regulation (including, without limitation, any tax law) or (b) due to the promulgation of or any change in the interpretation by any court, tribunal or regulatory authority with competent jurisdiction of any applicable law or regulation (including any action taken by a taxing authority), the Issuer determines that (i) it has become illegal to hold, acquire or dispose of Hedge Positions or (ii) it will incur a materially increased cost in performing its obligations with respect to the Notes (including, without limitation, due to any increase in tax liability, decrease in tax benefit or other adverse effect on its tax position);
- "CPI<sub>E</sub>" means the official determination of the Inflation Index published for the Determination Month (Early Redemption) subject to adjustment in accordance with the provisions of this Condition 8 (Inflation-Linked Note Provisions);
- "CPI<sub>Final</sub>" means the official determination of the Inflation Index published for the Determination Month (Final) subject to adjustment in accordance with the provisions of Condition 8 (*Inflation-Linked Note Provisions*);
- "CPI<sub>Initial</sub>" means either of the following as specified in the applicable Final Terms or Pricing Supplement: (a) the value specified as "CPI<sub>Initial</sub>" in the applicable Final Terms or Pricing Supplement; or (b) the Initial Inflation Index Level;
- "CPI<sub>m</sub>" means, in respect of each Interest Payment Date and each Interest Period ending on (but excluding) such Interest Payment Date, the official determination of the Inflation Index published for the Determination Month (m) in respect of such Interest Payment Date, subject to adjustment in accordance with the provisions of Condition 8 (Inflation-Linked Note Provisions);
- "CPIn" means, in respect of each Interest Payment Date and each Interest Period ending on (but excluding) such Interest Payment Date, the official determination of the Inflation Index published for the Determination Month (n) in respect of such Interest Payment Date, subject to adjustment in accordance with the provisions of Condition 8 (Inflation-Linked Note Provisions);
- "Determination Date" means, subject to the Conditions, the date specified as such in the applicable Final Terms or Pricing Supplement;
- "Determination Month" means, in respect of each Interest Payment Date, the month specified as such in the applicable Final Terms or Pricing Supplement, which may, without limitation, also be expressed as a specified number of months before or after, as specified in the applicable Final Terms or Pricing Supplement, the relevant Interest Payment Date;
- "Determination Month (Early Redemption) " means a calendar month specified as such in the applicable Final Terms or Pricing Supplement, which may, without limitation, also be expressed as a

specified number of months before or after, any date or event as specified in the applicable Final Terms or Pricing Supplement;

"Determination Month (Final)" means a calendar month of the year specified as such in the applicable Final Terms or Pricing Supplement, and each Determination Month (Final) shall be a "Reference Month" for the purposes of the Conditions;

"Determination Month (Initial)" means a calendar month of the year specified as such in the applicable Final Terms or Pricing Supplement, and each Determination Month (Initial) shall be a "Reference Month" for the purposes of the Conditions;

"Determination Month (m)" means, any of the following as specified in the applicable Final Terms or Pricing Supplement: (a) in respect of each Interest Payment Date and the Interest Period ending on (but excluding) such Interest Payment Date, the calendar month of the year specified in the column headed "Determination Month (m)" of the Determination Month Table in the row corresponding to the date (specified in the column headed "Interest Payment Date(s)") on which such Interest Payment Date is scheduled to fall; (b) in respect of each Interest Period and the Interest Payment Date on which such Interest Period ends (but is not included in such Interest Period), a specified number of calendar months before or after (or the same calendar month as) the month in which such Interest Payment Date falls; or (c) in respect of each Interest Period and the scheduled Interest Payment Date on which such Interest Period ends (but is not included in such Interest Period), a specified number of calendar months before or after (or the same calendar month as) the month in which the scheduled Interest Payment Date falls. Each Determination Month (m) shall be a "Reference Month" for the purposes of the Conditions;

"Determination Month (n)" means, any of the following as specified in the applicable Final Terms or Pricing Supplement: (a) in respect of each Interest Payment Date and the Interest Period ending on (but excluding) such Interest Payment Date, the calendar month of the year specified in the column headed "Determination Month (n)" of the Determination Month Table in the row corresponding to the date (specified in the column headed "Interest Payment Date(s)") on which such Interest Payment Date is scheduled to fall; (b) in respect of each Interest Period and the Interest Payment Date on which such Interest Period ends (but is not included in such Interest Period), a specified number of calendar months before or after (or the same calendar month as) the month in which such Interest Payment Date falls; or (c) in respect of each Interest Period and the scheduled Interest Payment Date on which such Interest Period ends (but is not included in such Interest Period), a specified number of calendar months before or after (or the same calendar month as) the month in which the scheduled Interest Payment Date falls. Each Determination Month (n) shall be a "Reference Month" for the purposes of the Conditions;

"**Determination Month Table**" means a table specified as such in the applicable Final Terms or Pricing Supplement, which will be in or substantially in the form set out below;

"N" means, in respect of a DIR Index Valuation Date, the total number of calendar days in the month in which such DIR Index Valuation Date falls, as determined by the Determination Agent.

"Fallback Bond" means an inflation-linked bond selected by the Determination Agent and issued by the government of a country to whose level of inflation the Inflation Index relates and which pays a coupon or redemption amount which is calculated by reference to the Inflation Index, with a maturity date which falls on (a) the same date as the Maturity Date, (b) if no such bond as described in (a) can be determined, the next longest maturity after the Maturity Date or (c) if no such bond as described in either (a) or (b) can be determined, the next shortest maturity before the Maturity Date. If the Inflation Index relates to the level of inflation across the European Monetary Union, the Determination Agent will select an inflation-linked bond that is a debt obligation of one of the governments (but not any government agency) of France, Italy, Germany or Spain and which pays a coupon or redemption amount which is calculated by reference to the level of inflation in the European Monetary Union. In each case, the Determination Agent will select the Fallback Bond from those inflation-linked bonds issued on or before the Issue Date of the Notes and, if there is more than one inflation-linked bond maturing on the same date, the Fallback Bond shall be selected by the Determination Agent from those bonds. If the Fallback Bond redeems, the Determination Agent will select a new Fallback Bond on the same basis, but selected from all eligible bonds in issue at the time the original Fallback Bond redeems (including any bond for which the redeemed bond is exchanged);

"Hedge Positions" means any purchase, sale, entry into or maintenance of one or more (a) positions or contracts in securities, options, futures, derivatives or foreign exchange, (b) stock loan transactions or (c) other instruments or arrangements (howsoever described) by a party in order to hedge, individually or on a portfolio basis, the Notes;

"Hedging Disruption" means that the Issuer is unable, after using commercially reasonable efforts, to (a) acquire, establish, re-establish, substitute, maintain, unwind or dispose of any transaction(s) or asset(s) it deems necessary to hedge the risk of entering into and performing its obligations under the Notes or (b) realise, recover or remit the proceeds of any such transactions or asset(s);

"Increased Cost of Hedging" means that the Issuer would incur a materially increased (as compared with circumstances existing on the Trade Date) amount of tax, duty, expense or fee (other than brokerage commissions) to (a) acquire, establish, re-establish, substitute, maintain, unwind or dispose of any transaction(s) or asset(s) it deems necessary to hedge the risk of entering into and performing its obligations with respect to the Notes or (b) realise, recover or remit the proceeds of any such transaction(s) or asset(s), **provided that** any such materially increased amount that is incurred solely due to the deterioration of the creditworthiness of the Issuer shall not be deemed an Increased Cost of Hedging;

"Inflation Business Days" means, the business days specified as such in the applicable Final Terms or Pricing Supplement or, if such business days are not specified, if the Inflation Index is measuring the rate of inflation in (a) the United States, any day, other than a Saturday or Sunday that is also a day that is neither a legal holiday nor a day on which banking institutions are authorised or required by law or regulation to close in New York, (b) France, Spain, Germany or the European Monetary Union, any TARGET Settlement Days or (c) the United Kingdom, any day, other than a Saturday or Sunday that is also a day that is neither a legal holiday nor a day on which banking institutions are authorised or required by law or regulation to close in London;

"Inflation Determination Date" means the date that is 5 Inflation Business Days prior to an Inflation Valuation Date;

"Inflation Valuation Date" means, as applicable, (a) each specified Interest Payment Date, (b) the Maturity Date (unadjusted), (c) any date fixed for early redemption of the Notes, or (d) other relevant payment date on which a payment due under the Notes is to be determined by reference to the relevant Inflation Index;

- "Inflation Index" means any index specified as such in the applicable Final Terms or Pricing Supplement;
- "Inflation Index Sponsor" means, in respect of an Inflation Index, the entity specified as such in the applicable Final Terms or Pricing Supplement or, if no entity is specified, the entity that publishes or announces (directly or through an agent) the level of the relevant Inflation Index;
- "Initial Inflation Index Level" means the official determination of the Inflation Index published for the Determination Month (Initial) subject to adjustment in accordance with the provisions of Condition 8 (Inflation-Linked Note Provisions);
- "Interest Cap" means an amount specified as such in the applicable Final Terms or Pricing Supplement;
- "Interest Floor" means an amount specified as such in the applicable Final Terms or Pricing Supplement;
- "Interest Period" means each period specified as such in the applicable Final Terms or Pricing Supplement, and may be expressed as beginning on (and including) a specified date and ending on (and not including) another date;
- "Leverage" means the percentage rate specified as such in the applicable Final Terms or Pricing Supplement;
- "Reference Month" means the calendar month for which the level of the relevant Inflation Index was reported, regardless of when this information is published or announced. If the period for which the Inflation Index level was reported is a period other than a month, the Reference Month will be the period for which the Inflation Index level was reported;
- "Related Bond" means the bond specified in the applicable Final Terms or Pricing Supplement, or if no bond is so specified, the Fallback Bond. If the Related Bond is "Fallback Bond", then for any Related Bond determination under the Conditions, the Determination Agent shall use the Fallback Bond (as that term is defined in this Condition 8.13 (*Definitions Applicable to Inflation-Linked Notes*)). If no bond is specified in the applicable Final Terms or Pricing Supplement as the Related Bond and "Fallback Bond: Not applicable" is specified in the applicable Final Terms or Pricing Supplement, there will be no Related Bond. If a bond is selected as the Related Bond in the applicable Final Terms or Pricing Supplement, and that bond redeems or matures before the relevant Maturity Date, unless "Fallback Bond: Not applicable" is specified in the applicable Final Terms or Pricing Supplement, the Determination Agent shall use the Fallback Bond for any Related Bond determination;
- **"Substitute Inflation Index Level"** means an Inflation Index level, determined by the Determination Agent pursuant to the provisions of Condition 8.1 (*Delay of Publication*), in respect of an Affected Payment Date; and
- "Successor Inflation Index" has the meaning specified in Condition 8.2(a) (Cessation of Publication).

# 9. **AUTOMATIC CHANGE OF INTEREST BASIS**

If the applicable Final Terms or Pricing Supplement specify "Automatic Change of Interest Basis" to be applicable, then the Rate of Interest in respect of an Interest Period and/or Interest Payment Date will be determined in accordance with the Interest Basis applicable to such Interest Period and/or Interest Payment Date specified in the Interest Basis Table set out in the applicable Final Terms or Pricing Supplement.

#### 10. REDEMPTION AND PURCHASE

- 10.1 **Scheduled Redemption**: Unless previously redeemed or cancelled, and unless otherwise specified in the Conditions, Notes will be redeemed at their Final Redemption Amount on the Maturity Date, subject as provided in Condition 11 (*Payments*) in accordance with the Conditions.
- 10.2 *Tax Redemption*: Notes may be redeemed in whole (but not in part), at the option of the Issuer at any time prior to maturity, upon the giving of a notice of redemption as described below in Condition 19 (*Notices*), if the Issuer determines that, as a result of:
  - any change in or amendment to the laws, or any regulations or rulings promulgated under the laws, of the U.S. or of any political subdivision or taxing authority of or in the U.S. affecting taxation; or

(b) any change in official position regarding the application or interpretation of the laws, regulations or rulings referred to above,

which change or amendment becomes effective on or after the date of the applicable Final Terms or Pricing Supplement in connection with the issuance of the Notes, the Issuer is or will become obligated to pay Additional Amounts with respect to the Notes as described in Condition 12 (*Taxation*). The Notes will be redeemed at the Early Redemption Amount (Tax).

Notice of redemption will be given not less than 30 nor more than 60 days prior to the date fixed for redemption. The date and the applicable redemption price will be specified in the notice.

- 10.3 Redemption at the Option of the Issuer: If the Call Option is specified in the applicable Final Terms or Pricing Supplement as being applicable, the Notes may be redeemed at the option of the Issuer in whole or, if so specified in the applicable Final Terms or Pricing Supplement, in part on any Optional Redemption Date (Call) at the relevant Optional Redemption Amount (Call) on the Issuer's giving not less than the number of days' notice equal to the Minimum Notice Number of Day(s), nor more than the number of days' notice equal to the Maximum Notice Number of Day(s) to the Noteholders (which notice shall be irrevocable and shall oblige the Issuer to redeem the Notes specified in such notice on the relevant Optional Redemption Date (Call) at the Optional Redemption Amount (Call) plus accrued interest (if any) to such date).<sup>2</sup>
- 10.4 **Partial Redemption**: If the Notes are to be redeemed in part only on any date in accordance with Condition 10.3 (*Redemption at the Option of the Issuer*), the Notes to be redeemed shall be selected by the drawing of lots, in the case of Notes in global form, in accordance with the policies and procedures of Relevant Clearing System, and otherwise in such place as the Fiscal Agent approves and in such manner as the Fiscal Agent considers appropriate, subject to compliance with applicable law and the rules of each listing authority, stock exchange and/or quotation system by which the Notes have then been admitted to listing, trading and/or quotation, and the notice to Noteholders referred to in Condition 10.3 (*Redemption at the Option of the Issuer*) shall specify the serial numbers of the Notes so to be redeemed.
- 10.5 *Purchase*: Morgan Stanley or any of its Subsidiaries may at any time purchase Notes in the open market or otherwise and at any price.
- 10.6 *Cancellation*: All Notes so redeemed shall, and all Notes so purchased by Morgan Stanley or any of its Subsidiaries may, at the discretion of the relevant purchaser, be cancelled. All Notes so redeemed, and all Notes so purchased and cancelled, may not be reissued or resold.
- 10.7 **Definitions**

In these Conditions:

"Maximum Notice Number of Day(s)" means the number of days specified in the Final Terms or Pricing Supplement; and

"Minimum Notice Number of Day(s)" means the number of days specified in the Final Terms or Pricing Supplement.

### 11. PAYMENTS

- 11.1 **Principal:** Subject to Condition 11.3 (Payments of Principal and Interest in CNY), payments of principal shall be made by cheque drawn in the currency in which the payment is due drawn on, or, upon application by a holder of a Note to the Specified Office of the Fiscal Agent not later than the fifteenth (15th) day before the due date for any such payment, by transfer to an account denominated in that currency (or, if that currency is euro, any other account to which euro may be credited or transferred) and maintained by the payee with, a bank in the Principal Financial Centre of that currency (in the case of a Sterling cheque, a town clearing branch of a bank in the City of London) and (in the case of redemption) upon surrender (or, in the case of part payment only, endorsement) of the relevant Note Certificates at the Specified Office of any Paying Agent.
- 11.2 **Interest**: Subject to Condition 11.3 (*Payments of Principal and Interest in CNY*), payments of interest shall be made by cheque drawn in the currency in which the payment is due drawn on,

or, upon application by a holder of a Note to the Specified Office of the Fiscal Agent not later than the fifteenth (15th) day before the due date for any such payment, by transfer to an account denominated in that currency (or, if that currency is euro, any other account to which euro may be credited or transferred) and maintained by the payee with, a bank in the Principal Financial Centre of that currency (in the case of a Sterling cheque, a town clearing branch of a bank in the City of London) and (in the case of interest payable on redemption) upon surrender (or, in the case of part payment only, endorsement) of the relevant Note Certificates at the Specified Office of any Paying Agent.

- 11.3 **Payments of Principal and Interest in CNY**: Notwithstanding Conditions 11.1 (*Principal*) and 11.2 (*Interest*), in respect of CNY Notes, no payment of principal or interest in CNY will be made by cheque and all payments to Noteholders will be made solely (a) for so long as the CNY Notes are represented by a Note held with the common depositary for Clearstream Banking, S.A. and Euroclear Bank SA/NV or any Relevant Clearing System, by transfer to a CNY bank account maintained in Hong Kong, or (b) for so long as the Notes are in definitive form, by transfer to a CNY bank account maintained in Hong Kong, in each case in accordance with prevailing rules and regulations.
- 11.4 **Payments Subject to Fiscal Laws**: All payments in respect of the Notes are subject in all cases to (a) any applicable fiscal or other laws and regulations, but without prejudice to the provisions of Condition 12 (*Taxation*) and (b) any withholding or deduction required pursuant to an agreement described in Section 1471(b) of the United States Internal Revenue Code of 1986 (the "Code") or otherwise imposed pursuant to Sections 1471 through 1474 of the Code, any regulations or agreements thereunder, any official interpretations thereof, or any law, regulation or official guidance implementing an intergovernmental approach thereto. No commissions or expenses shall be charged to the Noteholders in respect of such payments.
- Payments on Payment Business Days: Where payment is to be made by transfer to an account, payment instructions (for value the due date, or, if the due date is not a Payment Business Day, for value the next succeeding Payment Business Day) will be initiated and, where payment is to be made by cheque, the cheque will be mailed (a) (in the case of payments of principal and interest payable on redemption) on the later of the due date for payment and the day on which the relevant Note Certificate is surrendered (or, in the case of part payment only, endorsed) at the Specified Office of a Paying Agent and (b) (in the case of payments of interest payable other than on redemption) on the due date for payment. A holder of a Note shall not be entitled to any interest or other payment in respect of any delay in payment resulting from (i) the due date for a payment not being a Payment Business Day or (ii) a cheque mailed in accordance with this Condition 11 (*Payments*) arriving after the due date for payment or being lost in the mail.
- 11.6 **Partial Payments**: If a Paying Agent makes a partial payment in respect of any Note, the Issuer shall procure that the amount and date of such payment are noted on the Register and, in the case of partial payment upon presentation of a Note Certificate, that a statement indicating the amount and the date of such payment is endorsed on the relevant Note Certificate.
- 11.7 **Record Date**: Each payment in respect of a Note will be made to the person shown as the holder in the Register at the opening of business in the place of the Registrar's Specified Office on such number of days before the due date for such payment as is specified in the applicable Final Terms or Pricing Supplement (the **"Record Date"**). Where payment in respect of a Note is to be made by cheque, the cheque will be mailed to the address shown as the address of the holder in the Register at the opening of business on the relevant Record Date.
- Unavailability of Currency: If the Specified Currency is not available to the Issuer for making payments of principal of, and premium, interest and/or additional amounts, if any, on any Note (whether due to the imposition of exchange controls or other circumstances beyond the control of the Issuer, or if the Specified Currency is no longer used by the government of the country issuing that currency or by public institutions within the international banking community for the settlement of transactions), the Issuer may satisfy its obligations to Noteholders by making payments on the date of payment in U.S. dollars on the basis of the prevailing exchange rate on the date of the payment or of the most recent practicable date, such rate being based on the highest bid quotation in The City of New York received by the Exchange Rate Agent at approximately 11:00 a.m., New York City time, on the second Business Day preceding the applicable payment date from three recognised foreign exchange dealers for the purchase by the quoting dealer:

- (i) of the Specified Currency for U.S. dollars for settlement on the payment date;
- (ii) in the aggregate amount of the Specified Currency payable to those holders or beneficial owners of Notes; and
- (iii) at which the applicable dealer commits to execute a contract.

If those bid quotations are not available, the Exchange Rate Agent will determine the Market Exchange Rate at its reasonable discretion. All determinations by the Exchange Rate Agent will, in the absence of manifest error, be conclusive for all purposes and binding on the Issuer and the Noteholders. The Exchange Rate Agent will be Morgan Stanley & Co. International plc, unless otherwise noted in the applicable Final Terms or Pricing Supplement. If the Exchange Rate Agent is not an affiliate of Morgan Stanley, it may be one of the dealers providing quotations.

Any payment made in U.S. dollars on the basis of the prevailing exchange rate where the required payment is in an unavailable Specified Currency will not constitute an Event of Default or default.

The foregoing provisions do not apply if a Specified Currency is unavailable because it has been replaced by the euro. If the euro has been substituted for a Specified Currency, the Issuer may (or will, if required by applicable law) without the consent of the holders of the affected Notes, pay the principal of, premium, if any, or interest, if any, on any Note denominated in the Specified Currency in euro instead of the Specified Currency, in conformity with legally applicable measures taken pursuant to, or by virtue of, the Treaty. Any payment made in U.S. dollars or in euro as described above where the required payment is in an unavailable Specified Currency will not constitute an Event of Default or default.

#### 12. TAXATION

Additional Amounts: If the applicable Final Terms or Pricing Supplement specify "Additional Amounts" as being applicable in respect of any Series of Notes, the Issuer will, subject to certain exceptions and limitations set forth below, pay those additional amounts (the "Additional Amounts") to any Noteholder who is a U.S. Alien (as defined below) as may be necessary in order that every net payment by or on behalf of the Issuer of the principal of and interest in respect of the Note and any other amounts payable on the Note after withholding for or on account of any tax, assessment or governmental charge imposed upon or as a result of that payment by the U.S. or any political subdivision or taxing authority thereof or therein, will not be less than the amount provided for in the Note to be then due and payable.

The Issuer will not, however, be required to make any payment of Additional Amounts to any Noteholder for or on account of:

- (a) any tax, assessment or other governmental charge that would not have been so imposed but for:
  - (i) the existence of any present or former connection between the Noteholder or beneficial owner, or between a fiduciary, settlor, beneficiary, member or shareholder of the Noteholder, if the Noteholder is an estate, a trust, a partnership or a corporation, and the U.S. or its possessions, including, without limitation, the Noteholder or beneficial owner, or such fiduciary, settlor, beneficiary, member or shareholder, being or having been a citizen or resident of the U.S. or being or having been engaged in the conduct of a trade or business or present in the U.S. or having, or having had, a permanent establishment in the U.S.; or
  - (ii) the presentation by the Noteholder for payment on a date more than 15 days after the date on which payment became due and payable or the date on which payment thereof is duly provided for, whichever occurs later;
- (b) any estate, inheritance, gift, sales, transfer, capital gains, corporation, income or personal property tax or any similar tax, assessment or governmental charge;
- (c) any tax, assessment or other governmental charge imposed by reason of the Noteholder's or beneficial owner's past or present status as a personal holding company or controlled foreign corporation or passive foreign investment company for U.S.

federal income tax purposes or as a corporation that accumulates earnings to avoid U.S. federal income tax or as a private foundation or other tax-exempt organisation;

- (d) any tax, assessment or other governmental charge that is payable otherwise than by withholding from payments on or in respect of any Note;
- (e) any tax, assessment or other governmental charge that would not have been imposed but for the failure to comply with certification, information or other reporting requirements concerning the nationality, residence or identity or connection with the U.S. of the holder or beneficial owner of that Note, if compliance is required by statute or by regulation or published administrative guidance of the U.S. or of any political subdivision or taxing authority thereof or therein as a precondition to relief or exemption from the tax, assessment or other governmental charge;
- (f) any withholding tax imposed under Sections 1471 through 1474 of the Code or any agreement with the IRS pursuant to these Code sections, any applicable U.S. Treasury regulations promulgated thereunder or published administrative guidance implementing such sections and any provisions under non-U.S. law analogous or relating to the foregoing (including withholding resulting from any inter-governmental agreement or other agreement between the U.S. and any non-U.S. taxing authority in connection with such sections of the Code, regulations, guidance or laws);
- (g) any tax, assessment or other governmental charge imposed by reason of the Noteholder's or beneficial owner's past or present status as the direct, indirect or constructive owner of 10 per cent. or more of the total combined voting power of all classes of stock entitled to vote of Morgan Stanley;
- (h) any tax, assessment or other governmental charge imposed by reason of the Noteholder or a beneficial owner being a bank holding the Note in the context of an extension of credit made pursuant to a loan agreement entered into in the ordinary course of its trade or business;
- (i) any tax, assessment or other governmental charge that a holder or beneficial owner would have been able to avoid by presenting the relevant Note to another paying agent in a member state of the European Union or the United Kingdom; or
- (j) any combination of the items listed above.

Nor will Additional Amounts be paid with respect to any payment on a Note to a U.S. Alien who is a fiduciary or partnership or other than the sole beneficial owner of that payment to the extent that payment would be required by the laws of the U.S. (or any political subdivision thereof) to be included in the income, for tax purposes, of a beneficiary or settlor with respect to the fiduciary or a member of that partnership or a beneficial owner who would not have been entitled to the Additional Amounts had that beneficiary, settlor, member or beneficial owner been the Noteholder.

The term "U.S. Alien" means any person who, for U.S. federal income tax purposes, is a foreign corporation, a non-resident alien individual, a foreign trust, or a foreign partnership one or more of the members of which is a foreign corporation, a non-resident alien individual or a non-resident alien fiduciary of a foreign estate or trust.

For the avoidance of doubt, if any withholding or deduction of any tax, assessment or other governmental charge is required under the laws of any jurisdiction (including any political subdivision thereof or therein), none of the Issuer, an Agent or any other person will be required to pay additional amounts to a Noteholder or a beneficial owner of Notes with respect to such withholding or deduction, except to the extent provided in this Condition 12 (if Condition 12 is applicable pursuant to the relevant Final Terms or Pricing Supplement).

# 13. **EVENTS OF DEFAULT**

- 13.1 If any of the following events (each an "Event of Default") occurs and is continuing:
  - (a) **Non-payment**: the Issuer fails to pay any amount of principal in respect of the Notes or fails to pay any amount of interest in respect of the Notes, in each case within 30 days of the respective due date for payment thereof; or

(b) *Insolvency, etc.*: (i) the Issuer becomes insolvent or is unable to pay its debts as they fall due; (ii) an administrator or liquidator of the Issuer or the whole or a substantial part of the undertaking, assets and revenues of the Issuer is appointed (otherwise than for the purposes of or pursuant to an amalgamation, reorganisation or restructuring whilst solvent); (iii) the Issuer takes any action for a composition with or for the benefit of its creditors generally; or (iv) an order is made or an effective resolution is passed for the winding up, liquidation or dissolution of the Issuer (otherwise than for the purposes of or pursuant to an amalgamation, reorganisation or restructuring whilst solvent), and such order or effective resolution has remained in force and has not been rescinded, revoked or set aside for 60 days after the date on which such order is made or effective resolution is passed,

then Noteholders of not less than 25 per cent. in aggregate principal amount of the Notes may, by written notice addressed to the Issuer and delivered to the Issuer or to the Specified Office of the Fiscal Agent, declare the Notes to be immediately due and payable, whereupon they shall become so due and payable at their Early Redemption Amount without further action or formality. Notice of any such declaration shall promptly be given to the Noteholders.

13.2 Annulment of Acceleration and Waiver of Defaults: In some circumstances, if any or all Events of Default, other than the non-payment of the principal of the Notes of a Series that has become due as a result of an acceleration, have been cured, waived or otherwise remedied, then the holders of a majority in principal amount of such Series of Notes (voting as one class) may annul past declarations of acceleration of or waive past defaults of the Notes. However, any continuing default in payment of principal of or any premium or interest on those Notes may not be waived.

#### 14. **PRESCRIPTION**

Claims for principal and interest on redemption in respect of Notes shall become void unless the relevant Note Certificates are surrendered for payment within 10 years of the appropriate Relevant Date.

#### 15. REPLACEMENT OF NOTES

If any Note or Note Certificate is lost, stolen, mutilated, defaced or destroyed, it may be replaced at the Specified Office of the Registrar, during normal business hours (and, if the Notes are then admitted to listing, trading and/or quotation by any listing authority, stock exchange and/or quotation system which requires the appointment of a Paying Agent or Transfer Agent in any particular place, the Paying Agent or Transfer Agent having its Specified Office in the place required by such listing authority, stock exchange and/or quotation system), subject to all applicable laws and stock exchange requirements, upon payment by the claimant of the expenses incurred in connection with such replacement and on such terms as to evidence, security, indemnity and otherwise as the Issuer may reasonably require. Mutilated or defaced Notes or Note Certificates must be surrendered before replacements will be issued.

#### 16. **AGENTS**

- In acting under the Issue and Paying Agency Agreement and in connection with the Notes, the Agents act solely as agents of the Issuer and do not assume any obligations towards or relationship of agency or trust for or with any of the Noteholders. All calculation and determination functions required of the relevant Agent may be delegated to such persons as the relevant Agent may decide and all notifications, opinions, determinations, certificates, calculations, quotations and decisions given, expressed, made or obtained for the purposes of the Notes by the Agents or the Issuer shall (in the absence of manifest error or wilful misconduct) be binding on the Issuer and the Noteholders, and (subject as aforesaid) no liability to the Noteholders (or any of them) shall attach to the Agents or the Issuer in connection with the exercise or non-exercise by any of them of their powers, duties and discretions for such purposes.
- 16.2 The initial Agents and their initial Specified Office are listed below on the inside back cover of this Base Prospectus. The initial Calculation Agent is The Bank of New York Mellon, London Branch. The Issuer reserves the right at any time to vary or terminate the appointment of any

Agent and to appoint a successor Fiscal Agent or Registrar or Calculation Agent or additional or successor paying agents; provided, however, that:

- (a) there shall at all times be a Registrar appointed in respect of the Notes;
- (b) if a Calculation Agent is specified in the applicable Final Terms or Pricing Supplement, the Issuer shall at all times maintain a Calculation Agent;
- (c) if a Determination Agent is specified in the applicable Final Terms or Pricing Supplement, the Issuer shall at all times maintain a Determination Agent; and
- (d) if and for so long as the Notes are admitted to listing, trading and/or quotation by any listing authority, stock exchange and/or quotation system which requires the appointment of a Paying Agent and/or a Transfer Agent in any particular place, the Issuer shall maintain a Paying Agent and/or a Transfer Agent having its Specified Office in the place required by such listing authority, stock exchange and/or quotation system.
- Notice of any change in any of the Paying Agents or in their Specified Offices shall promptly be given to the Noteholders in accordance with Condition 19 (*Notices*).
- 16.4 Notwithstanding any provision to the contrary, the Determination Agent shall act as an expert and not as an agent for the Issuer or the Noteholders and all determinations, considerations and decisions made by the Determination Agent shall, in the absence of manifest error, wilful default or bad faith, be final and conclusive and the Determination Agent shall have no liability in relation to such determinations except in the case of its wilful default or bad faith.
- Notwithstanding any provision to the contrary, the Calculation Agent shall act as an expert and not as an agent for the Issuer or the Noteholders and all determinations, considerations and decisions made by the Calculation Agent shall, in the absence of manifest error, wilful default or bad faith, be final and conclusive and the Calculation Agent shall have no liability in relation to such determinations except in the case of its wilful default or bad faith.

# 17. MEETINGS OF NOTEHOLDERS AND MODIFICATION

17.1 Meetings of Noteholders: The Issue and Paying Agency Agreement contains provisions for convening meetings of Noteholders to consider matters relating to the Notes, including the modification of any provision of the Conditions. Any such modification may be made if sanctioned by an Extraordinary Resolution. Such a meeting may be convened by the Issuer and shall be convened by it upon the request in writing of Noteholders holding not less than one-tenth of the aggregate principal amount of the outstanding Notes. The quorum at any meeting convened to vote on an Extraordinary Resolution will be two or more Persons holding or representing one more than half of the aggregate principal amount of the outstanding Notes or, at any adjourned meeting, two or more Persons being or representing Noteholders whatever the principal amount of the Notes held or represented, provided, however, that Reserved Matters may only be sanctioned by an Extraordinary Resolution passed at a meeting of Noteholders at which two or more Persons holding or representing not less than three-quarters or, at any adjourned meeting, one quarter of the aggregate principal amount of the outstanding Notes form a quorum. Any Extraordinary Resolution duly passed at any such meeting shall be binding on all the Noteholders, whether present or not.

In addition, a resolution in writing signed by or on behalf of all Noteholders who for the time being are entitled to receive notice of a meeting of Noteholders will take effect as if it were an Extraordinary Resolution. Such a resolution in writing may be contained in one document or several documents in the same form, each signed by or on behalf of one or more Noteholders.

#### 17.2 **Modification**

- (a) The Notes and the Conditions may be amended without the consent of the Noteholders where, in the reasonable opinion of the Issuer:
  - (i) the amendment is to correct a manifest error or to effect a modification which is of a formal, minor or technical nature;
  - (ii) the amendment is to cure any ambiguity or is to correct or supplement any defective provisions;

- (iii) the amendment is to correct an error or omission such that, in the absence of such correction, the relevant terms proposed to be corrected would not otherwise represent the intended terms on which the relevant Notes were sold and have since traded; or
- (iv) the amendment is not materially prejudicial to the interest of the Noteholders.
- (b) The parties to the Issue and Paying Agency Agreement may agree to modify any provision thereof, but the Issuer shall not agree, without the consent of the Noteholders, to any such modification unless it is of a type contemplated in Condition 17.2(a).
- 17.3 *Interests of Noteholders*: In connection with the Conditions, the Issuer and the Fiscal Agent shall have regard to the interests of the Noteholders as a class. In particular, but without limitation, the Issuer and the Fiscal Agent shall not have regard to the consequences for individual Noteholders resulting from such individual Noteholders being for any purpose domiciled or resident in, or otherwise connected with, or subject to the jurisdiction of, any particular territory.
- 17.4 **Severance**: Should any of the provisions contained in the Conditions be or become invalid, the validity of the remaining provisions shall not be affected in any way.

#### 18. **FURTHER ISSUES**

The Issuer may from time to time, without the consent of the Noteholders, create and issue further notes having the same terms and conditions as the Notes in all respects (or in all respects except for the first payment of interest) so as to form a single series with the Notes.

#### 19. **NOTICES**

- 19.1 *Notes*: Notices to holders of Notes shall be sent to them by first class mail (or its equivalent) or (if posted to an overseas address) by airmail at their respective last addresses on the Register. Notices to holders of registered Notes in global form shall be sent to them by delivery of the relevant notice to Euroclear and/or Clearstream, Luxembourg and/or any other Relevant Clearing System for communication by them to the holders of the Notes. To the extent the Notes are admitted to listing on the Official List of the Luxembourg Stock Exchange and to trading on the Luxembourg Regulated Market or the Luxembourg Stock Exchange's Euro MTF market, or admitted to listing and trading on the SIX Swiss Exchange, notices to holders will be published in accordance with the rules of the Luxembourg Stock Exchange or the SIX Swiss Exchange (as applicable), and, if permitted by the rules and regulations of the Luxembourg Stock Exchange or the SIX Swiss Exchange (as applicable), on the Issuer's website at <a href="http://sp.morganstanley.com/EU/Documents">http://sp.morganstanley.com/EU/Documents</a>.
- 19.2 *Unlisted Notes*: Notices to Noteholders of non-listed Notes may be published, as specified in the applicable Final Terms or Pricing Supplement, in newspapers, on the Issuer's website at http://sp.morganstanley.com/EU/Documents, or otherwise.

#### 20. LOSSES

In no event shall the Issuer or the Agents have any liability for indirect, incidental, consequential or other damages (whether or not it may have been advised of the possibility of such damages) other than interest until the date of payment on sums not paid when due in respect of any Notes or assets not delivered when due. Noteholders are entitled to damages only and are not entitled to the remedy of specific performance in respect of any Note.

# 21. **CURRENCY INDEMNITY**

If any sum due from the Issuer in respect of the Notes or any order or judgment given or made in relation thereto has to be converted from the currency (the "first currency") in which the same is payable under the Conditions or such order or judgment into another currency (the "second currency") for the purpose of (a) making or filing a claim or proof against the Issuer, (b) obtaining an order or judgment in any court or other tribunal or (c) enforcing any order or judgment given or made in relation to the Notes, the Issuer shall indemnify each Noteholder, on the written demand of such Noteholder addressed to the Issuer and delivered to the Issuer or to the Specified Office of the Fiscal Agent, against any loss suffered as a result of any discrepancy between (i) the rate of exchange used for such purpose to convert the sum in question from the first currency into the second currency and (ii) the rate or rates of exchange at which such

Noteholder may in the ordinary course of business purchase the first currency with the second currency upon receipt of a sum paid to it in satisfaction, in whole or in part, of any such order, judgment, claim or proof.

21.2 This indemnity constitutes a separate and independent obligation of the Issuer and shall give rise to a separate and independent cause of action.

#### 22. ROUNDING

For the purposes of any calculations referred to in the Conditions (unless otherwise specified in the Conditions or the applicable Final Terms or Pricing Supplement), (a) all percentages resulting from such calculations will be rounded, if necessary, to the nearest one hundred-thousandth of a percentage point (with 0.000005 per cent. rounded up to 0.00001 per cent.), (b) all U.S. dollar amounts used in or resulting from such calculations will be rounded to the nearest cent (with one-half cent rounded upward), (c) all Japanese Yen amounts used in or resulting from such calculations will be rounded downward to the next lower whole Japanese Yen amount (or, if specified in the applicable Final Terms or Pricing Supplement, upward to the next upper whole Japanese Yen amount or, rounded to the nearest whole Japanese Yen amount) and (d) all amounts denominated in any other currency used in or resulting from such calculations will be rounded to the nearest two decimal places in such currency (with 0.005 rounded up to 0.01).

#### 23. REDENOMINATION, RENOMINALISATION AND RECONVENTIONING

- 23.1 **Application**: This Condition 23 (*Redenomination, Renominalisation and Reconventioning*) is applicable to the Notes only if it is specified in the applicable Final Terms or Pricing Supplement as being applicable.
- 23.2 **Notice of Redenomination**: If the country of the Specified Currency becomes, or announces its intention to become, a Participating Member State, the Issuer may, without the consent of the Noteholders, on giving at least 30 days' prior notice to the Noteholders and the Paying Agents, designate a date (the **"Redenomination Date"**), being an Interest Payment Date under the Notes falling on or after the date on which such country becomes a Participating Member State.
- 23.3 **Redenomination:** Notwithstanding the other provisions of the Conditions, with effect from the Redenomination Date, the Notes shall be deemed to be redenominated into euro in the denomination of euro 0.01 with a principal amount for each Note equal to the principal amount of that Note in the Specified Currency, converted into euro at the rate for conversion of such currency into euro established by the Council of the European Union pursuant to the Treaty (including compliance with rules relating to rounding in accordance with European Union regulations); provided, however, that, if the Issuer determines, with the agreement of the Fiscal Agent that the then market practice in respect of the redenomination into euro 0.01 of internationally offered securities is different from that specified above, such provisions shall be deemed to be amended so as to comply with such market practice and the Issuer shall promptly notify the Noteholders, each listing authority, stock exchange and/or quotation system (if any) by which the Notes have been admitted to listing, trading and/or quotation and the Paying Agents of such deemed amendments.
- 23.4 *Interest*: Following redenomination of the Notes pursuant to this Condition 23 (*Redenomination, Renominalisation and Reconventioning*), where Notes have been issued in definitive form, the amount of interest due in respect of such Notes will be calculated by reference to the aggregate principal amount of the Notes presented for payment by the relevant holder.
- 23.5 *Interest Determination Date*: If the Floating Rate Note Provisions are specified in the applicable Final Terms or Pricing Supplement as being applicable and Screen Rate Determination is specified in the applicable Final Terms or Pricing Supplement as the manner in which the Floating Interest Rate(s) is/are to be determined, with effect from the Redenomination Date, the Interest Determination Date shall be deemed to be the second TARGET Settlement Day before the first day of the relevant Interest Period.

#### 24. INCONVERTIBILITY EVENTS

- 24.1 If, in respect of any Series of Notes, the applicable Final Terms or Pricing Supplement specifies that "Inconvertibility Event Provisions" are applicable, this Condition 24 (*Inconvertibility Events*) shall apply in respect of such Notes.
- If, at any time during the term of such Notes, the Determination Agent determines that an Inconvertibility Event has occurred, it will inform the Issuer of the occurrence of such event. Following the determination by the Determination Agent of the occurrence of an Inconvertibility Event, the Issuer may, at its reasonable discretion, provide a notice of the occurrence of such an event of inconvertibility to the holders of the Notes in accordance with Condition 19 (*Notices*) electing either:
  - (a) if "Converted Payment" is specified in the applicable Final Terms or Pricing Supplement: to continue making any payments due under such Notes until the Maturity Date, in which case any amount due under such Notes shall be converted from the Relevant Currency into the Inconvertibility Specified Currency at the Fallback FX Spot Rate determined by the Determination Agent in its reasonable discretion;
  - (b) if "Early Redemption" is specified in the applicable Final Terms or Pricing Supplement: to early redeem the Notes on a specified date (such date the "Inconvertibility Early Redemption Date"), in which case the Notes shall early redeem at the Inconvertibility Early Redemption Amount on such Inconvertibility Early Redemption Date. The Issuer's obligations under the Notes shall be satisfied in full upon payment of such amount; or
  - (c) if "Suspended Payment" is specified in the applicable Final Terms or Pricing Supplement: to suspend the payment until such number of Business Days as are specified in the applicable Final Terms or Pricing Supplement after the Determination Agent has notified the Issuer that, in the Determination Agent's reasonable discretion, the Inconvertibility Event has ceased or is no longer in effect,

**provided that** the Issuer may, at any time from and including the Trade Date to and including the Maturity Date, subsequent to the despatch of a notice electing one of the selected options other than "Early Redemption", dispatch a second notice electing "Early Redemption", **provided that** such option was specified as applicable in the applicable Final Terms or Pricing Supplement, in which case the Notes will be redeemed in accordance with the terms of "Early Redemption" above and the date specified in such notice will be the Inconvertibility Early Redemption Date.

For the avoidance of doubt, failure to deliver such notice or the failure of the recipient to receive such notice will not affect the Issuer's ability to make payments according to the option it selected.

#### 24.3 Definitions:

"Fallback FX Spot Rate" means the relevant currency exchange rate determined in accordance with the applicable Settlement Rate Option and, if a Settlement Rate Option is not applicable, the currency exchange rate at the time at which such rate is to be determined for foreign exchange transactions in the Specified Currency or the Inconvertibility Specified Currency for value on the relevant Inconvertibility Early Redemption Date, as determined in good faith and in a commercially reasonable manner by the Determination Agent;

# "Inconvertibility Early Redemption Amount" means:

- (a) if **"Fixed Redemption"** is specified in the applicable Final Terms or Pricing Supplement, an amount per Calculation Amount as specified as such in the applicable Final Terms or Pricing Supplement;
- (b) if "Early Redemption Amount" is specified in the applicable Final Terms or Pricing Supplement, an amount equal to the Early Redemption Amount (i) converted from the Relevant Currency into the Inconvertibility Specified Currency at the exchange rate (expressed as a number of the Relevant Currency per one unit of the Inconvertibility Specified Currency) determined by the Determination Agent in its reasonable discretion for settlement on or about the relevant payment date and (ii) less the reasonable cost to and/or the loss realised by, the Issuer and/or any Affiliate in respect

of break funding costs for the Issuer term financing associated with such early redemption of the Notes, in each case as calculated by the Determination Agent in its reasonable discretion; or

(c) if "Fair market value" is specified in the applicable Final Terms or Pricing Supplement, an amount, in the Inconvertibility Specified Currency, equal to the fair market value of such Notes, on such day as is selected by the Determination Agent in its reasonable discretion (provided that such day is not more than 15 days before the Inconvertibility Early Redemption Date), less the proportion attributable to that Note of the reasonable cost to the Issuer and/or any Affiliate of, or the loss realised by the Issuer and/or any Affiliate on, unwinding any related hedging arrangements or in respect of break funding costs for the Issuer's term financing associated with such early redemption of the Notes, in each case as calculated by the Determination Agent in its reasonable discretion;

An "Inconvertibility Event" shall be deemed to have occurred if from (and including) the Trade Date to (and including) the Maturity Date, any event or circumstance occurs that generally makes it, in the reasonable discretion of the Determination Agent, impossible, unlawful or impracticable for the Issuer, the Determination Agent or any of its affiliates for any reason beyond their reasonable control:

- (a) to convert the Relevant Currency into the Inconvertibility Specified Currency or the Inconvertibility Specified Currency into the Relevant Currency (whether directly or through a cross exchange rate) through customary legal channels; or
- (b) to determine the rate of conversion of the Inconvertibility Specified Currency into the Relevant Currency or the Relevant Currency into the Inconvertibility Specified Currency or
- (c) to transfer, or make a payment in, or delivery of, the Relevant Currency from or to, outside, or inside, of the Relevant Jurisdiction, in each case under (i), (ii) or (iii), in an amount up to the total amount of payment due to be made by the Issuer under the Notes; or
- (d) to determine a rate at which any Relevant Currency can be lawfully exchanged for U.S. dollars; or
- (e) to convert any Relevant Currency into U.S. dollars; or
- (f) for the Issuer or any of its affiliates to hold, purchase, sell or otherwise deal in any Notes, or any other property in order for the Issuer or any of its affiliates to perform any related hedging arrangement, or for the purposes of the Issuer or the Issuer's obligations in respect of any Notes;

"Inconvertibility Specified Currency" means the currency specified in the applicable Final Terms or Pricing Supplement;

"Relevant Currency" means the currency as specified in the applicable Final Terms or Pricing Supplement; and

"Relevant Jurisdiction" means the jurisdiction as specified in the applicable Final Terms or Pricing Supplement.

# 25. CNY DISRUPTION EVENTS

- 25.1 In the event that a CNY Disruption Event, as determined by the Determination Agent in its reasonable discretion, occurs on or prior to any date on which a payment is scheduled to be made under a CNY Note (including, but not limited to, an Interest Payment Date or the Maturity Date) and such CNY Disruption Event is continuing on such date (any such CNY Note so affected, an "Affected CNY Note"), the following terms will apply:
  - (a) first, payments under the Affected CNY Note shall be postponed to two Hong Kong Business Days after the date on which the CNY Disruption Event ceases to exist, unless that CNY Disruption Event continues to exist for 14 consecutive calendar days from the original date that, but for the occurrence of the CNY Disruption Event, would have been the date for such payments (which payment date may be, but is not limited to, an Interest Payment Date or the Maturity Date). In that case, the provisions of Condition

- 25.1(b) (*CNY Disruption Events*) will apply on the day immediately following the lapse of such 14-calendar day period;
- (b) secondly, the relevant payment obligations under the Affected CNY Note shall be replaced by an obligation to pay an amount that would be due as if settlement were non-deliverable with the effect that any amounts in CNY payable under the Affected CNY Note shall be converted into an amount in USD as calculated by the Determination Agent in its reasonable discretion. All the payments hereunder shall be made in USD on the relevant Non-Deliverable Substitute Settlement Date. For the avoidance of doubt, this Condition 25.1(b) (CNY Disruption Events) shall only apply to any payment which is scheduled to occur on a date (which may be, but is not limited to, the Maturity Date or an Interest Payment Date) that is affected by the CNY Disruption Event and shall not affect any payments falling due on any other dates.
- 25.2 For the purpose of this Condition 25 (CNY Disruption Events):
  - "CNY Disruption Event" means any of CNY Illiquidity, CNY Inconvertibility or CNY Non-Transferability.
  - "CNY Illiquidity" means, as determined by the Determination Agent in its reasonable discretion, the occurrence of any event that makes it impossible (where it had previously been possible) for the Issuer to obtain a firm quote of an offer price in respect of an amount in CNY equal to the then current outstanding principal amount of the relevant Affected CNY Notes, any interest or any other amount to be paid under such Notes (the "Relevant Disrupted Amount"), during the term of such Notes, either in one transaction or a commercially reasonable number of transactions that, when taken together, is no less than such Relevant Disrupted Amount, in the general CNY exchange market in each Offshore CNY Centre in order to perform its obligations under the Affected CNY Notes.
  - "CNY Inconvertibility" means, as determined by the Determination Agent in its reasonable discretion, the occurrence of any event that makes it impossible (where it had previously been possible) for the Issuer to convert an amount of CNY no less than the Relevant Disrupted Amount into or from USD in the general CNY exchange market in each Offshore CNY Centre.
  - "CNY Non-Transferability" means, as determined by the Determination Agent in its reasonable discretion, the occurrence in each Offshore CNY Centre of any event that makes it impossible (where it had previously been possible) for the Issuer to transfer CNY (a) between accounts inside the Offshore CNY Centre, (b) from an account inside the Offshore CNY Centre to an account outside such Offshore CNY Centre and outside mainland China or (c) from an account outside an Offshore CNY Centre and outside mainland China to an account inside the Offshore CNY Centre. For the purpose of CNY Non-Transferability and Hong Kong as an Offshore CNY Centre only, a segregated Chinese Renminbi fiduciary cash account with the People's Bank of China and operated by Bank of China (Hong Kong) Limited shall be deemed to be an account inside Hong Kong.
  - "CNY Notes" means Notes denominated in CNY or Renminbi deliverable in Hong Kong, or such other CNY Centre as specified in the applicable Final Terms or Pricing Supplement.
  - "Hong Kong Business Day" means any day, other than a Saturday or a Sunday, that is neither a legal holiday nor a day on which banking institutions are authorised or required by law or regulation to close in Hong Kong.
  - "Non-Deliverable Substitute Settlement Date" means, in respect of any payment date determined pursuant to the terms herein, subject to adjustment in accordance with the provisions of Condition 25.1(a) (CNY Disruption Events) and/or any Business Day Convention applicable to the terms of an Affected CNY Note, the day determined by the Determination Agent which shall be as soon as practicable, but in no event later than two Hong Kong Business Days after the date on which the USD/CNY Spot Rate is determined.
  - "Offshore CNY Centre" means Hong Kong, or such other CNY Centre as specified in the applicable Final Terms or Pricing Supplement.

"USD/CNY Spot Rate" means the Chinese Renminbi/U.S. dollar official fixing rate, expressed as the amount of Chinese Renminbi per one U.S. dollar, for settlement in two Hong Kong Business Days reported by the Treasury Markets Association which appears on Reuters page <CNHFIX=> at approximately 11:15 a.m., Hong Kong time (the "Spot USD/CNY(HK) Fixing"). In the event that the Spot USD/CNY(HK) Fixing is not available, the Determination Agent may in its reasonable discretion (a) delay the determination of the USD/CNY Spot Rate until such day that the Spot USD/CNY(HK) Fixing is available or (b) determine the USD/CNY spot rate in its reasonable discretion.

For the avoidance of doubt, references to "general CNY exchange market in each Offshore CNY Centre" in the definitions of CNY Illiquidity and CNY Inconvertibility refers to purchase, sale, lending or borrowing of CNY for general purpose (including, but not limited to, funding), and therefore any purchase or sale of CNY where such CNY is required by relevant laws or regulations for settlement of any cross-border trade transaction with an entity in mainland China, or any purchase or sale of CNY for personal customers residing in each such Offshore CNY Centre, would not be purchase or sale made in such general CNY exchange market.

#### 26. SUBSTITUTION

# 26.1 Substitution of Issuer with Morgan Stanley Group Entities

Subject to the conditions set out in this Condition 26 (*Substitution*), the Issuer may, at any time, without the consent of Noteholders, substitute a Subsidiary of Morgan Stanley in place of the Issuer as principal debtor under the Notes, provided that any Notes in respect of which such a substitution is effected will be fully and unconditionally guaranteed pursuant to a guarantee of Morgan Stanley as to the payment of principal of, premium, interest and supplemental amounts, if any, and any Additional Amounts on those Notes when and as the same will become due and payable, whether at maturity or otherwise, and provided further that, under the terms of the guarantee, Noteholders will not be required to exercise their remedies against the substitute prior to proceeding directly against Morgan Stanley (as guarantor).

#### 26.2 Substitution of Issuer with Non Morgan Stanley Group Entities

Subject to the conditions set out in this Condition 26 (*Substitution*), the Issuer may, at any time, without the consent of the Noteholders, substitute for itself any entity which is not a Morgan Stanley Group entity, provided that such entity is, on the date of such substitution and in the opinion of the Issuer, of at least the equivalent creditworthiness (this will be deemed to be the case where the Substitute (defined below) has a long-term credit rating from at least one rating agency of standard application on the international capital markets (including, but not limited to, S&P, Moody's and Fitch) which is at least as high as the Issuer) to the Issuer.

#### 26.3 Conditions to Substitution

Substitution of the Issuer for another entity (the "Substitute") as provided in Condition 26.1 (Substitution of Issuer with Morgan Stanley Group Entities) or 26.2 (Substitution of Issuer with Non Morgan Stanley Group Entities) (as applicable) are subject to the following conditions:

- (a) the Substitute becoming party to the Issue and Paying Agency Agreement with any appropriate consequential amendments, as if it had been an original party to it in place of the Issuer;
- (b) the Substitute is validly existing under the laws under which it is established or incorporated, has capacity to assume all rights, obligations and liabilities under the Notes, receipts, coupons, and has obtained all necessary corporate authorisations to assume all such rights, obligations and liabilities under the Notes;
- (c) the Substitute has obtained all necessary governmental or regulatory approvals and consents for the performance by it of its obligations in connection with the Notes and that all such approvals and consents are in full force and effect;
- (d) in the case of substitution of the Issuer pursuant to Condition 26.2 (Substitution of Issuer with Non Morgan Stanley Group Entities) only:
  - (i) the Substitute and the Issuer having obtained legal opinions from independent legal advisers of recognised standing in the country of incorporation of the

Substitute and in New York that the obligations of the Substitute under the Notes are legal, valid and binding obligations of the Substitute; and

- (ii) if the relevant Notes are rated at the relevant time, the Substitute has obtained, prior to the substitution date, a written confirmation from the relevant rating agencies that the substitution will not result in whole or in part in a withdrawal, downgrading, placement in creditwatch or negative outlook of the Notes;
- (e) all consents and approvals as required have been obtained and that the Substitute and the Notes comply with all applicable requirements of the Securities Act;
- (f) the Fiscal Agent has confirmed to the Issuer that it has completed its relevant "know your customer" requirements on the proposed Substitute;
- (g) such substitution being permitted by the rules of any stock exchange on which the Notes are listed and each such stock exchange confirming that, following the proposed substitution of the Substitute, the Notes will continue to be listed on such stock exchange;
- (h) no payment in respect of the Notes, receipts and coupons is overdue at the relevant time;
- (i) at the time of any such substitution, the Substitute is in a position to fulfil all payment obligations arising from or in connection with the Notes in freely convertible and transferable lawful money without the necessity of any taxes or duties to be withheld at source (except for any type of withholding taxes that would have applied to payments by the Issuer if the substitution did not occur), and to transfer all amounts which are required therefor to the Fiscal Agent without any restrictions; and
- (j) if appropriate, the Substitute appointing a process agent as its agent in England to receive service of process on its behalf in relation to any legal action or proceedings arising out of or in connection with the Notes.
- 26.4 Reference in the Conditions to the Issuer

In the event of a substitution pursuant to this Condition 26 (*Substitution*), any reference in the Conditions to the Issuer shall be construed as a reference to the entity substituted.

26.5 Notification to Noteholders

The Issuer shall as soon as reasonably practicable notify Noteholders of the substitution in accordance with Condition 19 (*Notices*).

26.6 No Obligation to have Regard to the Consequences of the Exercise of the Right of Substitution

In connection with the right of substitution under this Condition 26 (*Substitution*), the Issuer shall not be obliged to have regard to the consequences of the exercise of such right for individual Noteholders, provided that the Substitute indemnifies each holder of Notes, receipts and coupons against any tax, assessment or governmental charge imposed on such Noteholder or required to be withheld or deducted as a consequence of such substitution.

26.7 Tax Consequences of Substitution

If the Issuer substitutes an entity in place of the Issuer as principal debtor under the Notes, the tax consequences (including the withholding tax consequences) of holding the Notes may change. Except as provided in Condition 12.1 (*Additional Amounts*), if withholding is required on the Notes, no additional amounts will be required to be paid.

Investors should seek their own advice based upon their particular circumstances from an independent tax adviser.

The following are certain of the U.S. federal income and estate tax consequences of ownership and disposition of the Notes by Non-U.S. Holders (as defined below). This summary is based on the U.S. Internal Revenue Code of 1986, as amended (the "Code"), administrative pronouncements, judicial decisions and final, temporary and proposed Treasury regulations, all as of the date hereof, changes to any of which subsequent to the date of this Base Prospectus may affect the tax consequences described herein. This summary does not discuss all of the tax consequences that may be relevant to holders in light of their particular circumstances or to holders subject to special rules under U.S. federal tax laws, such as:

- persons other than Non-U.S. Holders and persons that have or have had a connection to the United States other than holding the Notes;
- non-resident alien individuals who have lost their U.S. citizenship, who have ceased to be treated as resident aliens; or
- corporations that are treated as personal holding companies, controlled foreign corporations or passive foreign investment companies.

Further, this discussion does not address U.S. gift, state, local, non-U.S. and other tax considerations.

As used herein, the term "Non-U.S. Holder" means a beneficial owner of a Note that is not a U.S. Holder (as defined below) and is not an entity or arrangement treated as a partnership for U.S. federal income tax purposes. A Non-U.S. Holder does not include a holder who is an individual present in the United States for 183 days or more in the taxable year of a disposition of a Note and who is not otherwise a resident of the United States for U.S. federal income tax purposes or, except as described below, any holder who holds a Note in connection with the conduct of a trade or business in the United States engaged in by such holder. Such a person is urged to consult his or her own tax advisers regarding the U.S. federal income tax consequences of acquiring, owning, exchanging or disposing of a Note.

If an entity or arrangement treated as a partnership for U.S. federal income tax purposes holds a Note, the tax treatment of a partner generally will depend upon the status of the partner and the activities of the partnership. Partners of entities or arrangements treated as partnerships for U.S. federal income tax purposes holding Notes should consult their tax advisers regarding the U.S. federal income tax consequences of acquiring, owning, exchanging or disposing of a Note.

As used herein, the term "U.S. Holder" means a beneficial owner of a Note that is:

- a citizen or individual resident of the United States;
- a corporation, including any entity treated as a corporation for U.S. federal income tax purposes, created or organized in or under the laws of the United States, any state thereof or the District of Columbia; or
- an estate or trust, the income of which is subject to U.S. federal income tax without regard to its source.

# **Income Tax**

Except as otherwise discussed in "Effectively Connected Income", "FATCA" and "

Backup Withholding and Information Reporting" below, a Non-U.S. Holder generally will not be subject to U.S. federal income tax, including withholding tax, on payments of principal or interest (including original issue discount, if any) on a Note, or on proceeds from the sale, exchange or other disposition of a Note, **provided that** for U.S. federal income tax purposes:

#### **United States Federal Taxation**

- the Note is treated as indebtedness of the Issuer;
- the Non-U.S. Holder does not own (directly, indirectly or by attribution) 10 per cent. or more of the total combined voting power of all classes of stock of the Issuer entitled to vote;
- the Non-U.S. Holder is not a controlled foreign corporation for U.S. federal income tax purposes related, directly or indirectly, to the Issuer through stock ownership;
- the Non-U.S. Holder is not a bank holding the Note in the context of an extension of credit made pursuant to a loan agreement entered into in the ordinary course of its trade or business; and
- the Non-U.S. Holder (and any intermediary) have complied with all U.S. tax identification and certification requirements.

Certification Requirement. The certification requirements referred to in the preceding paragraphs will be fulfilled if the Non-U.S. Holder (and any intermediary) furnishes the U.S. Internal Revenue Service ("IRS") Form W-8BEN or W-8BEN-E (or with respect to certain intermediaries and beneficial owners, other appropriate forms), on which, among other things, the Non-U.S. Holder certifies under penalties of perjury that it is not a United States person, as defined in the Code.

Payments of interest (including original issue discount, if any) on the Notes that do not qualify for the exception to U.S. federal income and withholding tax discussed above and that are not effectively connected with a Non-U.S. Holder's conduct of a trade or business in the United States generally will be subject to 30 per cent. U.S. federal withholding tax, unless a U.S. income tax treaty applies to reduce or eliminate withholding and the Non-U.S. Holder complies with applicable certification requirements.

#### **Effectively Connected Income**

If interest on or gain from a Note is effectively connected with a Non-U.S. Holder's conduct of a U.S. trade or business (and, if required by an applicable income tax treaty, is attributable to a U.S. permanent establishment or fixed base), the Non-U.S. Holder will generally be taxed on income or gain from the Notes in the same manner as a U.S. taxpayer and will be subject to certain reporting obligations. Such Non-U.S. Holder will be required to provide a properly executed IRS Form W-8ECI in order to claim an exemption from withholding tax on interest. A Non-U.S. Holder that holds Notes in connection with a U.S. trade or business should consult its tax adviser with respect to the U.S. tax consequences of owning and disposing of Notes, including the possible imposition of a branch profits tax at a rate of 30% (or a lower treaty rate) in the case of a corporate Non-U.S. Holder.

#### **Estate Tax**

Subject to benefits provided by an applicable estate tax treaty, a Note that is treated as indebtedness for U.S. federal income tax purposes will generally be excluded from the gross estate of an individual Non-U.S. Holder for U.S. federal estate tax purposes upon the individual's death unless, at such time, interest payments on the Note would have been:

- subject to U.S. federal withholding tax without regard to any certification that such Non-U.S.
   Holder is not a United States person, as defined in the Code, not taking into account an elimination of such U.S. federal withholding tax due to the application of an income tax treaty; or
- effectively connected with the conduct by the Non-U.S. Holder of a U.S. trade or business.

### **FATCA**

Sections 1471 through 1474 of the Code (including U.S. Treasury regulations promulgated thereunder), an agreement entered into with the IRS pursuant to such sections of the Code or an intergovernmental agreement (an "IGA") between the United States and another jurisdiction in furtherance of such sections of the Code (including any non-U.S. laws and regulations implementing such an IGA) (collectively referred to as "FATCA") impose an information reporting regime and potentially a 30 per cent. withholding tax with respect to certain payments to (i) any non-U.S. financial institution (a "foreign financial institution" or "FFI" (as defined by FATCA)) that does not become a "Participating FFI" by entering into an agreement with the IRS to provide the IRS with certain information in respect of its account holders and investors, unless otherwise exempt from or deemed to be in compliance with FATCA or, where applicable, the FFI complies with any local laws enacted in respect of an IGA and (ii) any investor that (unless otherwise exempted) does not provide certain tax certifications or ownership

information (or, if applicable, a waiver of any laws prohibiting disclosure of such information to a taxing authority). The Issuer and most financial intermediaries will be subject to the requirements imposed under FATCA.

Withholding (if applicable) currently applies to payments of interest or other fixed or determinable annual or periodical income ("FDAP income") from sources within the United States. The FATCA legislation imposes withholding also on payments of gross proceeds of the disposition of financial instruments that provide for U.S.-source interest. However, under proposed regulations (the preamble to which specifies that taxpayers are permitted to rely on them pending finalization) no withholding will apply to payments of gross proceeds (other than amounts treated as FDAP income).

The United States and a number of jurisdictions have entered into IGAs to facilitate the implementation of FATCA. Payee financial institutions that are resident in a country that has entered into an IGA generally are required to comply with such country's FATCA implementing laws, which may not require that the financial institution enter into an agreement with the IRS. In such case, such country's FATCA implementing laws generally require the financial institution to collect and report certain information on its account holders to the relevant taxing authority of such country, which will send such information to the IRS.

In the event that the Issuer or an intermediary is required to deduct a withholding tax under FATCA, neither the Issuer, nor any intermediary will be required to pay any additional amounts with respect to the amounts so withheld. Each potential purchaser of Notes should consult its own tax adviser to determine how FATCA may affect such investor in its particular circumstance.

#### **Backup Withholding and Information Reporting**

Information returns will be filed with the IRS in connection with payments on the Notes and may be filed in connection with the proceeds from a sale, exchange or other disposition of the Notes. A Non-U.S. Holder may be subject to backup withholding in respect of amounts paid to the Non-U.S. Holder, unless such Non-U.S. Holder complies with applicable certification procedures to establish that it is not a United States person for U.S. federal income tax purposes or otherwise establishes an exemption from backup withholding. Compliance with the certification procedures described under "*Income Tax – Certification Requirement*" above will satisfy the certification requirements necessary to avoid backup withholding. Backup withholding is not an additional tax. The amount of any backup withholding from a payment to a Non-U.S. Holder will be allowed as a credit against the Non-U.S. Holder's U.S. federal income tax liability and may entitle the Non-U.S. Holder to a refund, provided that the required information is timely furnished to the IRS.

#### ITALIAN TAXATION

The following is a general description of current Italian law and practise mainly relating to the direct taxation of the Notes. The statements herein are based on the laws in force in Italy as at the date of this Base Prospectus and are subject to any changes in law occurring after such date, which changes could be made on a retroactive basis and could affect the continued validity of this summary. In this respect, one should consider that according to Italian Law 111, the Italian Tax Reform could in principle significantly change the statements set out below in this section. The precise nature, extent, and impact of these amendments cannot be quantified or foreseen with certainty at this stage as not all legislative decrees implementing the Italian Tax Reform have been enacted yet.

The following general description does not purport to be a comprehensive description of all the tax Italian considerations which may be relevant to a decision to subscribe for, purchase, own or dispose of the Notes and does not purport to deal with the tax consequences applicable to all categories of investors, some of which (such as dealers in securities) may be subject to special rules. This general description assumes that the Issuer is not a tax resident nor deemed to be a tax resident of Italy and that it has no permanent establishment within the Italian territory to which the Notes are effectively connected.

Prospective investors are advised to consult their own tax advisers concerning the overall tax consequences of their interest in the Notes.

#### Tax treatment of the Notes

As clarified by the Italian tax authorities, the Notes may be subject to different tax regimes depending on whether:

- (a) they represent derivative financial instruments or bundles of derivative financial instruments not entailing a "use of capital" (*impiego di capitale*), through which the Noteholders invests indirectly in underlying financial instruments (please see section 1 below); or
- (b) they represent a debt instrument implying a "use of capital" (*impiego di capitale*), through which the Noteholders transfer to the Issuer a certain amount of capital, for the economic exploitation of the same, subject to the right to obtain a (partial or entire) reimbursement of such amount at maturity. In particular, such Notes representing debt instruments implying a "use of capital" could be divided in: Notes having capital protection guaranteed by the Issuer (please see section 2 below) and Notes not having capital protection guaranteed by the Issuer, so called "atypical securities" (please see section 3 below).

# 1. Notes representing derivative financial instruments or bundles of derivative financial instruments

With regard to certain innovative or structured financial instruments, there is limited guidance as to the tax treatment of such financial instruments. Accordingly, it cannot be excluded that the Italian tax authorities will change their current view, as specified below, and courts will adopt a view different from that outlined below.

This description assumes that the Issuer is not a tax resident nor deemed to be a tax resident of Italy and that it has no permanent establishment within the Italian territory.

# 1.1 Italian resident Noteholders

#### Taxation of income from derivatives

If the Notes qualify as derivative instruments for the purposes of Italian tax law, the following consequences apply to an Italian resident Noteholder pursuant to Article 67(1)(c-quater) and/or (c-quinquies) of Italian Presidential Decree No. 917 of 22 December 1986, as subsequently amended ("Decree No. 917"), and according to, inter alia, the Italian tax authority's Resolution no. 72/E of 12 July 2010.

In particular, according to Italian Legislative Decree No. 461 of 21 November 1997 ("**Decree No. 461**""), where an Italian resident Noteholder is: (i) an individual not engaged in an entrepreneurial activity to which the Notes are connected; (ii) a non-commercial partnership; (iii) a non-commercial private or public institution or (iv) an investor exempt from Italian corporate income taxation, derivative income realised on the sale or redemption of the Notes are subject to a 26 per cent. substitute tax ("**imposta sostitutiva**").

In this respect, the above Italian resident Noteholders may opt for three different taxation regimes (*regime della dichiarazione, regime del risparmio amministrato, regime del risparmio gestito*, in this respect please see par. 2.2 "*Capital gains*" below). This option may result in certain impacts that the investors should consider with their tax advisers. In particular, provided that the relevant conditions are met, the depository is responsible for accounting for imposta sostitutiva and is required to pay the relevant amount to the Italian tax authorities on behalf of the taxpayer, deducting a corresponding amount from the proceeds to be credited to the Noteholder or using funds provided by the Noteholder for this purpose. Under certain conditions, capital losses may be deducted from the above-mentioned capital gains.

Subject to certain limitations and requirements (including a minimum holding period), Italian resident individuals holding the Notes not in connection with an entrepreneurial activity or social securities entities pursuant to Legislative Decree No. 509 of 30 June 1994 and Legislative Decree No. 103 of 10 February 1996 may be exempt from the imposta sostitutiva on Italian capital gains relating to the Notes if the Notes are included in a long-term savings account (*piano di risparmio a lungo termine*) that meets the requirements set forth in Article 1(100-114) of Law No. 232 of 11 December 2016, as subsequently amended and supplemented (the "Finance Act 2017"), in Article 1 (210-215) of Law No. 145 of 30 December 2018 (the "Finance Act 2019"), or in Article 13-*bis* of Law Decree No. 124 of 26 October 2019 converted into Law No. 157 of 19 December 2019, (the "Fiscal Decree linked to the Finance Act 2020"), Article 136 of Law Decree No. 34 of 19 May 2020, converted into Law No. 77 of 17 July 2020, as subsequently amended and supplemented (the "Decree No. 34"), Article 1 (219-225) of Law No. 178 of 30 December 2020, as subsequently amended and supplemented (the "Finance Act 2021"), Article 1 (26-27) Law No. 234 of 2021, as subsequently amended and supplemented (the "Finance Act 2022") and Article 8-quinquies of Law Decree No. 145 of 18 October 2023, converted into Law No. 191 of 15 December 2023 as subsequently amended and supplemented (the "Law Decree No. 145").

The imposta sostitutiva does not apply also to the following Italian resident taxpayers:

# (A) Corporate Investors

Where an Italian resident Noteholder is a company or similar commercial entity, or the Italian permanent establishment of a foreign commercial entity to which the Notes are effectively connected, capital gains arising from the Notes will not be subject to imposta sostitutiva, but must be included in the relevant Noteholder's income tax return and are therefore subject to Italian corporate tax ("IRES", currently applicable at a rate of 24 per cent. 36 with a 3,5 per cent. surcharge for banks and financial intermediaries) and, in certain cases, depending on the status of such holder, may also have to be included in its taxable base for regional tax purposes ("IRAP", currently applicable at the general rate of 3.9 per cent., though a surcharge up to 0.92 per cent. may be applicable from region to region). The IRAP rate may be increased in certain Italian regions; IRAP rate has also been increased by article 23(5) of Italian Law Decree no. 98 of 6 July 2011 to 4.65 per cent. for banks and other financial institutions and to 5.9 per cent. for the insurance companies as indicated, respectively, under article 6 and article 7 of Italian Legislative Decree no. 446 of 15 December 1997).

#### (B) Investment funds

Capital gains realised by a Noteholder which is an Italian open-ended or closed-ended investment fund (subject to the tax regime provided by Law No. 77 of 23 March 1983) (the "Investment Fund") or an Italian open-ended investment company (società di investimento a capitale variabile – "SICAV") or an Italian closed-ended investment company, other than a real estate investment company (società di investimento a capitale fisso – "SICAF") will neither be subject to imposta sostitutiva nor to any other income in the hands of the Investment Fund or the SICAV/SICAF. The proceeds distributed by the Investment Fund or the SICAV/SICAF or received by certain categories of unitholders upon redemption or disposal of the units will be taxed in the hands of the investors who subscribe the quotas of the Investment Funds or the shares of the SICAV/SICAF on a cash basis.

(C) Real estate investment funds and real estate SICAFs

Law No. 207 of 30 December 2024 (2025 Budget Law) introduced a provisional special reduction of the IRES rate to 20%, applicable, for the time being, exclusively for tax year 2025. Requirements to qualify for this reduction include, among others: (i) the taxpayer temporarily retaining at least 80% of its 2024 earnings for no less than two fiscal years, (ii) investing a certain amount in qualifying assets, which must be the greater of 30% of the 2024 retained earnings or 24% of the 2023 overall earnings, and (iii) sustaining or increasing certain levels of employment as defined by the law. Recapture mechanisms apply if the conditions for the tax rate reduction are not maintained or if the qualifying assets listed sub (ii) are transferred.

Capital gains realised by an investor which is an Italian resident real estate investment fund established pursuant to Article 37 of Legislative Decree No. 58 of 24 February 1998, as amended and supplemented, and Article 14-bis of Law No. 86 of 25 January 1994 ("Real Estate Fund") or an Italian real estate investment company (the "Real Estate SICAF") are subject neither to impost a sostitutiva nor to any other income in the hands of the same Real Estate Fund or Real Estate SICAF. The income of the Real Estate Fund or of the Real Estate SICAF may be subject to tax, in the hands of the unitholder/shareholder, depending on the status and percentage of participation.

#### (D) Pension funds

Capital gains realised by an Italian resident holder which is an Italian pension fund (subject to the regime provided by Article 17 of the Legislative Decree No. 252 of 5 December 2005 ("Decree No. 252") - "Pension Funds") will be included in the result of the relevant portfolio accrued at the end of the tax period, to be subject to a 20 per cent. ad hoc annual substitute tax ("Pension Fund Tax").

Subject to certain conditions (including minimum holding period requirement) and limitations, capital gains may be excluded from the taxable base of the Pension Fund Tax, pursuant to Article 1, paragraph 92, of the Finance Act 2017, if the Notes are included in a long-term savings account (*piano individuale di risparmio a lungo termine*) that meets the requirements set forth in Article 1 (100-114) of Finance Act 2017, in Article 1 (210-215) of the Finance Act 2019 or in Article 13-*bis* of the Fiscal Decree linked to the Finance Act 2020, Article 136 of the Decree No. 34, Article 1 (219-225) of the Finance Act 2021, Article 1 (26-27) of the Finance Act 2022 and Article 8-*quinquies* of Law Decree No. 145.

# 2. Notes representing debt instruments implying a "use of capital"; Notes having 100% capital protection guaranteed by the Issuer

#### 2.1 Taxation of interest

#### Italian resident Noteholders

Legislative Decree No. 239 of 1 April 1996 ("Decree No. 239") governs the tax treatment of interest, premiums and other income (including the difference between the redemption amount and the issue price) (hereinafter collectively referred to as "Interest") from Notes issued, inter alia, by non-Italian resident entities. The provisions of Decree No. 239 only apply to those Notes which qualify as *obbligazioni or titoli similari alle obbligazioni* pursuant to Article 44 paragraph 2, letter (c) of Decree No. 917.

Pursuant to Article 44, paragraph 2, letter (c) of Decree No. 917, Notes qualify as "bonds" or "debentures similar to bonds" for Italian tax purposes if they incorporate an unconditional obligation to pay, at maturity, an amount not less than the value indicated therein and do not give any right to directly or indirectly participate in the management of the relevant issuer or of the business in relation to which they are issued. The Italian tax authorities have clarified (please see Circular Letter No. 4/E of 18 January 2006) that bonds may have a maturity which is not scheduled at a specific date, but it is linked to the maturity of the issuing company or to the liquidation thereof, if the company has been set-up with an undetermined maturity pursuant to Article 2328 (2), No. 13, of the Italian Civil Code.

Interest on the Notes is subject to a 26 per cent. substitute tax (*imposta sostitutiva*) if the recipient is included among the following categories of Italian residents: (i) individuals not engaged in an entrepreneurial activity to which the Notes are effectively connected; (ii) non-commercial partnerships; (iii) non-commercial private or public institutions; or (iv) entities that are exempt from IRES. The imposta sostitutiva may not be recovered as a deduction from the income tax due. In the event that the Noteholders described under (i) and (iii) above are engaged in an entrepreneurial activity to which the Notes are connected, the *imposta sostitutiva* applies as a provisional tax and it may be credited against the overall corporate income tax due by the taxpayer in respect of the income derived from its business activity which will include the Interest.

The 26 per cent. *imposta sostitutiva* does not apply where the Notes are held in a discretionary investment portfolio managed by an Italian authorised financial intermediary and the beneficial owner thereof, where possible, has opted to be taxed at a flat rate of 26 per cent. on the year-end increase in value of the investment portfolio accrued, even if not realised (which increase in value includes any Interest accrued on the Notes), pursuant to the so-called portfolio management tax regime ("**regime del risparmio gestito**" - as defined and described below) provided for by Decree No. 461.

Subject to certain limitations and requirements (including a minimum holding period), Italian resident individuals holding the Notes not in connection with an entrepreneurial activity or social security entities pursuant to Legislative Decree No. 509 of 30 June 1994 and Legislative Decree No. 103 of 10 February 1996 may be exempt from any income tax, including the *imposta sostitutiva*, on Interest relating to the Notes if the Notes are included in a long-term individual savings plan (*piano individuale di risparmio a lungo termine*) that meets the requirements set forth in Article 1 (100-114) of the Finance Act 2017, in Article 1 (210-215) of the Finance Act 2019 or in Article 13-bis of the Fiscal Decree linked to the Finance Act 2020, Article 136 of the Decree No. 34, Article 1 (219-225) of the Finance Act 2021, Article 1 (26-27) of the Finance Act 2022 and Article 8-quinquies of Law Decree No. 145.

Pursuant to Decree No. 239, the 26 per cent. *imposta sostitutiva* is applied by banks, SIMs, fiduciary companies, *società di gestione del risparmio* ("SGRs") stock brokers and other qualified entities identified by a decree of the Ministry of Finance ("Intermediaries" and each an "Intermediary") resident in Italy, or by permanent establishments in Italy of a non-Italian resident Intermediary, that intervene, in any way, in the collection of Interest or, also as transferees, in transfers or disposals of the Notes. For the purpose of the application of the *imposta sostitutiva*, a transfer of notes includes any assignment or other act, either with or without consideration, which results in a change of the ownership of the relevant securities or in a change of the Intermediary with which the notes are deposited.

Where the Notes are not deposited with an authorised Italian Intermediary (or with a permanent establishment in Italy of a foreign Intermediary), the *imposta sostitutiva* is applied and withheld by any Italian Intermediary paying Interest to the Noteholders.

The *imposta sostitutiva* does not apply also to the following Italian resident persons, to the extent that the Notes are deposited in a timely manner, directly or indirectly, with an Intermediary:

#### (A) Corporate Investors

Interest on the Notes received by (i) an Italian resident company or similar commercial entity; and (ii) an Italian permanent establishment of foreign entities to which the Notes are effectively connected; will not be subject to the *imposta sostitutiva*, but will be included in the taxable base for the purposes of IRES and – under certain circumstances – of IRAP, as described in section 1 above.

#### (B) Real estate investment funds and real estate SICAFs

Where a Noteholder is an Italian resident Real Estate Fund or an Italian Real Estate SICAF, to which the provisions of Law Decree No. 351 of 25 September, 2001, Law Decree No. 78 of 31 May 2010, converted into Law No. 122 of 30 July 2010, and Legislative Decree No. 44 of 4 March 2014, all as amended, apply Interest accrued on the Notes are subject neither to the *imposta sostitutiva* nor to any other income tax in the hands of the Real Estate Fund or Real Estate SICAF. The income of the Real Estate Fund or of the Real Estate SICAF may be subject to tax, in the hands of the unitholder/shareholder, depending on the status and percentage of participation.

### (C) Investment funds

Interest accrued on the Notes held by Italian Investment Funds, SICAVs, SICAFs is not subject to such imposta sostitutiva nor to any other income tax of the Investment Funds, or SICAVs/SICAFs, but is included in the aggregate income of the Investment Funds or SICAVs/SICAFs. The proceeds distributed by the Investment Fund or the SICAV/SICAF or received by certain categories of unitholders upon redemption or disposal of the units will be taxed in the hands of the investors who subscribe the quotas of the Investment Funds or the shares of the SICAV/SICAF on a cash basis.

#### (D) Pension funds

Interest accrued on the Notes held by Italian pension funds subject to the regime provided for by Article 17 of Decree No. 252 is not subject to such *imposta sostitutiva* but will be included in the result of the relevant portfolio accrued at the end of the tax period, to be subject to the Pension Fund Tax. Subject to certain conditions (including a minimum holding period) and limitations, pursuant to Article 1, paragraph 92, of the Finance Act 2017, Interest accrued on the Notes may be excluded from the taxable base of the Pension Fund Tax if the Notes are included in a long-term individual savings plan (*piano individuale di risparmio a lungo termine*) that meets the requirements set forth under Article 1 (100-114) of the Finance Act 2017, in Article 1 (210-215) of the Finance Act 2019 or in Article 13-bis of the Fiscal Decree linked

to the Finance Act 2020, Article 136 of the Decree No. 34, Article 1 (219-225) of the Finance Act 2021, Article 1 (26-27) of the Finance Act 2022 and Article 8-quinquies of Law Decree No. 145.

#### 2.2 Taxation of Capital Gains

#### Italian resident Noteholders

A 26 per cent., imposta sostitutiva is applicable on capital gains realised on the disposal of the Notes by the Noteholders included among the following categories of Italian residents: (i) individuals not engaged in an entrepreneurial activity to which the Notes are effectively connected; (ii) non-commercial partnerships; and (iii) non-commercial private or public institutions.

In respect of the application of the imposta sostitutiva, such taxpayers may opt for one of the three regimes described below.

- Under the "regime della dichiarazione" provided for by Article 5 of Decree No. 461 (the "Tax Declaration Regime"), which is the standard regime for Italian resident individuals not engaged in an entrepreneurial activity to which the Notes are effectively connected, the 26 per cent. imposta sostitutiva will be chargeable, on a cumulative basis, on all capital gains, net of any incurred capital loss, realised by the Italian resident individual holding the Notes not in connection with an entrepreneurial activity pursuant to all disposals of the Notes carried out during any given tax year. Italian resident individuals holding the Notes not in connection with an entrepreneurial activity must indicate the overall capital gains realised in any tax year, net of any relevant incurred capital loss in the annual tax return and the imposta sostitutiva must be paid on such gains together with any balance income tax due for such year. Capital losses in excess of capital gains may be carried forward against capital gains realised in any of the four succeeding tax years;
- (b) as an alternative to the tax declaration regime, Noteholders listed above may elect to pay under the "risparmio amministrato" regime provided for by Art. 6 of Decree No. 461 (the "Administrative Savings Regime") the imposta sostitutiva separately on capital gains realised on each sale or redemption of the Notes. Such separate taxation of capital gains is allowed subject to (i) the Notes being deposited with Italian banks, "società di intermediazione mobiliare" ("SIMs") or certain authorised financial intermediaries and (ii) an express election for the Administrative Savings Regime being timely made in writing by the relevant Noteholder. The depository is responsible for accounting for imposta sostitutiva in respect of capital gains realised on each sale or redemption of the Notes (as well as in respect of capital gains realised upon the revocation of its mandate), net of any incurred capital loss, and is required to pay the relevant amount to the Italian tax authorities on behalf of the taxpayer, deducting a corresponding amount from the proceeds to be credited to the Noteholders or using funds provided by the Noteholders for this purpose. Under the Administrative Savings Regime, where a sale or redemption of the Notes results in a capital loss, such loss may be deducted from capital gains subsequently realised, within the same securities management, in the same tax year or in the following tax years up to the fourth. Under the risparmio amministrato regime, the Noteholder is not required to declare the capital gains in the annual tax return;
- any payments received and any capital gains accrued by the Noteholders listed above who have entrusted the management of their financial assets, including the Notes, to an authorised intermediary and have opted for the so-called "risparmio gestito" regime provided for by Art. 7 of Decree No. 461 (the "Asset Management Regime") will be included in the computation of the annual increase in value of the managed assets accrued, even if not realised, at year end, subject to a 26 per cent. substitute tax, to be paid by the managing authorised intermediary. Under the Asset Management Regime, any depreciation of the managed assets accrued at year end may be carried forward against increase in value of the managed assets accrued in any of the four succeeding tax years. Under the Asset Management Regime, the Noteholder is not required to declare the capital gains realised in the annual tax return.

Subject to certain limitations and requirements (including a minimum holding period), Italian resident individuals holding the Notes not in connection with an entrepreneurial activity pursuant to Legislative Decree No. 509 of 30 June 1994 and Legislative Decree No. 103 of 10 February 1996 may be exempt from Italian capital gain taxes, including the 26 per cent. imposta sostitutiva, on capital gains realised

upon sale or redemption of the Notes if the Notes are included in a long-term savings account (*piano di risparmio a lungo termine*) that meets the requirements set forth in Article 1 (100-114) of Finance Act 2017, in Article 1 (210-215) of the Finance Act 2019, in Article 13-*bis* of the Fiscal Decree linked to Finance Act 2020, Article 136 of the Decree No. 34, Article 1 (219-225) of the Finance Act 2021, Article 1 (26-27) of the Finance Act 2022 and Article 8-*quinquies* of Law Decree No. 145.

The imposta sostitutiva does not apply also to the following Italian-resident taxpayers:

#### (A) Corporate Investors

Any capital gains obtained from the sale or redemption of the Notes will not be subject to imposta sostitutiva but would be treated as part of the IRES taxable income and, in certain circumstances, depending on the status of the Noteholder, also as part of the net value of the production for IRAP purposes if realised by (i) an Italian company or a similar commercial entity; (ii) an Italian permanent establishment of foreign entities to which the Notes are connected).

# (B) Real estate investment funds and real estate SICAFs

Any capital gains realized by a Noteholder which is an Italian Real Estate Fund or an Italian Real Estate SICAF to which the provisions of Law Decree No. 351 of 25 September, 2001, Law Decree No. 78 of 31 May 2010, converted into Law No. 122 of 30 July 2010, and Legislative Decree No. 44 of 4 March 2014, all as amended, apply are subject neither to impost a sostitutiva nor to any other income tax in the hands of the Real Estate Fund or the Real Estate SICAF. The income of the Real Estate Fund or of the Real Estate SICAF may be subject to tax, in the hands of the unitholder/shareholder, depending on the status and percentage of participation.

#### (C) Investment funds

Any capital gains realised by a Noteholder which is an Italian Investment Fund, a SICAV or a SICAF will neither be subject to impost asostitutiva nor to any income tax in the hands of the Investment Fund or of the SICAV/SICAF. The proceeds distributed by the Investment Fund or the SICAV/SICAF or received by certain categories of unitholders upon redemption or disposal of the units will be taxed in the hands of the investors who subscribe the quotas of the Investment Funds or the shares of the SICAV/SICAF on a cash basis.

#### (D) Pension funds

Any capital gains realised by a Noteholder which is an Italian pension fund (subject to the regime provided for by Article 17 of Decree No. 252) will be included in the result of the relevant portfolio accrued at the end of the tax period, to be subject to the 20 per cent. Pension Fund Tax.

Subject to certain conditions (including minimum holding period requirement) and limitations, capital gains realised through the transfer for consideration or redemption of the Notes may be excluded from the taxable base of the Pension Funds, pursuant to Article 1, paragraph 92, of the Finance Act 2017, if the Notes are included in a long-term individual savings plan (*piano individuale di risparmio a lungo termine*) pursuant to Article 1 (100-114) of the Finance Act 2017, Article 1 (210-215) of the Finance Act 2019 or in Article 13-*bis* of the Fiscal Decree linked to Finance Act 2020, Article 136 of the Decree No. 34, Article 1 (219-225) of the Finance Act 2021, Article 1 (26-27) of the Finance Act 2022 and Article 8-*quinquies* of Law Decree No. 145.

# 3. Notes not having capital protection guaranteed by the Issuer (Atypical Securities) 3.1 Taxation of interest

#### Italian resident Noteholders

Interest payments relating to Notes that are not deemed to fall within the category of bonds (*obbligazioni*) or debentures similar to bonds (*titoli similari alle obbligazioni*) may be subject to a withholding tax, (final or on account depending on the "status" and tax residence of the Noteholder) levied at the rate of 26 per cent by the Italian tax resident financial intermediary intervening in the payment of the Interest, if any.

If the Notes are issued by a non-Italian resident Issuer, the 26 per cent. withholding tax mentioned above does not apply as a final tax to Interest payments made to an Italian resident Noteholder which is (i) a company or similar commercial entity (including the Italian permanent establishment of foreign entities to which the Notes are effectively connected), (ii) a commercial partnership or (iii) a commercial private or public institution. According to Italian tax law, in similar cases, the withholding tax, if any, qualifies as a provisional withholding tax.

Subject to certain limitations and requirements (including a minimum holding period), Interest in respect of Notes received by Italian resident individuals holding the Notes not in connection with an entrepreneurial activity or social security entities pursuant to Legislative Decree No. 509 of 30 June 1994 and Legislative Decree No. 103 of 10 February 1996 may be exempt from taxation, including the withholding tax on interest, premium and other income relating to atypical securities, if those Notes are included in a long-term individual savings plan (*piano individuale di risparmio a lungo termine*) that meets the requirements set forth in Article 1 (100–114) of the Finance Act 2017, as subsequently amended and supplemented, in Article 1 (210-215) of the Finance Act 2019, as subsequently amended and supplemented, Article 13-bis of the Fiscal Decree linked to the Finance Act 2020, as subsequently amended and supplemented, Article 136 of the Decree No. 34, Article 1 (219-225) of the Finance Act 2021, Article 1 (26-27) of the Finance Act 2022 and Article 8-quinquies of Law Decree No. 145.

# 3.2 Capital gains

The same regime as under paragraph 2.2 above should be applicable mutatis mutandis.

#### 4. Stamp duty

The Italian Law Decree No. 201 of 6 December 2011 ("Decree No. 201"), converted into law with amendments by Law No. 214 of 22 December 2011, has replaced the paragraphs 2-bis and 2-ter and related notes (3-bis and 3-ter) of Article 13 of the first part of the Tariff annexed to stamp duty Law approved with Presidential Decree No. 642 of 26 October 1972.

Pursuant to Article 13 (2-ter) of the first part of the Tariff annexed to stamp duty law approved with Presidential Decree No. 642 of 26 October 1972, statements sent to customers by banks and financial intermediaries and related to certain financial products and instruments, including those not deposited, are subject to stamp duty at the rate of 0.20 per cent. The maximum amount due is set at euro 14,000 for Noteholders other than individuals.

The tax is applied to each statement, on the total market value, or in its absence, on the face or repayment value of securities and financial products. The statement is considered to be sent at least once a year, even for instruments for which is not mandatory nor the deposit nor the release or the drafting of the statement. In case of reporting periods of less than 12 months, the stamp duty is payable pro rata. Based on the wording of the law and the implementing decree issued by the Italian Ministry of Finance on 24 May 2012, the stamp duty applies to any investor who is a client (as defined in the regulations issued by the Bank of Italy on 20 June 2012, as subsequently amended and supplemented from time to time) of an entity that exercises in any form a banking, financial or insurance activity within the Italian territory. The stamp duty applies both to Italian resident Noteholders and to non-Italian resident Noteholders, to the extent that the Notes are held with an Italian based financial intermediary (and not directly held by the Noteholders outside Italy), in which case the wealth tax (see "—Wealth Tax on securities deposited abroad) applies to Italian resident Noteholders only.

# 5. Wealth tax on securities deposited abroad

Pursuant to Article 19, paragraphs 18 to 23, of Decree No. 201, Italian resident individuals, non-profit entities and certain partnership including *società semplici* or similar partnerships in accordance with Article 5 of Decree No. 917 holding the Notes outside the Italian territory without the involvement of an Italian financial intermediary are required to pay a wealth tax at a rate of 0.20 per cent (the level of tax being determined in proportion to the period of ownership). The maximum amount due is set at Euro 14,000 for Noteholders other than individuals. Starting from January 1, 2024, the wealth tax applies at a rate of 0.4 per cent. if the Notes are held in a country listed in the Italian Ministerial Decree dated 4 May 1999, pursuant to the provisions of Law No. 213/2023.

The tax is calculated on the fair market value of the Notes at the end of the relevant year or, in the case the fair market value cannot be determined, on their nominal values or redemption values or, in the case the face or redemption values cannot be determined, on the purchase value of any financial asset (including banking bonds, *obbligazioni* and capital adequacy financial instruments) held abroad by

Italian resident individuals. A tax credit is granted for any foreign property tax levied abroad on such financial assets.

Financial assets (including the Notes) held abroad are excluded from the scope of the wealth tax if they are administered by Italian financial intermediaries pursuant to an administration agreement and the items of income derived from such instruments have been subject to tax by the same intermediaries. In this case, the below mentioned stamp duty provided for by Article 13(2-ter) of the first part of the Tariff attached to Presidential Decree No. 642 of 26 October 1972 does apply.

### 6. Inheritance and Gift Tax

Pursuant to Italian Law Decree No. 262 of 3 October 2006, as converted with amendments by Law No. 286 of 24 November 2006, inheritance and gift taxes have been re-introduced in Italy, with effect as of 3 October 2006.

Inheritance and gift taxes apply according to the following rates and exclusions:

- (a) if assets (including money) pass to a spouse, as well as to any linear descendent, tax is levied at a rate of 4 per cent. The tax applies to the value of the assets (net of liabilities) left to each heir/beneficiary which exceeded euro 1,000,000;
- (b) assets (including money) pass to a relative within the fourth degree or to a linear relative-inlaw, as well as to a collateral relative within the third degree, tax is levied at a rate of 6 per cent. The tax applies to the value of the assets (net of liabilities) exceeding euro 100,000 if assets are left to a brother or sister;
- (c) 8 per cent. in all other cases.

If the transfer is made in favour of persons affected by a handicap deemed as "critical" pursuant to Law No. 104 of 5 February 1992, inheritance and gift taxes apply only on the value exceeding euro 1,500,000.

Under Article 1 (114) of the Finance Act 2017, as subsequently amended and supplemented, the mortis causa transfer of financial instruments included in a long-term savings account (*piano individuale di risparmio a lungo termine*) that meets the requirements set forth in Article 1(100-114) of the Finance Act 2017, Article 1 (210-215) of the Finance Act 2019 or Article 13-bis of the Fiscal Decree linked to Finance Act 2020, Article 136 of the Decree No. 34, Article 1 (219-225) of the Finance Act 2021, Article 1 (26-27) of the Finance Act 2022 and Article 8-*quinquies* of Law Decree No. 145 are exempt from inheritance and gift taxes. As of 1 January 2025, inheritance and gift tax are subject to the new provisions of the Legislative Decree no. 139 of 18 September 2024, which are, though, not foreseen to have impacts on the above-described provisions.

#### 7. Tax monitoring obligations

Pursuant to Italian Law Decree No. 167 of 28 June 1990, as amended by Law No. 97 of 6 August 2013 and by Law No. 50 of 28 March 2014, individuals, non-profit entities and certain partnerships (in particular, *società semplici* or similar partnerships in accordance with Article 5 of Decree No. 917) resident in Italy are required to report in their yearly income tax declaration, for tax monitoring purposes, the amount of Notes held abroad during each tax year.

The requirement applies also where the persons above, being not the direct holder of the financial instruments, are the beneficial owner of the instrument for anti-money laundering purposes. The above reporting is not required to be complied with respect to Notes deposited for management with qualified Italian intermediaries and with respect to contracts entered into through their intervention, provided that the financial flows and income derived from the Notes are subject to tax by the same intermediaries.

#### 8. EU Directive on Administrative Cooperation in the field of Taxation

On 9 July 2015, the Italian Parliament adopted Law No. 114 delegating the Italian Government to implement in Italy certain EU Council Directives, including Council Directive 2011/16/EU on Administrative Cooperation in the field of Taxation (as amended by Council Directive 2014/107/EU). Such Directive is aimed at broadening the scope of the operational mechanism of intra-EU automatic exchange of information in order to fight cross-border tax fraud and evasion. The Italian government implemented the above-mentioned Council Directive 2014/107/EU in the Ministerial Decree issued by the Ministry of Finance on 28 December 2015, as amended by the Ministerial Decree of 17 January 2017. Following the Ministerial Decree quoted, the Italian tax authorities may communicate to other EU

member states information about interest and other categories of financial income of Italian source, including income from the Notes.

Furthermore, the Italian Government implemented the later changes to the Council Directive 2011/16/EU, including the changes introduced by the Council Directive 2376/2015/EU on the mandatory automatic exchange of information on advance cross-border rulings and advance pricing arrangements, through the issue of the Legislative Decree 15 March 2017, no. 32, and by the Council Directive 2016/2258/EU as regards access to anti-money-laundering information by tax authorities, through the issue of the Legislative Decree 18 May 2018, no. 60.

#### 9. Financial Transaction Tax

Pursuant to Article 1 (491-500) of Law No. 228 of 24 December 2012, an Italian financial transaction tax ("FTT") applies to (a) transfer of property rights in shares and other participating securities issued by Italian resident companies or of financial instruments representing the mentioned shares and/or participating securities (irrespective of whether issued by Italian resident issuers or not) (the Relevant Securities), (b) transactions on financial derivatives (i) the main underlying assets of which are the Relevant Securities, or (ii) whose value depends mainly on one or more Relevant Securities, as well as to (c) any transaction on certain securities (i) which allow to mainly purchase or sell one or more Relevant Securities or (ii) implying a cash payment determined with main reference to one or more Relevant Securities.

Certain Notes could be included in the scope of application of the FTT if they meet the requirements set out above. On the other hand, Notes falling within the category of bonds (*obbligazioni*) or debentures similar to bonds (*titoli similari alle obbligazioni*) are not included in the scope of the FTT.

The FTT on derivative instruments is levied at a fixed amount that varies depending on the nature of the relevant instrument and the notional value of the transaction, and ranges between Euro 0.01875 and Euro 200 per transaction. The amount of FTT payable is reduced to 1/5 of the standard rate in case the transaction is performed on regulated markets or multilateral trading facilities of certain EU and EEA member states. The FTT on derivatives is due by each of the parties to the transactions. FTT exemptions and exclusions are provided for certain transactions and entities.

The FTT is levied and paid by the subject (generally a financial intermediary) that is involved, in any way, in the execution of the transaction. Intermediaries which are not resident in Italy but are liable to apply the FTT can appoint an Italian tax representative for the purposes of the FTT. If no intermediary is involved in the execution of the transaction, the FTT must be paid by the relevant taxpayers.

Investors are advised to consult their own tax advisers also on the possible impact of the FTT.

#### **SWISS TAXATION**

The following discussion is a summary of certain material Swiss tax considerations relating to (i) Notes issued by the Issuer where the Holder is tax resident in Switzerland or has a tax presence in Switzerland or (ii) Notes where the Paying Agent, custodian or securities dealer is located in Switzerland. The discussion is a summary based on legislation as of the date of this Base Prospectus. It does not aim to be a comprehensive description of all the Swiss tax considerations that may be relevant for a decision to invest in Notes. The tax treatment for each investor depends on the particular situation. All investors are advised to consult with their professional tax advisers as to the respective Swiss tax consequences of the purchase, ownership, disposition, lapse, exercise or redemption of Notes (or options embedded therein) in light of their particular circumstances.

# **Swiss Withholding Tax**

Payments under the Notes will not be subject to Swiss federal withholding tax, provided that the Issuer is at all times resident and managed outside Switzerland for Swiss tax purposes.

#### **Income Taxation**

#### Notes held as Private Assets by a Swiss resident Holder

#### Structured Notes

If a Note is classified as a structured note, its income taxation in Switzerland depends on whether the bond and the derivative financial instrument(s)embedded therein are recorded separately from each other and whether the Note is classified as a structured note with or without a predominant one-time interest payment (a structured note is classified as a note with a predominant one-time interest payment if the one-time interest payment exceeds the sum of the periodic interest payments):

Non-transparent Structured Notes: If the bond is not recorded separately from the embedded derivative financial instrument(s), the Note is classified as Non-transparent Structured Note and any return over the initial investment is classified as a taxable interest payment. Non-transparent Structured Notes generally include a predominant one-time interest payment and are taxed in accordance with the principles set forth below under "Bonds with a predominant one-time interest payment".

Transparent Structured Notes without a predominant one-time interest payment: If the bond is recorded separately from the embedded derivative financial instrument(s) and the yield-to-maturity predominantly derives from periodic interest payments and not from a one-time interest payment (see below "Transparent Structured Notes with a predominant one-time interest payment"), then any such periodic interest payment, and the non-predominant one-time interest payment, if any, is taxed when paid to the holder of the Note. A gain (including interest accrued) or a loss realised on the sale of such a Note is a tax-free private capital gain or a non-tax-deductible private capital loss, respectively (see below "Capital Gains, Notes held as Private Assets by a Swiss resident holder"). The same applies if such a Note is redeemed, except that interest accrued is taxed when paid.

Transparent Structured Notes with a predominant one-time interest payment: If the bond is recorded separately from the embedded derivative financial instrument(s) and if the yield-to-maturity predominantly derives from a one-time interest payment such as an original issue discount or a repayment premium and not from periodic interest payments, then any periodic interest payments constitute, and upon the redemption or sale of the Note, the difference between the value of the bond at redemption or sale, as applicable, and its value at issuance or secondary market purchase, as applicable, converted, in each case, into Swiss francs at the exchange rate prevailing at the time of redemption or sale, and at the time of issuance or purchase, respectively (modified differential taxation method), constitutes, taxable income. A value decrease on the bond realised on the redemption or sale of the Note may be offset against any gains (including periodic interest payments) realised within the same taxation period from all instruments with a predominant one-time interest payment. Any residual return realised on the embedded derivative financial instrument(s) is a tax-free private capital gain, and any residual loss is a non-tax-deductible private capital loss (see below "Capital Gains, Notes held as Private Assets by a Swiss resident holder").

### Bonds

#### **Swiss Taxation**

Bonds without a predominant one-time interest payment: If a Note is classified as a pure bond without a predominant one-time interest payment (the yield-to-maturity predominantly derives from periodic interest payments and not from a one-time-interest-payment), Swiss resident private investors will be taxed on the periodic and any one-time interest payments, if any, converted into Swiss francs at the exchange rate prevailing at the time of the relevant payment. A gain (including interest accrued) or a loss realised on the sale of such a Note is a tax-free private capital gain or a non-tax-deductible private capital loss, respectively (see below "Capital Gains, Notes held as Private Assets by a Swiss resident holder").

Bonds with a predominant one-time interest payment: If a Note is classified as a pure bond with a predominant one-time interest payment (the yield-to-maturity predominantly derives from a one-time-interest-payment such as an original issue discount or a repayment premium and not from periodic interest payments), Swiss resident private investors will be taxed on any periodic interest payments and on any gains (including capital and foreign exchange gains) realised on such Note (differential taxation method).

Certificates predominantly replicating interest bearing underlying, except actively managed certificates without a fixed maturity date (see below "Fund-like Instruments"), are classified as and taxed in accordance with the principles of Bonds.

#### Pure Derivative Financial Instruments

Periodic and one-time dividend equalisation payments realised on a Note that is classified as a pure derivative financial instrument and which is held as part of a holder's private assets constitute taxable investment income. Any other return on such a Note will be classified as a tax-exempt capital gain or a non-tax deductible capital loss (see below "Capital Gains, Notes held as Private Assets by a Swiss resident holder").

Pure Derivative Financial Instruments, for the avoidance of doubt, excluding Derivative Financial Instruments with an Interest Component (see below "Derivative Financial Instruments with an Interest Component"), include (i) call and put options, including options where the underlying is pre-financed by at least 50% at the time of issuance (Low Exercise Price Options) and with at maturity not exceeding one year, (ii) futures with a maturity not exceeding one year and a leverage of at least 4 at the time of issuance, and (iv) static certificates replicating an index or a basket of at least five non-interest bearing underlying and with a fixed maturity date or an annual redemption right.

#### Derivative Financial Instruments with an Interest Component

Notes, which are classified as Derivative Financial Instruments with an Interest Component and which are held as part of a holder's private assets bear a taxable interest component corresponding to the swap rate of the currency of the Notes. The interest component is taxed at redemption, or, if the Notes have no fixed maturity date, generally at 31.12. of each calendar year. Any other return on such a Note will be classified as a tax-exempt capital gain or a non-tax deductible capital loss (see below "Capital Gains, Notes held as Private Assets by a Swiss resident holder").

Pure Derivative Financial Instruments with an Interest Component include (i) Low Exercise Price Options with a maturity exceeding one year, (ii) futures on non-interest bearing underlying with a maturity exceeding one year and a leverage of below 4 at the time of issuance, (iii) futures on interest bearing underlying with a maturity not exceeding one year and a leverage of below 4 at the time of issuance, (iv) futures on interest bearing underlying with a maturity exceeding one year, and (v) static certificates replicating a basket of less than five non-interest bearing underlying and with a fixed maturity date or an annual redemption right.

## Fund-like Instruments

A Note, classified as a fund-like instrument, will be considered a pass-through instrument for Swiss tax purposes if dividend and interest income (less attributable costs) from, and capital gains and losses (less costs attributable) realised on, the underlying investments, are reported and distributed separately. Under such conditions, an individual holding a fund-like Note, as part of private assets only receives taxable income (which he or she must report annually) over such portion of the distributions (in case the fund is distributing the income realised on the underlying investments) or earnings credits (in case the fund is

reinvesting the income realised on the underlying investments) as derived from dividends and interest (less attributable costs) on the underlying instruments. Any distributions or credits deriving from capital gains realised on the underlying investments constitute a tax-free private capital gain and any respective loss on the underlying investments is a non-tax-deductible private capital loss. Any gain realised within a taxation period on the sale of a fund-like Note (including accrued dividends and interest) is exempt from income taxation as a private capital gain, and, conversely, any loss realised within a taxation period on the sale of a fund-like Note a non-tax-deductible capital loss (see below "Capital Gains, Notes held as Private Assets by a Swiss resident holder").

Fund-like Instruments include (i) certificates replicating one or a basket of collective investment schemes, (ii) actively managed certificates predominantly replicating non-interest bearing underlying, (iii) actively managed certificates predominantly replicating interest bearing underlying and without a fixed maturity date, (iv) static certificates predominantly replicating non-interest bearing, but including interest bearing underlying, and (v) static certificates replicating an index or a basket of at least five non-interest bearing underlying and without a fixed maturity date or an annual redemption right.

#### Notes held as Assets of a Swiss Business

Corporate entities and individuals who hold Notes as part of a trade or business in Switzerland, in the case of residents abroad carried on through a permanent establishment or a fixed place of business in Switzerland, are required to recognise any payments on, and any capital gains or losses realised on the sale or redemption of, such Notes (irrespective of their classification) in their income statement for the respective taxation period and will be taxed on any net taxable earnings for such period.

The same taxation treatment also applies to Swiss-resident individuals who, for income tax purposes, are classified as "professional securities dealers" for reasons of, *inter alia*, frequent dealing and leveraged investments in securities.

#### **Capital Gains Taxation**

#### Notes held as Private Assets by a Swiss resident Holder

Any gain or any loss realised by an individual resident in Switzerland for tax purposes upon the sale or other disposal of a Note held as part of his or her private assets is a tax-free private capital gain, or a non-tax deductible capital loss, respectively, unless such individual is classified, for income tax purposes, as a "professional securities dealer" for reasons of, *inter alia*, frequent dealing and leveraged investments in securities. If an individual is classified as "professional securities dealer" he or she will be taxed in accordance with the principles set forth above under "*Notes held as Assets of a Swiss Business*". In relation to the bifurcation of a tax-exempt capital gains component, or a non-tax deductible capital loss component from taxable income components of a Note, see the bifurcation principles set forth above with regard to the different instruments under "*Income Taxation, Notes held as Private Assets by a Swiss resident Holder*").

# Notes held as Assets of a Swiss Business

Capital gains realised on Notes held as part of a trade or business in Switzerland, are taxed in accordance with the taxation principles set forth above under "Income Taxation, Notes held as Assets of a Swiss Business").

# **Stamp Taxes**

#### **Swiss Federal Issue Stamp Tax**

The Notes are not subject to Swiss federal issue stamp tax on the issuance of securities.

#### **Swiss Federal Securities Turnover Tax**

The issuance of Notes are classified as Fund-like Instruments is subject to Swiss federal securities turnover tax of up to 0.3 per cent. on the consideration paid if a Swiss securities dealer (as defined in the Swiss federal stamp tax act) is a party or intermediary to the transaction and no exemption applies. The issuance of Notes classified other than Fund-like Instruments are not subject to Swiss federal securities turnover tax.

#### **Swiss Taxation**

Dealings in Notes that are classified as (i) Pure Derivative Financial Instruments or (ii) Bonds or Structured Notes or Derivative Financial Instruments with an Interest Component and with a maturity not exceeding one year are not subject to Swiss federal securities turnover tax.

Dealings in Notes which are classified as (i) Fund-like Instruments or (ii) Bonds or Structured Notes or Derivative Financial Instruments with an Interest Component and with a maturity exceeding one year are subject to Swiss federal securities turnover tax of up to 0.3 per cent. on the consideration paid if a Swiss securities dealer (as defined in the Swiss federal stamp tax act) is a party or intermediary to the transaction and no exemption applies.

The delivery of an underlying taxable security at exercise or redemption to the holder of the Note, is subject to Swiss federal securities turnover tax of up to 0.3 per cent. if a Swiss domestic securities dealer (as defined in the Swiss federal stamp tax act) is a party or intermediary to the transaction and no exemption applies.

#### Gift, Inheritance and Estate Taxes

Subject to an applicable tax treaty in an international situation, transfers of Notes may be subject to cantonal and/or communal inheritance tax, estate tax or gift tax if the deceased person has had his or her last domicile in Switzerland, the donor is resident in Switzerland, respectively, or in the case of a foreign deceased or resident person, the transfer involves an unincorporated business in Switzerland and Notes are held as part of such business. No such taxes exist at the federal level. Rates depend upon the existing relationship (i.e. the relationship between the deceased and the heirs, or between the donor and the donee) and the size of the inheritance or gift. Interspousal gifts and gifts to descendants, and inheritances collected by the surviving spouse and descendants are frequently exempt or taxed at low rates (up to 6 per cent.). Gifts and inheritances received from unrelated persons attract rates ranging from 20 per cent. to 40 per cent. The taxable base is usually the market value of the property transferred.

#### **Net Worth and Capital Taxes**

A holder of Notes, who is an individual resident in Switzerland, for tax purposes, or is a non-Swiss resident holding Notes, as part of a Swiss business operation or a Swiss permanent establishment, is required to report Notes as part of private wealth or as part of Swiss business assets, as the case may be, and is subject to annual cantonal and/or communal private wealth tax on any net taxable wealth (including the Notes), in the case of a non-Swiss resident individual holding Notes as part of a Swiss business operation or a Swiss permanent establishment, to the extent the aggregate taxable wealth is allocable to Switzerland. Incorporated holders of Notes are subject to cantonal and communal capital tax on net taxable equity, in the case of non-Swiss resident entities holding Notes as part of a Swiss permanent establishment, to the extent the aggregate taxable equity is allocable to Switzerland. No net worth and capital taxes exist at the federal level in Switzerland.

#### **Non-Swiss resident Holders**

A holder of a Note who is not resident in Switzerland for tax purposes and who during the taxation year has not engaged in a trade or business carried on through a permanent establishment or fixed place of business in Switzerland will in respect of such Note not be subject to income tax in Switzerland.

#### SUBSCRIPTION AND SALE

The Issuer is offering the Notes on a continuing basis through Morgan Stanley & Co. International plc of 25 Cabot Square, Canary Wharf, London E14 4QA (the "Distribution Agent"), who has agreed to use reasonable efforts to solicit, directly or through its affiliates, offers to purchase the Notes. The Issuer will have the sole right to accept offers to purchase Notes and may reject any offer in whole or in part. The Distribution Agent will have the right to reject any offer to purchase Notes solicited by it in whole or in part. Terms used in this paragraph have the meanings given to them in Regulation S. Each Distribution Agent has agreed that, at or prior to confirmation of sale of Notes, it will have sent to each distributor, dealer or person receiving a selling concession, fee or other remuneration that purchases Notes from a confirmation or notice to substantially the following effect:

"The securities covered hereby have not been registered under the United States Securities Act of 1933, as amended (the "Securities Act"), and may not at any time be offered or sold within the U.S. or to, or for the account or benefit of, any U.S. person as defined in Regulation S under the Securities Act ("Regulation S"). Terms used above have the meanings given to them by Regulation S."

Each Distribution Agent has represented that it has not entered and has agreed that it will not enter into any contractual arrangement with any distributor (as that term is defined in Regulation S) with respect to the distribution or delivery of the Notes, except with its affiliates or with the prior written consent of the Issuer. An offer or sale of Notes within the U.S. by any dealer (whether or not participating in the offering of such Notes) may violate the registration requirements of the Securities Act.

#### 2. Credit Ratings

Notes may or may not be rated. Any credit rating applied for in relation to an issue of Notes will be specified in the applicable Final Terms or Pricing Supplement. Whether or not such credit ratings applied for will be issued by a credit rating agency established in the European Union and registered under Regulation 1060/2009 of the European Parliament and of the Council of 16 September 2009 on credit rating agencies (the "CRA Regulation") will be disclosed in the Final Terms or Pricing Supplement. In general, European regulated investors are restricted from using a rating for regulatory purposes if such rating is not issued by a credit rating agency established in the European Economic Area ("EEA") and registered under the CRA Regulation unless (1) the rating is provided by a credit rating agency operating in the EEA before 7 June 2010 which has submitted an application for registration in accordance with the CRA Regulation and such registration has not been refused, or (2) the rating is provided by a credit rating agency not established in the EEA but is endorsed by a credit rating agency established in the EEA and registered under the CRA Regulation, or (3) the rating is provided by a credit rating agency not established in the EEA which is certified under the CRA Regulation. None of DBRS, Fitch, Moody's or S&P is established in the EEA or has applied for registration under the CRA Regulation. However, certain of their respective affiliates are established in the EEA and registered under the CRA Regulation. Such affiliates endorse the ratings of DBRS, Fitch, Moody's and S&P for use for regulatory purposes in the EEA.

R&I is not incorporated in the EEA and is not registered under the CRA Regulation.

The credit rating of Morgan Stanley's short-term and long-term debt is (i) R-1 (middle) and AA (low), with a stable outlook, by DBRS, Inc. ("**DBRS**") (ii) F1 and A+, with a stable outlook, by Fitch Ratings, Inc ("**Fitch**"), (iii) P-1 and A1, with a stable outlook, by Moody's Investors Service, Inc. ("**Moody's**"), (iv) a-1 and A+, with a stable outlook, by Rating and Investment Information, Inc. ("**R&I**"); and (v) A-2 and A- with a stable outlook, by Standard & Poor's Financial Services LLC through its business unit Standard & Poor's Global Ratings ("**S&P**").

#### Explanation of Ratings

DBRS: For short-term ratings, DBRS has a sliding scale from R-1 (highest credit quality) to R-5 (highly speculative). The modifier (middle) indicates that the obligation ranks in the middle end of the R-1 category. For long-term credit ratings, DBRS has a sliding scale ranging from AAA (highest credit quality) to C (very highly speculative). The modifier (high) indicates that the obligation ranks in the higher end of the A category.<sup>37</sup>

Fitch: For short-term ratings, a rating of F1 indicates the strongest intrinsic capacity for timely payment of financial commitments. For long-term credit ratings, a rating of A denotes expectations of low credit risk. The capacity for payment of financial commitments is

considered strong. This capacity may, nevertheless, be more vulnerable to adverse business conditions than is the case for higher ratings.<sup>38</sup>

Moody's: For short-term ratings, Issuers rated P-1 are deemed to have a superior ability to repay short-term debt obligations. For long-term ratings, obligations rated A are judged to be upper-medium grade and are subject to low credit risk. Moody's appends numerical modifiers 1, 2 and 3 to each generic rating classification. The modifier 1 indicates that the obligation ranks in the higher end of its generic rating category.<sup>39</sup>

R&I: For short-term ratings, a rating of a-1 indicates that the certainty of the fulfilment of a short-term obligation is high. For long-term ratings, a rating of A+ indicates high creditworthiness. The modifier (-) indicates that the obligation ranks in the lower end of the A category.

S&P: For short-term ratings, a rating of A-2 indicates satisfactory capacity to meet financial commitments. However, the Issuer is more susceptible to the adverse effects of changes in circumstances and economic conditions than obligors in the highest rating category. For long-term ratings, an obligation rated 'A' is somewhat more susceptible to the adverse effects of changes in circumstances and economic conditions than obligations in higher-rated categories.<sup>41</sup>

#### 8. Secured Overnight Financing Rate

As further described under "Risk Factors Relating to the Notes" above, the interest rate on the Notes may be determined by reference to SOFR (as defined in the Terms and Conditions of the Notes).

SOFR is published by the New York Federal Reserve and is intended to be a broad measure of the cost of borrowing cash overnight collateralized by U.S. Treasury securities. The New York Federal Reserve reports that SOFR includes all trades in the Broad General Collateral Rate and bilateral Treasury repurchase agreement (repo) transactions cleared through the delivery-versus-payment service offered by the Fixed Income Clearing Corporation (the "FICC"), a subsidiary of The Depository Trust and Clearing Corporation ("DTCC"), and SOFR is filtered by the New York Federal Reserve to remove some (but not all) of the foregoing transactions considered to be "specials." According to the New York Federal Reserve, "specials" are repos for specific-issue collateral, which take place at cash-lending rates below those for general collateral repos because cash providers are willing to accept a lesser return on their cash in order to obtain a particular security.

The New York Federal Reserve reports that SOFR is calculated as a volume-weighted median of transaction-level tri-party repo data collected from The Bank of New York Mellon as well as General Collateral Finance Repo transaction data and data on bilateral Treasury repo transactions cleared through the FICC's delivery-versus-payment service. The New York Federal Reserve also notes that it obtains information from DTCC Solutions LLC, an affiliate of DTCC.

If data for a given market segment were unavailable for any day, then the most recently available data for that segment would be utilized, with the rates on each transaction from that day adjusted to account for any change in the level of market rates in that segment over the intervening period. SOFR would be calculated from this adjusted prior day's data for segments where current data were unavailable, and unadjusted data for any segments where data were available. To determine the change in the level of market rates over the intervening period for the missing market segment, the New York Federal Reserve would use information collected through a daily survey conducted by its Trading Desk of primary dealers' repo borrowing activity. Such daily

survey would include information reported by Morgan Stanley & Co. LLC, a wholly owned subsidiary of the Issuer, as a primary dealer.

If errors are discovered in the transaction data provided by The Bank of New York Mellon or DTCC Solutions LLC, or in the calculation process, subsequent to the initial publication of SOFR but on that same day, SOFR and the accompanying summary statistics may be republished at approximately 2:30 p.m., New York City time. Additionally, if transaction data from The Bank of New York Mellon or DTCC Solutions LLC had previously not been available in time for publication, but became available later in the day, the affected rate or rates may be republished at around this time. Rate revisions will only be effected on the same day as initial publication and will only be republished if the change in the rate exceeds one basis point. Any time a rate is revised, a footnote to the New York Federal Reserve's publication would indicate the revision. This revision threshold will be reviewed periodically by the New York Federal Reserve and may be changed based on market conditions.

Because SOFR is published by the New York Federal Reserve based on data received from other sources, the Issuer has no control over its determination, calculation or publication. See "Risk Factors Relating to the Notes" above.
